**TPB CITIZENS ADVISORY COMMITTEE  
MONTHLY REPORT**

July 18, 2018

The CAC met on Thursday, July 12. At the meeting the committee was briefed on the Coordinated Human Service Transportation Plan update. They also received a progress report on CAC activities to date.

**COORDINATED HUMAN SERVICE TRANSPORTATION PLAN**

Wendy Klancher, TPB Transportation Planner, briefed the committee on the federal requirements for coordinated planning. She described the process for updating the plan and how it is used to guide funding decisions for the FTA's Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities program.

The committee supported the TPB's work and asked questions about eligible applicants and the types of groups that have applied in the past. They asked about how WMATA has used Enhanced Mobility funding.

**MID-YEAR CAC PROGRESS REPORT**

Bryan Hayes, TPB Transportation Planner, presented an overview of CAC work activities for the 2018 session. He reminded the committee of their mission to promote public involvement and provide independent, region-oriented citizen advice to the TPB on transportation plans and issues. He said that 33 percent of the committee's time this year has focused on Visualize 2045 and public involvement, and that 40 percent has focused on providing feedback on TPB activities.

**TPB AGENDA FOR THE JULY MEETING**

Lyn Erickson, TPB Plan Development & Program Coordination Director, reviewed the agenda for the July TPB meeting.

The committee had a robust discussion about the Car Free Day Proclamation. The committee discussed challenges for getting people to participate in the event, especially compared to Bike to Work Day. They asked about how the event is being promoted and the ways that Commuter Connections is coordinating with local jurisdictions.
