# RESOLUTION ON AMENDMENT TO THE FY 2007- 2012 AND FY 2008- 20013 TRANSPORTATION IMPROVEMENT PROGRAMS (TIP) THAT IS EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT TO INCLUDE THE EAST SIDE FERN STREET SIDEWALK PROJECT AS REQUESTED BY THE MONTGOMERY COUNTY DEPARTMENT OF PUBLIC WORKS AND TRANSPORTATION (DPWT)

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of Safe, Accountable, Flexible, and Efficient Transportation Equity Act - A Legacy for Users (SAFETEA-LU) for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the Metropolitan Area; and

**WHEREAS,** on October 20, 2006 the TPB adopted the 2006 CLRP and the FY 2007-2012 TIP; and

**WHEREAS,** on January 16, 2008 the TPB is scheduled to adopt the 2007 CLRP and the FY 2008-2013 TIP; and

WHEREAS, in the attached letter of December 21, 2007, the Montgomery County Department of Public Works and Transportation (DPWT) has requested an amendment to the FY 2007-2012 and FY 2008-2013 TIPs to include the East Side Fern Street Sidewalk project which is part of the Wheaton CBD Intermodal Access Program, as described in the attached materials; and

**WHEREAS**, this project is exempt from the air quality conformity requirement, as defined in Environmental Protection Agency (EPA) regulations "40 CFR Parts 51 and 93 Transportation Conformity Rule Amendments: Flexibility and Streamlining; Final Rule," issued in the May 6, 2005, *Federal Register*;

**NOW, THEREFORE, BE IT RESOLVED THAT** the Steering Committee of the National Capital Region Transportation Planning Board amends the FY 2007-2012 and FY 2008-2013 TIPs to include the East Side Fern Street Sidewalk project which is part of the Wheaton CBD Intermodal Access Program, as described in the attached materials.

### Dear Chairperson Hudgins:

The Montgomery County Department of Public Works and Transportation (DPWT) request an amendment to the current FY 2007-2012 and the soon to be approved FY 2008-2013 Transportation Improvement Program (TIP) to reflect the addition of the Wheaton CBD Intermodal Access Program. The Wheaton Redevelopment Program has requested that DPWT submit, on their behalf, a request for a TIP amendment to reflect the MTA Wheaton CBD SAFETEA-LU earmark. This project is exempt from air quality conformity analysis.

The Montgomery County, Maryland Wheaton CBD Intermodal Access Program earmark was authorized under the SAFETEA-LU Transportation Act in the summer of 2005 as a high priority FTA Section 5309 Bus and Bus Facilities Project # 224 with a federal amount authorized for each of the federal fiscal years in the Act. Montgomery County has authorized the 20% local match through the Streetscape Program under the Wheaton Redevelopment Program /Mid-County Regional Services portion of the Capital Improvement Program (CIP).

This project involves sidewalk widening, removal of the ADA non-compliant conditions, and construction of a planting panel along the east side of Fern Street between University Boulevard and Reedie Drive. Fern Street provides direct access to the Wheaton Metrorail Station entrance at a mixed-use-air-rights project over the Metro Kiss and Ride lot. Along with access to single family residential housing, this project removes safety and handicap impediments to enhance the pedestrian linkage between the Metrorail station and surrounding residential community. The total cost of this project is estimated to be \$526,524 of which \$417,039 is federal and \$109,485 is County. Engineering has been completed for this project and it will be ready for construction to begin in the Fall of 2008.

The Montgomery County Department of Public Works and Transportation requests this amendment be approved by the TPB Steering Committee at its meeting on January 4, 2008. Your consideration of this request is appreciated.

As we discussed on the phone, the Wheaton Redevelopment Program is requesting DPWT submit, on our behalf, the Transportation Information Program (TIP) Form for the MTA Wheaton CBD SAFETEA-LU Earmark. In addition to the current funds available, the county asks MTA to apply for preaward authority (a "Letter Of No Prejudice").

MTA has agreed to be the grant applicant for the "Montgomery County, MD Wheaton CBD Intermodal Access Program." The "Montgomery County, MD Wheaton CBD Intermodal Access Program" earmark was authorized under the SAFETEA-LU transportation in the summer of 2005 as high priority FTA Section 5309 bus and bus facilities project #224 with a federal amount authorized for each of the federal fiscal years in the Act: FY006 \$96,140; FY2007 \$100,320; FY2008 \$108,680; FY2009 \$112,860 for a total of \$418,000.

The 2006 and 2007 funds have been appropriated by the congress and FTA has subtracted its 1% skim for oversight from 2006, now \$95,179 (it appears they will not subtract for 2007). Thus, a total of \$195,479 federal share is now available to apply for. The funds in this program are available for the years appropriated plus two. Funding for FY2006 will disappear if not approved by September 30, 2008.

Montgomery County has already authorized the 20% local match and these funds are in our Streetscape Program under the Wheaton Redevelopment Program/Mid-County Regional Services Center portion of the County's Capital Improvement Program (CIP).

The County will use these funds on a major pedestrian route that directly leads to the Wheaton Metrorail entrance at the mixed-use air-rights project over the Metro Kiss and Ride lot. This project involves sidewalk widening, removal of ADA non-compliant conditions, and construction of a planting

panel along the east side of Fern Street (883 linear feet) between University Boulevard and Reedie Drive. Along with access to single family residential housing, this project removes safety and handicap conditions for pedestrian linkage between the Metrorail station and 353 existing multi-family housing units, 189 units currently under construction, and 320 units pending Planning Board approval. The Wheaton CBD Access project has gone through engineering and will be ready for construction spring 2008. The total cost of this project is \$526,524 (\$417,039 Federal and \$109,485 County).

The Wheaton Redevelopment Office will be the responsible party for this project. The actual work will be contracted through the County's Department of Public Works and Transportation (DPWT). DPWT will monitor the work schedule and the day-to-day work of the contractor and will report to the Wheaton Redevelopment Office.
