# Climate Energy and Environment Policy Committee Technical and Citizen Committees

# **Technical Committees**

Energy Advisory Committee<sup>1</sup> (Jeff King and Leah Boggs | <u>jking@mwcog.org</u> and <u>lboggs@mwcog.org</u>)

- EAC met on March 15<sup>th</sup>.
- Members heard a presentation on PJM's Demand Response program. Participation in the program is open to all Virginia municipalities that are able to reduce energy load during peak hours.
- Members also heard an overview of Virginia Beach's Energy Assurance Planning process. The planning effort, funded by a stimulus grant, will enhance communication and coordination to prepare for and respond to energy disruptions.
- The next meeting will be held on April 19<sup>th</sup>.

### Electric Vehicle Planning Initiative (Leah Boggs | lboggs@mwcog.org)

- The EV Planning Initiative met on February 29, 2012.
- The group heard an overview of results from EV-related questions in this year's CEEPC survey; a presentation on San Francisco's Multifamily Building EV Charging initiative; and a presentation on Snohomish County, Washington's EV zoning plan.
- The group was divided into 7 topic-related working groups. These subgroups are working to develop recommendations on electric utility policy, multi-family and commercial properties, inspection and permitting, municipal policy, public and private fleets, outreach and communication, and the business case for EVs.

Air and Climate Public Advisory Committee (ACPAC) (Maia Davis | mdavis@mwcog.org)

- ACPAC met on February 13, 2012. Katherine Sierra, Global Economy and Development at BROOKINGS, presented on the outcomes of the United Nations Climate Change Conference in Durban, South Africa in Nov/Dec 2011. Caroline Petti and Beverly Fourier were re-elected as chair and vice chair, respectively.
- ACPAC also met on March 19, 2012. ACPAC discussed the Annual Climate and Energy Progress Report, CEEPC Workplan and transportation conformity and margin of safety. (I may need to update this after Monday's meeting)
- The next ACPAC meeting will be April 16, 2012.

# **Supporting Technical and Policy Committees**

<u>MWAQC Technical Advisory Committee</u> (Jeff King | jking@mwcog.org)

- MWAQC met on February 22, 2012.
- MWAQC approved a FY 2013 Work Program and Budget.
- MWAQC reviewed final emissions inventories for the PM2.5 Redesignation Request and Maintenance Plan. The mobile emissions inventories will establish mobile budgets for future years 2017 and 2025. The future year mobile limits will be used for transportation conformity assessments as soon as EPA finds the mobile budgets adequate for conformity.
- MWAQC discussed the concept of safety margins for the budgets to allow room for uncertainty due to future model changes and changing inputs. Some state air directors expressed concern about increasing the mobile budgets at a time when new federal ozone standards require further reductions, particularly in NOx emissions. The states agreed to continue discussion among themselves to try to reach agreement on mobile budgets.
- The next MWAQC meeting will be held immediately following CEEPC on March 28, 2012.

# Transportation Planning Board (TPB), TPB Technical Committee, TPB Travel Management Subcommittee and TPB Scenario

- TPB met on March 21, 2012
- A work session on Complete Streets in the Washington Region was held prior to the meeting.
- The TPB voted to approve Amendments to the FY 2012 Unified Planning Work Program (UPWP), FY 2012 UPWP Carryover Funding to FY 2013, and the FY 2013 UPWP.
- The TPB was briefed on the establishment of mobile emissions budgets for fine particulate pollution (PM2.5) for the 2012 Redesignation Request and Maintenance Plan.
- Work continues on the TPB Regional Transportation Priorities Plan (RTPP). Over the coming months TPB staff will be arranging listening sessions with many of the stakeholders throughout the region in order to solicit their input on performance measures to be included.
