1:15 P.M. 9. VISUALIZE 2045: ENVIRONMENTAL JUSTICE ANALYSIS RESULTS

The TPB is required to conduct an Environmental Justice analysis examining the constrained element of Visualize 2045 for impacts on low-income populations, minority populations, or both. Using the TPB-approved Equity Emphasis Areas, staff will present the results of this analysis. The results of the analysis demonstrate that Visualize 2045 does not have a disproportionately high or significantly adverse impact on these populations.
