  - More vibrant Activity Centers.




### Sections of the SOPTR

  - Significant transportation projects or studies occurring during CY 2018.
- Part V: Transportation Planning Board
  - Information on how the TPB is assisting with regional public transportation.

#### OVERVIEW

Metrobus provides more than 400,000 trips each weekday serving 11,500 bus stops in the District of Columbia, Maryland, and Virginia. Metrobus is the sixth busiest bus agency in the United States, with a fleet of more than 1,500 buses operating on 325 routes.



#### RECENT ACCOMPLISHMENTS


Construction of Andrews Bus Facility: Metro is constructing a new facility at Andrews Federal
Center in Prince George's County, along with a heavy overhaul and maintenance facility. This
facility will replace the Southern Avenue Bus Garage with a fully modern Leadership in Energy and
Environmental Design (LEED) Silver facility that can hold 175 buses.



# Sample of Part V: TPB Activities

- Regional Public Transportation Subcommittee (RPTS)
  - The objective to provide a permanent process for the coordination of bus planning throughout the Washington region, and for incorporating regional bus plans into the long-range transportation plan.
- Performance-Based Planning and Programming (PBPP)
  - The development of regional targets. Transit asset management (TAM) is a strategic and systematic process of operating, maintaining, and improving public transportation capital assets effectively through the life cycle of such assets.
- Long-Range Plan (Visualize 2045)
  - TPB's long-range plan which includes a set of aspirational initiatives that the board identified for their potential to address some of the region's biggest transportation challenges in the future.



# Highlights from 2018

#### WMATA

- The delivery of the new 7000-series rail cars. Construction of Silver Line Phase II.
- DC Circulator
  - The addition of electric buses to the existing fleet. Free Wi-Fi on fleet.
- RideOn
  - Solar powered bus shelters. Awarded grant to purchase electric buses.
- OmniRide
  - The delivery of new motor coaches to replace the existing fleet.
- VRE
  - New York Avenue Midday Storage Facility. Multiple station improvements.
- MARC & VRE
  - Studying the feasibility of run through service.
- NVTC
  - Envision Route 7 Phase III. I-66 Commuter Choice Program



### **Trends**

- Overall, as with the rest of the nation, ridership has been on a steady decline.
- However, some regional providers have experienced a ridership increase
  - Arlington Transit
  - OmniRide
  - VRE
- Public transportation is a costly public good, and operating costs for the region's providers have been on an increase.
- Public transportation providers are investing and investigating new plans, vehicles, amenities, services, etc. to recapture the lost ridership, and attract new riders.
