1. Introductions

The meeting was brought to order by Chairperson Karen Taylor with NSVRC in Winchester, VA. Attendees were asked to introduce themselves and sign the attendance sheet.

4. TDM System Update | School Pool

Stephen Finafrock, COG/TPB staff, confirmed the TDM & SchoolPool software upgrade from JBoss 6 to JBoss 8 - Wild Fly. Wild Fly is currently running on a test database for use by COG Staff only. Mr. Finafrock then logged into the test database, reviewed a commuter's profile information and generated a matchlist. Mr. Finafrock informed those in attendance that the customized matchletter logos will be ported over when Wild Fly is put into production. COG Staff has not encountered any major issues with this software upgrade, but further testing is needed.

Mr. Finafrock continued to inform those in attendance of additional enhancements coming to the TDM System. COG will be enhancing the trip logging function for the Commuter Connections 'Pool Rewards program. This function will be streamlined and made more intuitive for program participants. The commute log may be integrated into the Commuter Connections mobile application for user's convenience.

Mr. Finafrock continues to expand on additional enhancements coming to the TDM System. A reports module overhaul will be in effect this fiscal year. Report definitions, names and functions will be appropriately changed as needed. Commuter Connections will also offer an opt-out marketing option. Registered commuters and new registrants will soon be able to opt out of marketing information and additional communications from Commuter Connections. Individuals who opt out will still receive matchlists and reminders to reregister. This option will be available when Wild Fly is moved to the production server.

Mr. Finafrock also announced that COG is looking into additional ways to use content management system (CMS) tools in order to make the Commuter Connections website more customizable and display different, more relevant news. Mr. Finafrock also announces that route-based ridematching is to be expected in 2016. Route-based ridematching will be an addition to the current radial search option.

George Clark, Tri County Council for Southern Maryland, expressed his concerns with the current radial ridematching system and the need for route-based ridematching. Commuters living and working in southern Maryland are currently matching across barriers.

Mr. Finafrock then discussed the possibility of introducing a dynamic ridesharing system to Commuter Connections. Nicholas Ramfos, COG/TPB Staff, added that the first iteration may be to match individuals who are heading to popular transit stations where parking may be costly and limited.

Mr. Finafrock then added the possibility that dynamic ridesharing could benefit individuals attending special events. Mr. Clark stated that some enhancements should be made to the special events module. He also suggested that an admin should be able to enter a longer description of the special event.

5. ATP's SchoolPool & TDM for Arlington Public School Employees

Stephen Finafrock, COG/TPB staff then began presenting the improved SchoolPool website and noted that schools must be registered with SchoolPool in order to become searchable in the database. As of now, COG has approximately 30 schools registered with SchoolPool. SchoolPool can now be customized and was presented using the Arlington Public School (APS) color scheme. Mr. Finafrock then logged in using a test account and began reviewing profiles and performing a matchlist. Parents will have the option to email other matched parents when they receive their matchlist results. Mr. Finafrock reminded those in attendance that college-aged students are not eligible for SchoolPool.

Mr. Finafrock noted that future improvements may include adding further customization to SchoolPool by swapping out the Commuter Connections logo with the relevant public school system logo. A section for special events may also be added.

Elizabeth Denton, Arlington Transportation Partners (ATP), presented strategies for Arlington Public Schools using both the SchoolPool and TDM software systems. The goal is to increase carpool options between employees working at any Arlington Public Schools. Initial research was carried out, including surveys showing that staff at Arlington Public School predominantly drive alone.

Arlington Transportation Partners is trying to gather more information to have a viable solution by this time next year. Surveys conducted by ATP show a large interest in carpooling among the estimated 5,000 APS employees.

ATP is also exploring incentive options for APS employees who carpool regularly. They may incentivize the use of carpools promoting parking spaces as a reward for carpooling. The goal is also to involve other staff members at Arlington Public Schools beyond teachers such as administrative and support staff.

6. Rideshare Delaware's Web-Based Chat Function

Kevin Schultz, former Project Manager of RSDE, has accepted a position with AMTRAK and was not able to attend the meeting and present on the Rideshare Delaware's web-based chat function. In place of the presentation, Stephen Finafrock, COG/TPB staff mentioned the software and asked the committee if any members had experience with similar products. Leigh Anderson, GW RideConnect, informed those in attendance that RSDE has been using a live chat application on their TDM website called "Tawk.To." This application is free to use and can be set up by copying and pasting a line of JavaScript into the HTML of the website. Mrs. Anderson believes this has been a successful communication tool for the public and has helped increase exposure to the Commuter Connections programs.

7. Client Site Status | Roundtable Discussion

There were no hot topic issues brought up for discussion and the group was asked to bring any issues encountered to the next Ridematching Quarterly meeting.

8. July 2015 TDM Resources Directory

Stephen Finafrock, COG/TPB, notified attendees that COG Staff has begun working on the July 2015 Resource Directory to be published in August 2015. The directory will be available in PDF format - printed versions will be available by request.

9. Quarterly Progress Report

Stephen Finafrock, COG/TBP staff, reminded the group to bring to his attention any issues regarding the data that shows inaccuracy. Kelly Woodward, DATA, clarified that numbers she reported are separate from Fairfax.

10. Other Business | Upcoming Agenda Items

Michelle Landrum, Enterprise, reminded the group about the ACT International Conference held on July 26-29, in Baltimore MD as an excellent opportunity for networking and collaborating with other colleagues.
