WASTEWATER

Sustainable Wastewater Practices Workshop

COG staff is working with wastewater experts in the region to organize a workshop on sustainable wastewater practices. The workshop is sponsored by the Chesapeake Bay Program's Scientific and Technical Advisory Committee (STAC), and it titled "Real World Examples: Cost- Effective and Sustainable Wastewater Treatment Practices and Other Options to Address Nutrient Reduction Requirements." The workshop will be held on Wednesday, May 16, 2012, at the Westin Hotel in Richmond, Virginia. The workshop will be integrated with and follow the VWEA education conference scheduled for the following day (May 17th) at the same location.

Regional Wastewater Flow Forecast Model (RWFFM) for WWTPs' Wastewater Flow Projections in COG's Region.

RWWFM has been actively used by COG's staff for the Blue Plains Service Area (BPSA) Wastewater Flow projections. Wastewater projections are based on demographic information from COG's Cooperative Forecast Model - which is linked to the appropriate flow factors to derive wastewater flows.

Blue Plains flow capacity is half of the COG Region wastewater flow capacity and the BPSA is approximately half of COG Region's service area. For planning purposes, we propose using the RWFFM and the same flow assumptions (that we use for the BPSA) for WWTPs' wastewater flow projections in COG's region. We will be contacting the Region's Jurisdictions/Agencies to confirm or to identify more appropriate numbers. We will be also verifying WWTPs' service area maps and identifying sewer vs. septic service areas. In addition, Charles County joined COG's region recently, and we will be updating the RWFFM with flow factors, I&I and 2009 base year flow for Charles County WWTPs.

STORMWATER

Stormwater Survey

COG will be sending out an electronic stormwater program survey this summer (July/August timeframe). It will be a continuation of COG's data collection efforts about challenges and costs for stormwater programs in the region. Survey findings will be used for possible presentations to the COG Board, CAOs Committee, and future factsheets.

DRINKING WATER

COG's Regional Water Supply and Drought Response Plan was adopted in June, 2000 by the COG Board of Directors to assure a regionally consistent response to drought conditions as well as promote water conservation and wise water use on a year-round basis. Under the plan, the CAOs Committee, in collaboration with area water utilities, constitute the "Drought Coordination Committee" (DCC) and

have delegated authority to issue drought stage declarations along with public messages. COG staff briefed the DCC at their May 2nd meeting about this plan, current water supply and drought conditions, and the seasonal outlook. A document was created to provide background information for the CAOs, per the drought primer, and will be distributed to the WRTC as well.

Chesapeake Bay Report Card

This report card provides a transparent, timely, and geographically detailed assessment of Chesapeake Bay. The overall health of Chesapeake Bay, determined using water quality and biotic indicators, declined slightly in 2011. The overall grade of D+ was a decrease for the second year in a row, down

from a C- in 2010. Only two reporting regions, the Patapsco and Back Rivers, and the Lower Western Shore (MD), had improved grades in 2011. The highest-ranked region for the second year in a row was the Upper Bay, with a grade of C.

May 15 - Chesapeake Bay (WIP) II Public Meetings (9:30 to 11:30 a.m.)

Phase II of Virginia's Chesapeake Bay Total Maximum Daily Load Watershed Implementation Plan (WIP) was submitted to EPA on March 30 and a formal public comment period on the document was initiated and will conclude on May 31. To supplement this formal comment period, DCR is working with its partners to hold a series of public meetings on the Phase II WIP across the state. The purpose of these meetings is to provide a brief update on the status of the Phase II WIP, the next steps in the Chesapeake Bay TMDL planning process and to provide local governments, planning district commissions, soil and water conservation districts and stakeholders with an opportunity to comment on the Phase II WIP.
