4. TDM System Update

Stephen Finafrock, COG/TPB staff, began his presentation reporting that there have lately been some issues with geocoding. Changes at Google and the expansion of program modules have necessitated re-evaluation of geocoding. A solution to the problem is currently being worked out. He encouraged everybody to keep reporting issues to COG through the Commuter Support line at (202)962-3333.

Mr. Finafrock updated the Committee about the Flextime Rewards program and the first rewards given for the months of January and February. Commuter Connections granted a \$100 prize for commuters who, after being notified, changed their times of travel and recorded trip data in the TDM system. To qualify for the program commuters, need to accept at least one invitation.

Mr. Finafrock also mentioned that the special events feature is working well. Cherry Blossom festivities and upcoming National games are being listed. In FY19, a special event feed will be added to the Commuter Dashboard to increase the module's exposure.

Mr. Finafrock then discussed the possibility of creating a custom page design for employers. For the time being, Commuter Connection will only help interested Federal Agencies, Universities and big corporations with a significant number of employees. The TDM System now has four custom Employer pages. Most recent additions include DOD/WHS & Reston Hospital Center.

Lastly, Mr. Finafrock stated that a Guaranteed Ride Home request function without calling the dispatch number will be available very soon. The idea is that with just one click from the account commuters can request a GRH. It would be easy to use with a likely "call back" feature from the dispatch service.

5. incenTrip Update

Steve Osborn, COG/TPB, presented the incenTrip Mobile Application demonstration. He highlighted the intuitive way of navigating through it. Commuters can create an account from scratch or sign in with the Commuter Connections account. Once logged in, users can review their account, trips planned, rewards etc. Also, they can see their points history.

For the time being, Carpool Now isn't yet incorporated in the app. incenTrip can suggest multiple travel options that suit the commuter preferences trying to optimize the trip. The cost factor isn't part of the formula. i.e. the cost of tolls.

George Clark, TCCSM, was concerned whether the estimated price of Uber service was accurate. Mr. Osborn, COG/TPB announced that the mobile application is ready to be downloaded using the Android Platform. For iOS users, the application is not yet ready. It's expected to be available around April or the beginning of May of this year.

Mr. Osborn then distributed a few available smartphones so the members of Commuter Connections were able to use the mobile application. Heidi Mitter, VDOT, noticed that the options given to commuters are sometimes not realistic, like walking distances, that is why it is important to send feedback and relevant input to make it more attractive to commuters. Mr. Osborn stated that incenTrip uses real-time traffic data to help you make an informed decision for your trip. Eco Driving allows users to earn additional points by driving efficiently. The less efficient the less points. Points accumulated through the app's trip planning can be redeemed for various prizes. Rewards may include Amazon gift cards. The gift card value varies depending on the amount of points a user redeems.

Mr. Osborn concluded by stating that the maximum points a commuter can redeem is 5,000. An official launch presentation from the University of Maryland developers of IncenTrip will take place in the Board Room around May. The exact date is undetermined. 6. Mobile Applications Update

Stephen Finafrock, COG/TPB staff, reviewed the improvements of the mobile application CarpoolNow with the Committee. He brought up the existence of a recent "bug." The software now has more information, and complexity. Transit information is offered as an alternative. The driver notification has been enhanced.

7. GIS Update

Ross Edgar, COG/TPB staff, updated the Committee on the status of the bike-routing module. He demonstrated heads-up digitizing of bike paths over aerial photography to correct errors in input data. He continued demonstrating the steps needed to extract and transform data from different sources into a dataset that can be used as input to build a navigable bike routing network.

8. Client Site Status/Roundtable

During the meeting Nancy Huggins from MTA was recognized for her effort in working with cab providers to get onto the Ford Meade Base for the GRH Baltimore program.

9. Quarterly Progress Report

Stephen Finafrock, COG/TPB staff, reviewed the FY18 2nd quarter CCWP progress report. He mentioned that some numbers of the previous quarter activity can be used for comparison purposes. He encouraged those in attendance to review the progress report and offer any comments or suggestions. He stated that it is helpful to receive data from all jurisdictions as early as possible so that it is included in the report. Other Business/Upcoming Agenda Items

Stephen Finafrock, COG/TPB staff, ended the meeting suggesting those in attendance test the Flextime Rewards program using a personal Commuter Connections account to check for notifications. Also, he recommended that attendees download the incenTrip app to learn more about it.
