- 6:10 6:15 Discussion Regarding the Election of Six Members for the 2011 CAC According to the TPB's Participation Plan, the CAC is required annually to select six members (two each from MD, VA and DC) to serve on next year's committee. At the CAC's November meeting, the committee agreed that this year the CAC would select these six members through an email election. At the CAC meeting on December 15, staff will announce the results of this election. At the TPB meeting on January 18, the TPB officers is scheduled to nominate an additional nine members, making a full complement of 15 members for 2012.
- 6:15 6:45 Briefing on 2011 Peak Period Freeway Congestion in the Washington Region, and Changes Since 2008 and 2005 Beginning in 1993, the TPB has commissioned aerial surveys every three years to monitor the performance of the regional freeway system during the morning and afternoon peak periods. The CAC will be briefed on the recurring congestion observed in the latest survey of spring 2011, and on changes in congestion locations and durations since the surveys of 2005 and 2008.
