The TPB initiated the Transportation Land-Use Connections (TLC) Program in 2006 to provide support to local jurisdictions as they deal with the challenges of integrating land-use and transportation planning at the community level. To date nearly 100 technical assistance projects have been funded through the program. The solicitation for the FY2017 TLC round of technical assistance was conducted between February 1 and April 1. The board will be briefed on the applications that a technical review committee has recommended for funding in FY 2017.

**1:20 P.M. 9. BRIEFING ON MARYLAND'S PUBLIC PRIVATE PARTNERSHIP TO DESIGN, BUILD AND OPERATE THE PURPLE LINE LIGHT RAIL SYSTEM**

The TPB approved a TIP amendment at its April 20, 2016 meeting to reflect the latest financial plan to implement the 16-mile Purple Line light rail line, to be constructed in Montgomery and Prince George's counties and linking the Washington Metro's Red, Blue, Orange and Green lines. On April 6, the State of Maryland approved entering into a contract with the Purple Line Transit Partners group to design, build, finance, operate and maintain the new Purple Line. The board will be briefed on the elements of the Public Private Partnership arrangement.
