# **Presidential Inauguration 2013**

As the capital of the United States and seat of the federal government, the District of Columbia plays host every four years to the inauguration of the country's president and the related activities such as the inaugural parade, balls and galas and other festive events.

Through the DC Presidential Inaugural Committee (DC PIC) the Government of the District of Columbia provides logistical coordination and support for the inaugural activities, working in close coordination with its federal, regional and private sector partners to ensure seamless oversight and integrated management.





# **Statutory Authority**

- Mayor's Order 2012-123 Establishment of the District of Columbia Presidential Inaugural Committee.
- **36 USC § 502(a)(1)** Regulations and Licenses. "For each inaugural period, the Council of the District of Columbia shall ... prescribe reasonable regulations necessary to preserve public order and protect life, health, and property."
- **36 USC § 503(a)** *Permit for Use.* "The Mayor of the District of Columbia may grant a similar permit to use public space under the Mayor's jurisdiction.
- 36 USC § 503(b) Reviewing Stands and Commercial Stands and Structures. "A reviewing stand or a stand or structure for sale of merchandise, food, or drink may be built on public grounds in the District of Columbia only if approved by the Inaugural Committee and by the Secretary or the Mayor, as appropriate."
- **36 USC** § **508** *Enforcement.* "The Mayor of the District of Columbia ... shall enforce this chapter, take necessary precautions to protect the public, and ensure that the pavement of any street, sidewalk, avenue, or alley disturbed or damaged is restored to its prior condition."
- 36 USC § 510(a)(1) Authorization. "Necessary amounts are authorized to be appropriated ... to enable the Mayor of the District of Columbia to provide additional municipal services in the District of Columbia during the inaugural period"

## **Presidential Inaugural Planning Entities**

### PRESIDENTIAL INAUGURAL COMMITTEE (PIC)

- Formed after November 6<sup>th</sup> election when President-elect announces the PIC leadership
- Charged with organizing and funding many of the inaugural events

### **US SECRET SERVICE (USSS)**

- Develops the overall security plan for the Inauguration
- Lead federal agency for the design and implementation of the operational security plan
- Chairs the USSS Executive Steering Committee

### DC Presidential Inaugural Committee (DCPIC)

- An interagency committee established for the purpose of planning and coordinating the DC Government's support for the Inauguration to preserve public order and protect life, health, and property
- Coordinates planning efforts for activities during the NSSE period with the USSS, JFHQ-NRC, JCCIC, and PIC

### JOINT FORCE HEADQUARTERS-NATIONAL CAPITAL REGION (JFHQ-NCR)

- Joint service committee with members from all branches of the armed forces
- Coordinates all military ceremonial support working closely with the JCCIC, USSS, DCPIC and the PIC

### JOINT CONGRESSIONAL COMMITTEE ON INAUGURAL CEREMONIES (JCCIC)

- Comprised of the Senate Majority Leader, the chair and ranking member of the Senate Committee on Rules and Administration, the Speaker of the House, and the Majority and Minority Leaders of the House of Representatives
- Oversees Inaugural ceremonies at the U.S. Capitol, including the Swearing-in Ceremony and the Congressional luncheon





### **USSS Executive Steering Committee**

Meets monthly and ramps up after November election. Membership on this Committee is based on the lead agencies for each of the subcommittees.



### District support includes but not limited to...

- Providing police protection
- Providing health and medical services for inaugural events
- Providing fire/life safety and HazMat services for inaugural events
- Coordinating emergency hospital treatment with local hospitals
- Establishing unified command
- Establishing a central medical command post capable of communications to all field stations
- Providing health and food inspections for inaugural events
- Pre-cleaning and post-cleaning of the parade route
- Removal and replacement of traffic signals and poles along parade route
- Construction of reviewing stands
- Securing of manholes and installing and removing cables along parade route
- Installation of flags along parade route
- Providing liaisons to emergency operations centers
- Designing, manufacturing and issuing special inaugural license tags
- Providing structural, electrical, and plumbing inspections of temporary structures
- Providing occupancy and code inspections of all public and private facilities offering public accommodations for inaugural activities
- Issuing permits for temporary construction projects
- Issuing licenses for concessionaires and vendors
- Providing fire protection
- Providing snow contingency planning
- Provide contingency or crisis information within their respective jurisdictional areas
- Maintain awareness of inaugural events, including movement and status of participants, contingency forces and support assets
- Coordinate their respective agencies' support of inaugural events and contingency operations
- Provide liaison and coordination with relevant ELOs when operations have impact or potential impact within their jurisdictional areas, or when multi-agency operations are required
