Climate Energy and Environment Policy Committee Technical and Citizen Committees

Technical Committees

- BEEAC met on September 19 to discuss energy efficient streetlight projects in the region.
 Arlington County, the District of Columbia, and Greenbelt were highlighted. The group also received presentations on STAR Communities rating system and ACEEE's City Energy Efficiency Scorecard.

- In August, the Recycling Committee Outreach Subcommittee met to plan the next Go Recycle campaign

 Maryland in the next two years.

- ACPAC met on July 15, 2013 and discussed the regional tree canopy report, a climate and energy leadership awards concept, and regional ozone attainment options
- ACPAC held a conference call on August 21, 2013 to discuss the climate and energy awards proposal
- ACPAC is meeting on September 16, 2013 to discuss the Regional Transportation Priorities Plan, the Ozone Season Summary, and the Climate and Energy Awards Pilot Proposal.

Supporting Technical and Policy Committees

MWAQC and MWAQC Technical Advisory Committee (Sunil Kumar | skumar@mwcog.org)

- MWAQC did not meet since its last meeting on May 22, 2013. There are no updates.
- MWAQC-TAC met on September 10, 2013. COG staff presented the 2013 ozone season summary. There was exceedance observed for the 2008 ozone standard on June 5, July 17, July 18, and July 19. The group discussed the various aspects of the selection of a base year for the 2008 ozone SIP. A comprehensive base year is required for submission to EPA. The group also discussed the Washington region's possibility of meeting the Reasonable Further Progress requirements for the above ozone standard, which is required in case the Washington region does not meet the 2008 ozone standard by the deadline and therefore gets re-classified to a higher nonattainment level for the 2008 ozone standard. States agreed to develop this plan in anticipation of the possible higher reclassification. MDE staff also presented a detailed greenhouse gas emission reduction plan for Maryland, which was published recently. The plan aims to achieve 25% reduction by 2020 from multiple sectors besides creating jobs.

<u>Transportation Planning Board</u> (TPB), <u>TPB Technical Committee</u>, <u>TPB Travel Management Subcommittee</u> and <u>TPB Scenario Study Task Force</u> (Ron Kirby and Gerald Miller | <u>rkirby@mwcog.org</u> and <u>gmiller@mwcog.org</u>)

- The TPB met September 18, 2013
- The TPB approved an amendment to the FY 20113-2018 Transportation Improvement Program (TIP) to include funding for the construction of a replacement interchange on MD 4 at Suitland Parkway and for the reconstruction of US 1 in College Park.
- The TPB received a briefing on the results of the 2013 State of the Commute Survey.
- The TPB received briefings on highlighted regional freight projects and the Long Bridge Study, which assesses the potential for intermodal connectivity and operations improvements to the bridge that is owned by CSX.
- The TPB received an update on the final version of the report "What do People Think about Congestion Pricing? A Deliberative Dialogue with Residents of Metropolitan Washington".
- The TPB was briefed on comments received during on the draft TPB Regional Transportation Priorities Plan (RTPP).
