Item 3. Federal Court Decision on Clean Air Interstate Rule

Presenter: Joan Rohlfs, Chief, Air Quality Planning

Description:

The U.S. Court of Appeals for the District of Columbia Circuit vacated the Clean Air Interstate Rule (CAIR) on July 11. EPA promulgated the rule in 2005 to reduce power plant emissions of sulfur dioxide and nitrogen oxides. The CAIR rule was adopted in various forms by Virginia, Maryland and the District and is used in the 2008 PM2.5 State Implementation Plan (SIP). EPA has 90 days to appeal the decision.

The approval followed a unanimous recommendation from the City's Mirant Community Monitoring Group, which met on June 30 to review the potential settlement and recommended that the City approve the terms of the settlement agreement. As a condition for approval of the PM2.5 SIP, the City of Alexandria and the Virginia Dept. of Environmental Quality agreed that a letter will be drafted and sent by MWAQC to the Commonwealth of Virginia Air Pollution Control Board asking that action be initiated to tighten Virginia's standards from the existing 20% for opacity to 10%. Mr. King will present the draft letter.
