The constrained element of Visualize 2045 identifies all regionally significant transportation investments the region can demonstrate to afford between now and 2045. Federal law requires that this collection of projects and programs be analyzed to ensure that future vehicle-related emissions remain below approved regional limits.

At the January 17 meeting, the board approved the project submissions and the Air Quality Conformity analysis scope of work. After the public comment period closed, Montgomery County requested the addition of the New Hampshire Avenue Bus Rapid Transit Project. The board opened an additional public comment period for this project which will close on February 17. The board will be briefed on the comments received and recommended responses, and asked to approve the additional project submission from Montgomery County for inclusion in the air quality conformity analysis for Visualize 2045 and the FY2019-2024 TIP.
