Status of Redesignation Request

- **Evidence of NAAQS Compliance**
 - **Design value data and trend graphs available**
- **Demonstrate NAAQS compliance due to emissions reduction from permanent & enforceable control measures between 2002 & 2007**
 - **A list of control measures adopted in the region along with emissions benefits provided by them between 2002-2007 being compiled**

Status of Maintenance Plan

- **Demonstrate continued maintenance of NAAQS**
 - Emissions reduction - Base Year to Maintenance Year
- **Emissions inventories needed for**
 - Base Year (2007)
 - Interim Year (2017)
 - Maintenance Year (2025)
 - Draft 2007/17/25 inventories complete except for MOVES emissions
- **Contingency measures – needed in case of NAAQS violation after redesignation**
 - Contingency measure work-group being set up

Status of Emissions Inventories - 1

- **Milestone Years**

- 2002, 2007, 2017, 2025

- **Inventories needed**

- Point Source (EGU & NEGU)
 - EGU = Electric Generating Unit, NEGU = Non Electric Generating Unit
- Area Source (Open burning, residential wood burning, dust (unpaved road), etc.)
- Nonroad Source (Lawn mowers, agricultural & construction equipments, aircraft, locomotive, etc.)
- Onroad Source (Motor vehicles)

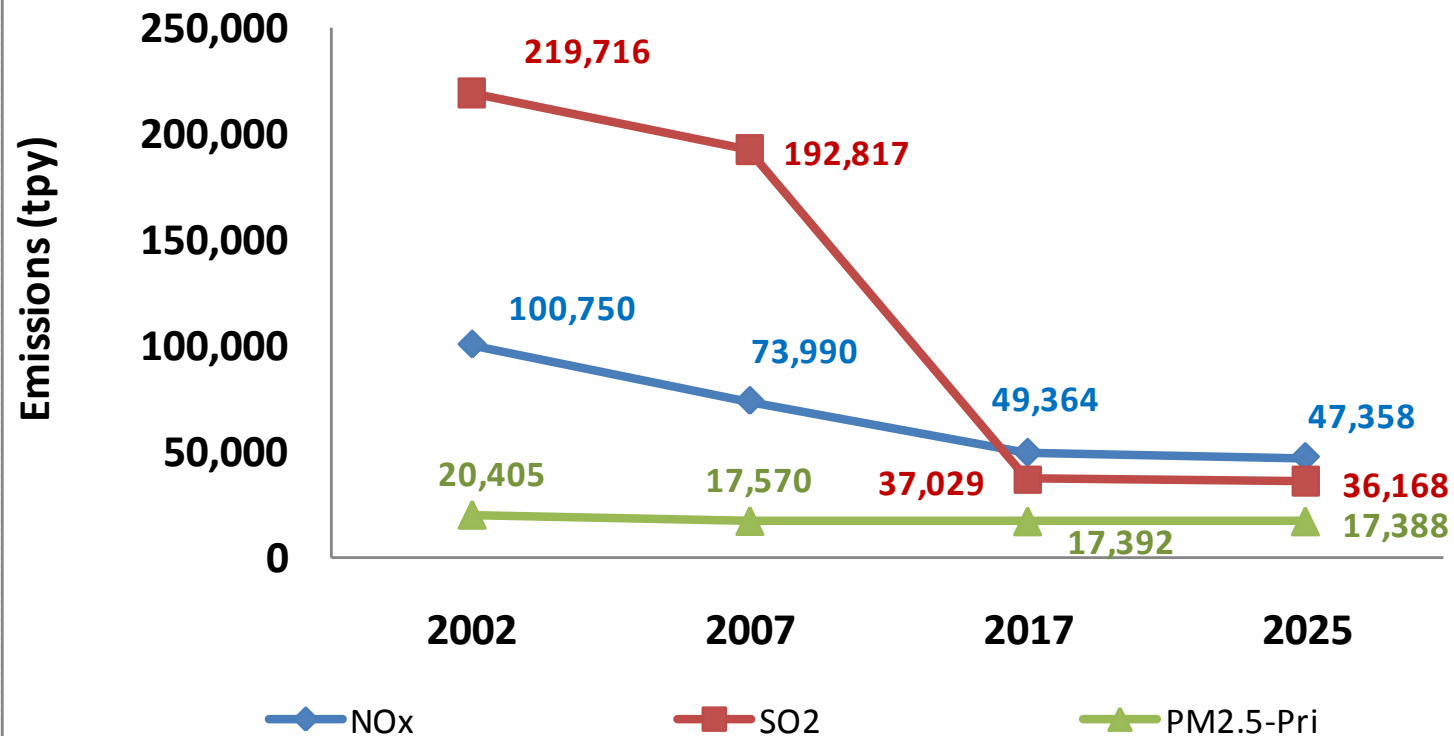

Conclusion

- **NO_x, SO₂, & PM_{2.5}-Pri emissions**
 - 2002 – 2007
 - 2007 – 2017
 - 2007 - 2025
- **Downward emissions trend**
 - 2002 – 2007: Satisfies the criterion for Redesignation Request
 - 2007 – 2017 & 2007 – 2025: Continued maintenance of 1997 annual PM_{2.5} standard (15 ug/m³)
- **A number of inventories are still draft.**
- **Onroad Mobile Source – MOVES emissions need to be developed to complete the picture.**
- **Contingency measures to be decided**
