### **2015 Ozone Standard Redesignation Request & Maintenance Plan**

# Background

- Current official ozone design value based on 2021-23 data is 71 ppb, which is above the current 2015 ozone standard (70 ppb).
- A few high ozone days in 2023 were influenced by wildfires that were outside the Washington region (Canada, Jew Jersey). Therefore, the District applied for the "Exceptional Events" waiver to exclude data from those days in the design value calculation. EPA recently granted the District that waiver for June 23, 2023 data.
- As a result, the Washington region's design value came down to 70 ppb, which brings the region into compliance with the above standard.



# Background

- EPA proposed in November and is expected to finalize the "Determination of Attainment by the Attainment Date" and EE Waiver in Spring next year.
- Having attained the current standard, the Washington region is planning to develop and submit to EPA a request to redesignate the region to attainment/maintenance area for the above standard along with a maintenance plan to demonstrate continued attainment in the future.
- To start the process, the region has sent a list of questions to EPA regarding the requirements to submit the above plans, the identification of milestone years, and emissions inventories to be



used in the plan. Metropolitan Washington Council of Governments

# **Questions for EPA**

- Following questions were sent to EPA -
  - Proposed milestone years:
    - Base Year: 2017
    - Attainment Year 2022
    - Interim Year: 2032
    - Maintenance Year: 2038
  - Emission Inventories:
    - Need to update onroad and nonroad inventories in the BY2017 inventory document (developed using MOVES2014b model) using the new MOVES4.0.1 model)?
    - EPA's new model "MOVES5.0.0" expected in December 2024. Would EPA still allow the region to use MOVES4.0.1 as this will save us time for testing the new model and/or possibly developing inputs in new format? This version produces higher emissions in the future compared to MOVES5.0.0 so the maintenance demonstration using it will be conservative.



# **Questions for EPA**

- Requirements for submittal of Redesignation Request/Maintenance Plan
  - The District, Maryland, and Virginia need to complete certain requirements such as, Moderate Nonattainment area New Source Review, RACT, and a few components of intestate transport, etc. Do they need to be completed before the region can submit RR/MP?
- Emission Reduction Credits for retired power plants in Maryland:
  - Morgantown, Chalk Point and Dickerson power plants shut down in 2022 and are considering applying for Emission Reduction Credits (ERCs). How are ERCs accounted for in the Redesignation Request & Maintenance Plan emissions inventory?
