8-Hour Designations and Implementation of the 8-Hour Ozone Standard

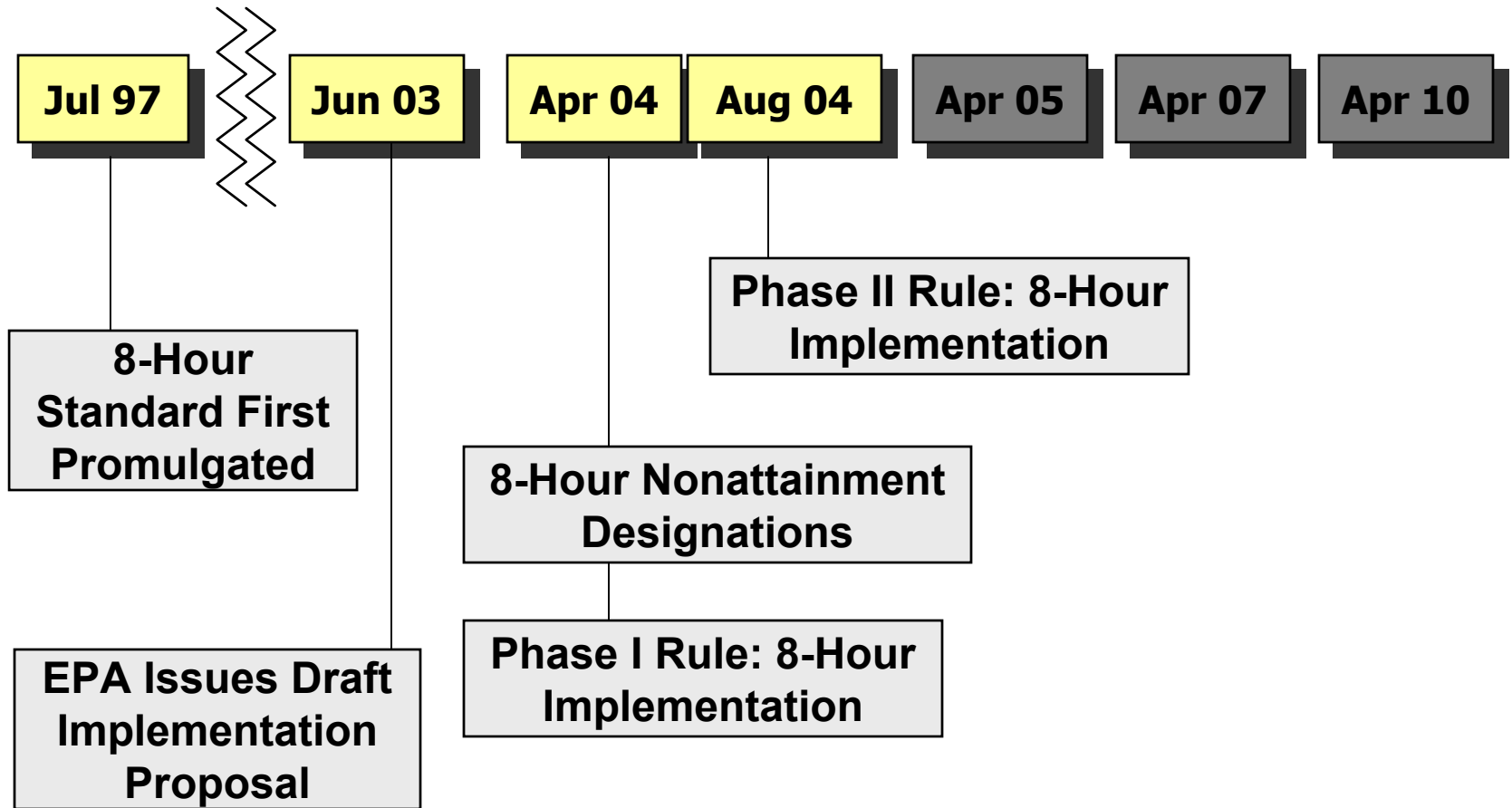

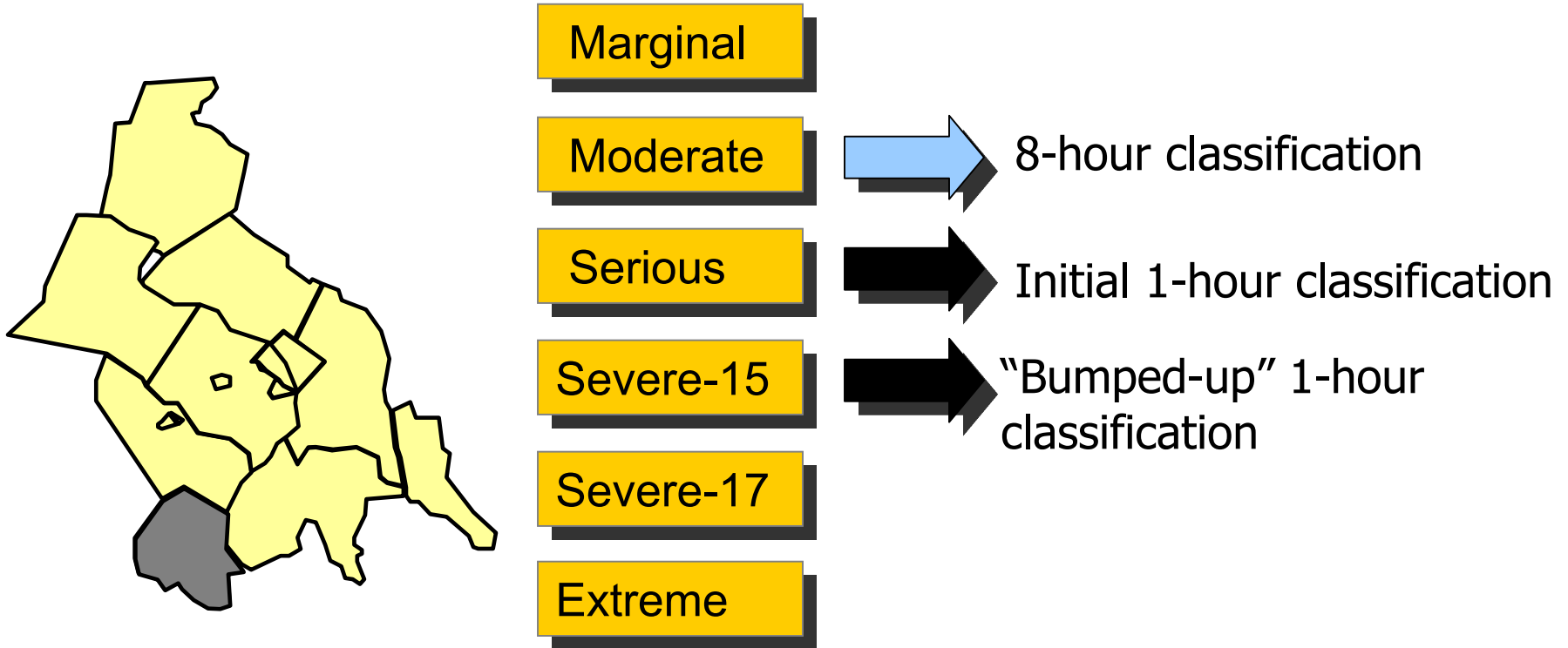

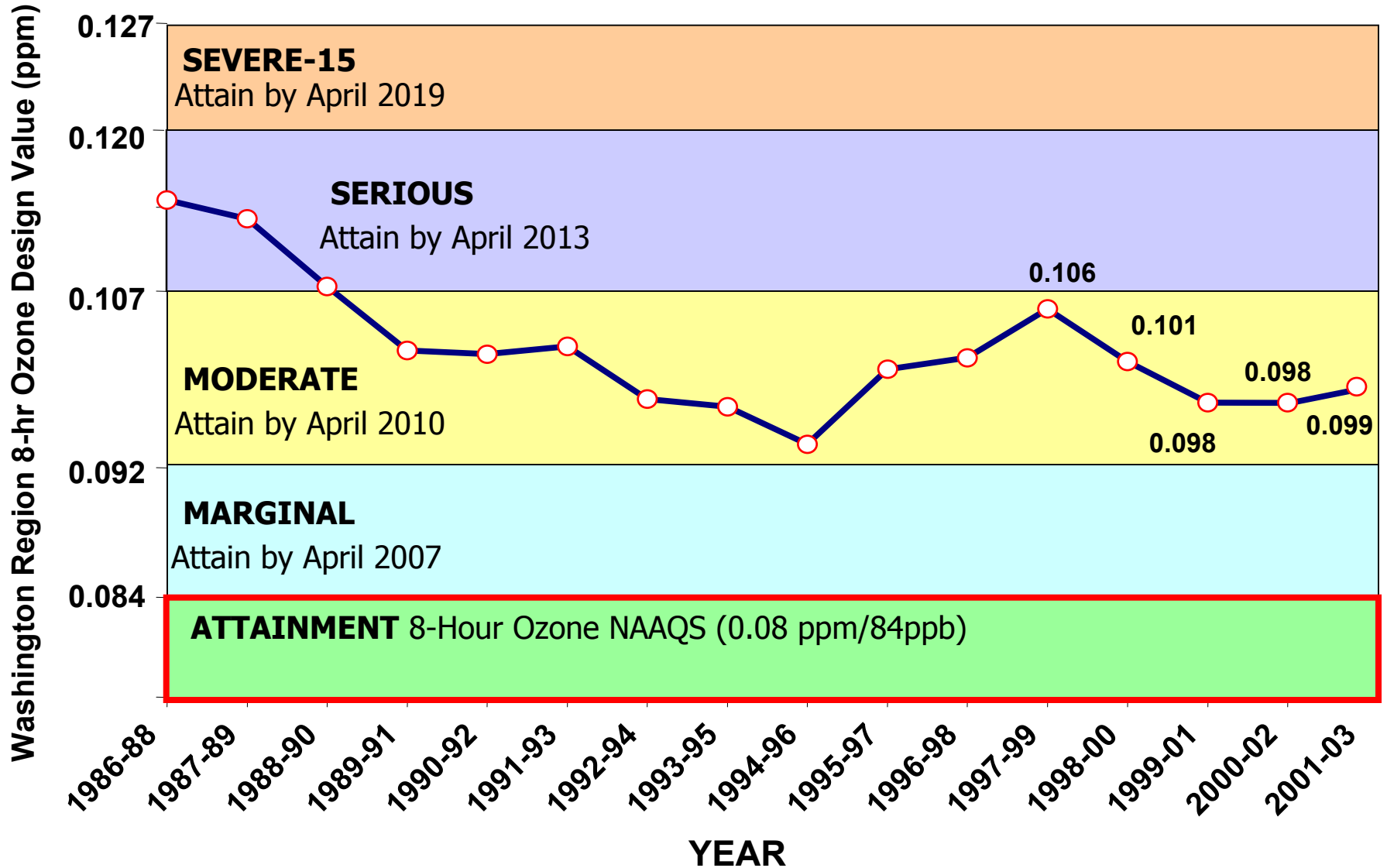


New Classification and Attainment Area

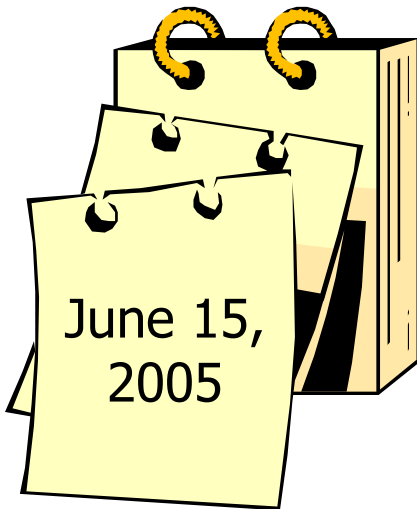


Stafford County joins the Fredericksburg nonattainment area.

Classification of "Moderate"

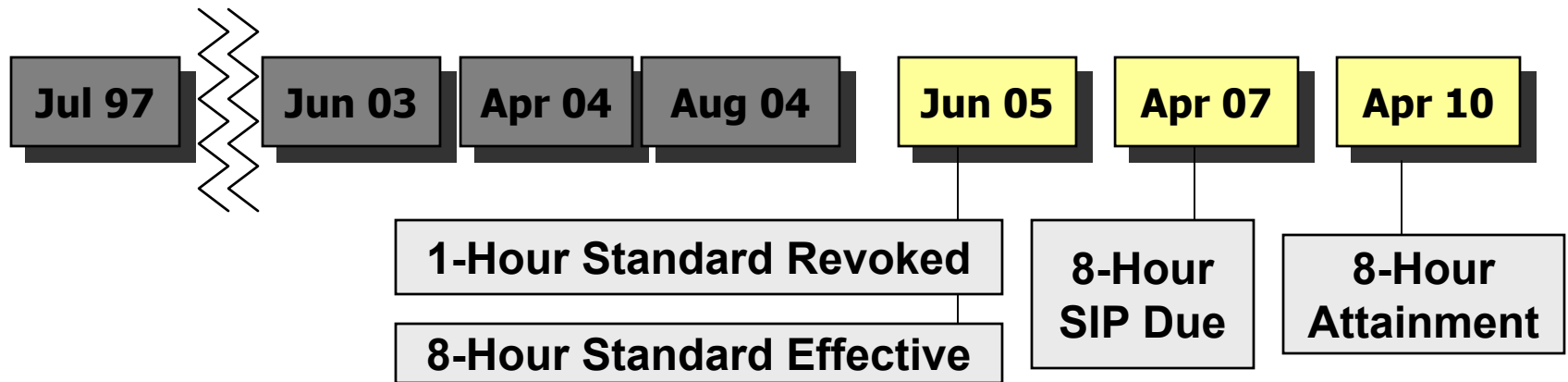


Revoking the 1-Hour Standard



- 1-hour standard will no longer apply
- 8-hour standard becomes effective
- No failure to attain
- But EPA must act to approve/disapprove our SIP by April 29, 2005
- Litigation could delay 1-hour revocation

Transition to 8-Hour Standard



- Keep control measures required under 1-hour designation
- Must meet all 1-hour rate-of-progress obligations
- May discontinue or substitute discretionary control measures if it won't interfere with 8-hour attainment

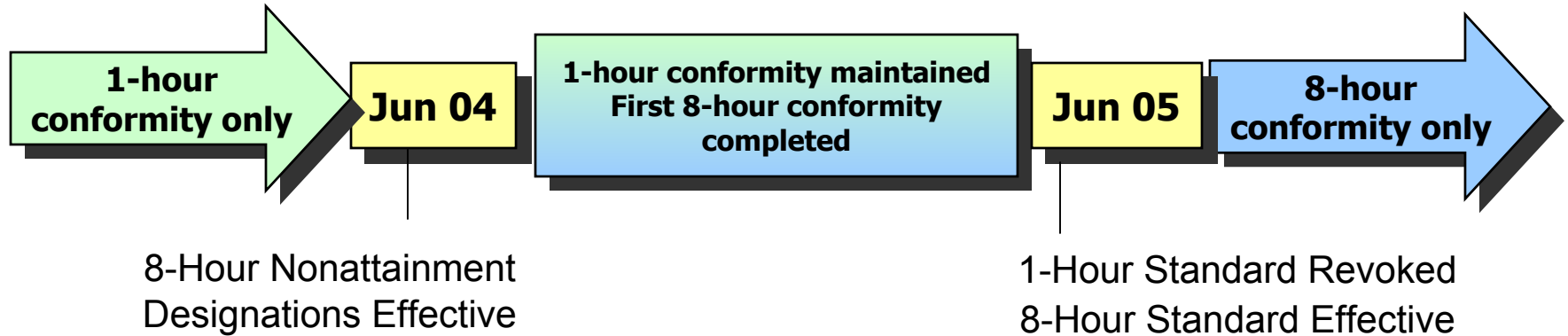

Conformity/Mobile Budget

- 8-hour conformity starting in 2005
- No conformity for 1-hour standard once it is revoked and 8-hour is effective

One Year Grace Period for 8-Hour Conformity



Use “interim emissions test” until mobile budget approved

- Less-than-baseline test?
- Build/no build test?

June 2007 8-hour SIP will contain 8-hour mobile budget ₉

- Final rule on mobile source conformity
