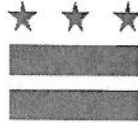
**WHEREAS**, on October 20, 2006 the TPB adopted the 2006 CLRP and the FY 2007-2012 TIP; and

**WHEREAS**, in the attached letter of February 13, 2007, DDOT has requested that its portion of the FY 2007-2012 TIP as approved by the TPB on October 20, 2006 be replaced by the attached submission which includes updated project information to accurately show project obligation funding information; and

**WHEREAS**, the funding changes in this submission do not affect the air quality conformity determination of the 2006 CLRP and the FY 2007-2012 TIP;

As a result of staff turnover at the District Department of Transportation, DDOT's initial TIP submission contained a number of errors such as projects listed more than once and project obligation schedules that did not reflect DDOT's most current planning. Therefore, DDOT is resubmitting its portion of the FY 2007 through FY 2012 TIP that presents a more accurate reflection of the District's six-year Transportation Improvement Plan. As a result of this updated effort, there is also an improved alignment between project obligation schedules and available resources.

Because the updated TIP presents some substantial changes over the version that was approved in October, DDOT requests that this update be made available for public review and comment prior to final TPB approval.

Re: Changes to the Amendments to the FY 2007-2012 TIP that are Exempt from the Air Quality Conformity Requirement to Realign Project Funding, as Requested by the District of Columbia Department of Transportation (DDOT)

The following changes to the proposed Amendments to the FY 2007-2012 TIP have been requested by DDOT.

Funding for the Reconstruction and Widening of the Theodore Roosevelt Memorial Bridge has been pushed out to start in FY 2009 and conclude in FY 2012.

The following changes apply to the Transit Capital portion of the TIP. The item numbers correspond to their listings in the TIP document.

1 – Rapid Bus Transit. This project was inadvertently listed twice in the Draft Amendments. This listing will be deleted and Item 9 will be retained.

2- Bus Shuttle Services. Delete from District. This will be apart of the Circulator

3 and 4 – CSX Shephard Branch Railroad. WMATA funding is shown. Delete from the District

5 – D.C. Transit Development Study Reduce to \$400 in FY07

6 – Downtown Circulator. Change title to Circulator and add 11,000 in FY08

7 – East Entrance Foggy Bottom. Eliminate FY07 entry; 10 million in FY09

8 – Farragut Station Pedestrian Tunnel. Eliminate FY08 entry; 10 million for FY09 and 10 million for FY10.

11 – Yellow Line Extension. \$1.5 million for FY07, FY08, FY09

12 – Metrobus Replacement Program. Bus replacements are listed in the WMATA TIP as IRP Rolling Stock. Remove from the DC TIP

14 – Metrorail and Metrobus CIP. Remove from the DC TIP

16 – Pedestrian Passageway. Located at Union Station. Delete

Description: New York Avenue is a major arterial carrying approximately 65,000 vehicles/day. Safety is a major issue as a result of left turns into local streets without having separate turn lanes. A study is proposed to determine the impact of having traffic make left turns at two locations (Fenwick and Kendall Streets) and to prohibit left turns at 16th and Fairview Streets. The left turns would be made by exiting New York Avenue to the right in advance of each of the two intersections, following a curbing alignment, and then cross New York Avenue as a through-movement at each signalized intersection.

Description: The New York Avenue/I-395 intersection is highly congested and is the fourth worst crash location in the District. A left-turn movement from New York Avenue to I-395 is one of the reasons for the congestion. The left-turn movement carries a high volume of traffic throughout the day and into the evening. The eastbound through movement also carries a high volume of traffic. To alleviate the congestion, a four-lane tunnel is proposed to provide a direct connection between the east and south approaches. This will remove some of the traffic from the signalized intersection resulting in less congestion and increasing safety.
