The draft activity centers map was released for COG member and stakeholder comment by the Region Forward Coalition in July 2012. Since that date, COG staff briefed each of COG's member governments and obtained additional input from several stakeholder organizations. The draft activity centers map was revised to incorporate COG member and other feedback. On January 9th, the COG Board of Directors adopted the 2012 Regional Activity Centers Map. COG staff will brief the committee on the final details about the Activity Centers Map and discuss the policy and process for updating the map. Finally, staff will discuss ongoing work with local governments to identify analysis geographies for the Centers.
