3. Highlights of *The National Economic and Labor Impacts of the Water Utility Sector* Study

George Hawkins, General Manager, DC Water Karen Pallansch, President and CEO, Alexandria Renew Enterprises

Mr. Hawkins and Ms. Pallansch will brief the committee about the key findings of the *Water Works* Coalition's recently released study (conducted by the Water Research Foundation and Water Environment Research Foundation), which illustrates the importance of water infrastructure investments to the economy, economic growth, and jobs (Ref. 3). They will discuss how this work relates to the COG region and its members, and suggest ways for the CBPC and COG to leverage these national efforts to address regional water infrastructure needs.

Recommended action: Endorse COG staff's continued work with the Coalition to develop specific actions for the CBPC and COG Board's consideration.
