## Summary of Climate-Related Activities of COG Committees Supporting CEEPC - September 2010

## Climate Energy and Environment Policy Committee Technical and Citizen Committees

#### **Technical Committees**

Energy Advisory Committee<sup>1</sup> (Jeff King and Leah Boggs | jking@mwcog.org and lboggs@mwcog.org)

• The Energy Advisory Committee (EAC) met on September 16th. Topics discussed included the District of Columbia Sustainable Energy Utility, the COG energy outreach campaign: WE CAN, building codes training, utility data tracking and regional energy contracts.

## Intergovernmental Green Building Group (IGBG) (Leah Boggs | Iboggs@mwcog.org)

• The IGBG met on September 14, 2010. The focus of the meeting was energy building codes training for local government staff planning to attend the International Code Council (ICC) Final Action Hearing in Charlotte, October 25-31, 2010.

#### Street Lights Working Group (Jeff King | jking@mwcog.org)

- The Street Lights working group met on September 20, 2010. Members heard about Arlington County's project to use EECBG funding to update many of its street lights to more efficient LED technology. Alan Proctor attended to present information on his petition to intervene on the MD PSC Case 9217. He discussed information about his interest in having Pepco advance efforts more expeditiously to either move to new more efficient technology and/or remove barriers to municipalities that wish to purchase street lights and install new technology. The MD PSC ordered the interested parties to form a workgroup and report back on proposed solutions in about six months.
- The group also heard updates on the Dominion LED pilot and on the energy contracts database and EECBG projects.

#### Recycling Committee (John Snarr | jsnarr@mwcog.org)

- September 16 meeting focused on how to stimulate commercial recycling. Attendees heard from local businesses that have successfully implemented programs and have helped others.
- America Recycles Day is November 15. COG will be offering a regional prize and local governments will hold various events.
- COG is gearing up for the Winter 2011 Go Recycle Campaign to promote recycling in the workplace.

# Energy Outreach Coordination (Joan Rohlfs | jrohlfs@mwcog.org)

- The ad hoc committee appointed by CEEPC at its March meeting met twice this summer. The committee agreed on a name, website address, and logo for the energy outreach program launched by COG this month. An update on this project will be presented to CEEPC members on September 22.
- The campaign includes: a website with energy saving tips and access to a platform that allows people who sign up to monitor their energy use online in connection with their utility accounts; a reward program offered by sponsors based on how much energy participants save; and a friendly competition between individuals and communities for the most energy savings. - Three communities have been selected to participate in the pilot phase from October 2010 to March 2011: Brookland, DC, Greenbelt, MD and the Cascades neighborhood in Loudoun County, VA.

## Energy Financing Task Force (Anne Mariani | amariani@mwcog.org)

- The task force held its first meeting on July 20 to discuss opportunity for regional collaboration on financing solutions for energy efficiency and renewable energy. This group is chaired by Eric Coffman – Montgomery County.
- The next meeting will be Sept 27, 2010. The meeting will focus specifically on the residential sector, and will investigate innovative financing mechanisms such as loan loss reserve funds, clean energy bonds and other possible alternatives to PACE programs.

# Air and Climate Public Advisory Committee (ACPAC) (Joan Rohlfs | jrohlfs@mwcog.org)

- ACPAC met on September 13. Members heard updates on the 2010 Ozone Season and the Regional Energy
  Outreach Campaign. ACPAC also heard updates on regional use of EECBG funds and heard about a COG database
  of regional contracts for energy efficiency and renewable energy related goods and services. Members discussed
  the implications of the Office of the Inspector General Report on the EECBG program. Staff reported on the
  agendas for upcoming meetings.
- The next meeting will be October 18. ACPAC would like to discuss the Air Quality Index system and how risks are communicated to citizens.

# **Supporting Technical and Policy Committees**

#### MWAQC Technical Advisory Committee (Jeff King | jking@mwcog.org)

- The MWAQC TAC met on September 14.
- EPA has proposed a rulemaking (the Transport Rule) to resolve issues with the Clean Air Interstate Rule (CAIR) that was remanded by the courts to EPA for reconsideration. The rule will set state level budgets and will limit interstate trading of allowances. TAC prepared a draft comment letter for action by MWAQC in September.
- On September 16, the OTC held stakeholder meetings to discuss new proposed model rules under development. The model rules focus on stationary generators, high electricity demand days, lightering controls, nonroad idling regulations, and low solvent degreasers.
- Staff convened meetings of the Energy Managers in the region to develop a proposal for an annual data request to
  area utilities for data needed to help the region track progress in meeting its energy and climate goals. Based on
  the agreement on the specifics of the data request, COG staff worked with representatives from area utilities to
  formalize the request. Utilities are in the process of developing the data response for 2009 and intend to provide
  the reports in the first quarter of each year moving forward. Staff have also developed a new outline for the
  format of the progress report presentation due to CEEPC in the second quarter of 2011.
- COG has launched a new energy outreach campaign.
- The next meeting is scheduled for October 12.

# <u>Transportation Planning Board (TPB), TPB Technical Committee, TPB Travel Management Subcommittee and TPB Scenario Study Task Force</u> (Ron Kirby and Gerald Miller | <u>rkirby@mwcog.org</u> and <u>gmiller@mwcog.org</u>)

• Current activities focus on transition to a new EPA mobile emissions model called the Motor Vehicle Emission Simulation Model (MOVES). The TPB is also working toward implementation of many climate-friendly initiatives. Staff is submitted an application for a regional bike-sharing system to compete for the US DOT TIGER II competitive grant program on August 20. The TPB has also been organizing the annual Regional Car Free Day, which will take place on September 22. Staff has also been continuing work on the CLRP Environmental Consultation process, which currently focuses advanced environmental mitigation of transportation projects, including possible efforts that would provide climate change mitigation and/or adaptation benefits. Lastly, staff is working on preliminary study of climate change adaptation approaches in the transportation sector.
