## How Does CORR Work?

- Facility first Registers with RCI, then submits "Application for Certification"
- RCI Pre-qualification
- Trained RCI Evaluators, independent, thirdparty firms
- Evaluators, using RCI Protocols evaluate the processes, records, and reports of the facility.



# **Types of Certification**

- FULL / CONDITIONAL
- MIXED C&D or SINGLE MATERIAL
- MSW and MIXED C&D COMBINED
- Application Process....





# Registration / Certification

- **REGISTRATION** allows a facility to upload its information
- Not Audited, only self-reported
- CERTIFICATION includes audited/verification and evaluation of data and operational processes




# Certifying MSW/C&D Facilities

- Facilities handling MSW and C&D
- C&D is extracted from MSW line and added to C&D line (w/o measurement)
- CORR Protocol calculates C&D recycling rate based on all incoming materials
- Need to accurately represent the C&D line performance

# **CORR Sampling Protocol**

- Statistical Validity / Reliability / Confidence
- StopWaste Grant / Cascadia Consulting
- Stakeholder Process
- Maintain ISO-level for bodies operating product certification systems and certifying products and services

weight of recovered material

weight of incoming mixed C&D loads

# Sample Cycle & Reporting

- Sampling Event includes 30 loads min 100 tons
- Weighing all C&D recyclables of recovered and residual samples
- Sixteen Sampling Events over a 5-year period
- Quarterly Reporting\* Per Sampling Event
