C. Management approaches and regulatory frameworks are most beneficial when *holistic* (e.g., PFAS).

D. Maximizing access to infrastructure funding through the SRFs—how can our local governments best access funding, especially for pockets of disadvantaged communities within relatively wealthy jurisdictions?

E. Applying sound science, adaptive management, and flexible approaches for achieving and evaluating Bay progress.
