## **Survey Branding**

- Official name of COG/TPB Household Travel Survey:
   Regional Travel Survey (RTS)
- Survey branding reflects the diverse and expansive TPB model region beyond the Washington metropolitan area







#### **Survey Questionnaire and Other Materials**

- COG/TPB staff met with the survey contractor (RSG) to discuss and finalize the variable list
- 2007 HTS variables from the recruit and retrieval surveys were reviewed to determine which variables to keep or drop for the 2017 RTS
- Key new variables for the 2017 survey include:
  - HOV and Express/Managed Lane use
  - Uber, Lyft, and Capital Bikeshare use
  - Types of transit passes used
  - Toll transponder in vehicle



#### **Survey Questionnaire and Other Materials**

- Based on the selected variables, COG/TPB staff has reviewed the draft questionnaire and survey script for the recruitment and retrieval parts of the survey
- COG/TPB staff has also obtained permission from the following transportation agencies to use their logos on RTS materials including the recruitment letter and the survey website:
  - VDOT, MDOT, WMATA, DRPT (approved)
  - DDOT (pending)



## **Survey Sampling Plan**

- RTS will survey 15,000 households within the region during a 12-month data collection period
- An 800 household pretest (including a 400 household smartphone GPS component) to be completed over a two week period
- Address based sampling (ABS) will be used, sampling frame will be a listing of all deliverable city and rural route postal addresses in the TPB modeled region



## **Survey Sampling Plan**

- The sampling frame will be stratified into approximately
   50 to 60 geographic strata in the TPB modeled area
- Sampling strata will comprise of census block group aggregations
- Areas to be sampled will include higher density/mixeduse regional activity clusters and lower-density residential areas
- Oversampling of higher density areas and areas with a greater proportion of hard to reach households (e.g., lower income and racial/ethnic minority households)



# **Updated Survey Schedule**

- Some items still subject to adjustment
- Survey pre-test: early February 2017
  - Following election and major holidays
- Main survey: late May/early June 2017
  - Following WMATA SafeTrack surges (Surges 12-15 revised schedule expected in December)
- Complete main survey: late Spring 2018
- All deliverables by end of 2018





# **Current Project Status**

- Finalize project management plan
- Revision of survey questionnaires based on comments from COG/TPB staff
- Pretest sampling plan in progress (based on ACS block group and other data sources, regional activity center boundaries)

- Procurement of address-based sample based on sampling plan
- Prepare print materials for pretest (recruitment mailings, questionnaire)
- Test latest version of rMove
- Develop project website and mail schedule
- Next report to TFS: January 2017 meeting
