Ms. Rohlfs will discuss development of the 8-hour ozone air quality plan (SIP). Due to coordination of modeling between Virginia Dept. of Environmental Quality with other modeling centers in the Ozone Transport Region, there have been some delays in attainment modeling for the Washington region. Final attainment modeling results are expected in mid-October. The modeling results will be included in the draft air quality plan that will be submitted to MWAQC for approval for public hearing in January. Public hearings will be held in March and final approval of the SIP is expected in April.
