#### **A. APPOINTMENT OF 2012 POLICY COMMITTEE VICE CHAIRS**

The COG Board will be asked to adopt Resolution R08-2012 authorizing the Executive Director, or his designee, to apply for and accept grant funding in an amount not to exceed \$60,000, and to enter into subcontracts, to develop and implement a stormwater education program in the Anacostia Watershed. The duration of the grant is 24 months from the date of execution, and a match of \$2,500 will be made using already-budgeted COG water resources program funds.

COG established the Cooperative Forecasting program in 1975 to enable local, regional and federal agencies to coordinate planning using common assumptions about future growth and development. The Cooperative Forecasts are developed through a “top-down / bottom-up” process which synthesizes regional econometric model projections and local government forecasts based on current and planned development. The Planning Directors Technical Advisory Committee (PDTAC) approved this first update to the 8<sup>th</sup> major series of Forecasts, “Round 8.1” on January 20, reflecting the 2010 Census and local economic trends. The Board will be asked to approve the draft Round 8.1 Forecasts for use by the National Capital Region Transportation Planning Board (TPB) in the Air Quality Conformity Analysis of the 2012 Financially Constrained Long Range Transportation Plan (CLRP) and the FY2013-2018 Transportation Improvement Program (TIP).

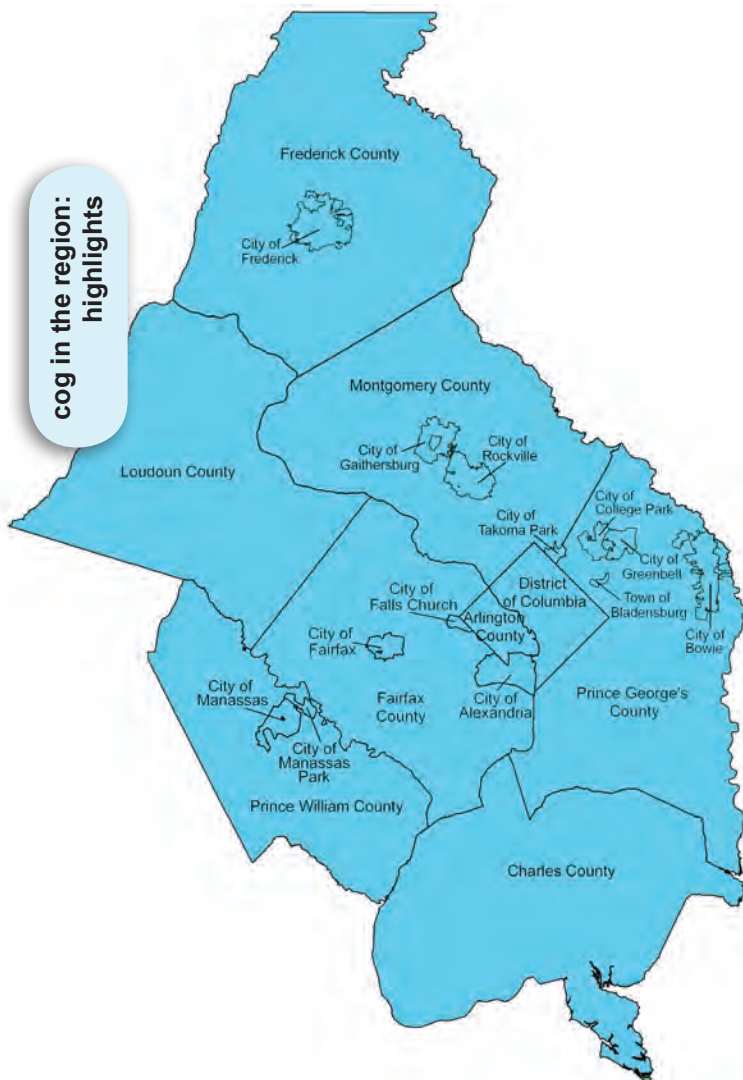

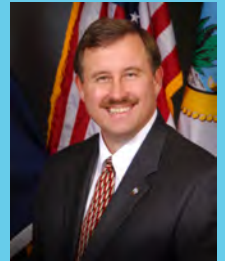

### **Message**

Recycling is the most universally accepted green activity that Americans do every day. Studies have found that recycling contributes a significant reduction to greenhouse gas emissions in the United States and can contribute more savings if expanded. With at least 50 percent of all waste generated in the workplace, focusing on recycling at work can yield big gains for the environment.

The Metropolitan Washington Council of Governments (COG) launched the Go Recycle Campaign in an effort to empower and educate local residents to extend their home recycling practices into the workplace. Through two 60-second pre-recorded radio spots that use humor to affect behavior change, the audience is directed to a Web site ([www.GoRecycle.org](http://www.GoRecycle.org)), a Facebook page ([www.facebook.com/gorecycle](http://www.facebook.com/gorecycle)), and a toll-free phone number (877-GoRecycle) for more information about how to improve recycling at work. The media spots may be found under the [Learn>Media](#) menu on the new [www.GoRecycle.org](http://www.GoRecycle.org) Web site. The campaign will build on the success of COG's similar 2002-2011 campaigns.

### **Coverage**

Local radio stations will air the spots during prime driving times from February 20-March 3, 2012. The target audience is women age 25 to 54. The \$67,500 media buy will use multiple radio stations. Our media buyer, PRR, has secured promotional extras from the stations to increase campaign awareness.

### **Sponsorship**


Dear Governor O'Malley, Governor McDonnell, and Mayor Gray,

I am writing to you on behalf of the Board of Directors of the Metropolitan Washington Council of Governments about a vital issue for the National Capital Region – **insuring full funding and participation in the Interstate Commission on the Potomac River Basin (ICPRB)**. There are very few organizations as critical to the future success of our growing region – currently 5 million residents, and by 2040, expected to reach nearly 7 million people.

Simply put, within the framework of the interstate compact established by Congress in 1940 for the enhancement and protection of the 14,000 square miles of the Potomac River Basin, ICPRB is the agency that has provided the expert technical analysis and ongoing support critical for assuring that water supply fundamental to the economic development and health of the National Capital Region citizens is available in perpetuity. The ICPRB is also the central coordinator enabling the region to withstand periods of drought. These extraordinary accomplishments occur within the structure of the interstate compact and associated water supply agreements among the states and District parties to the ICPRB compact, in conjunction with area water providers.

I strongly urge you take the actions necessary to fully fund and actively participate in the Interstate Commission on the Potomac River Basin.



##### **A. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT TO OBTAIN THE SERVICES OF A REGIONAL INCIDENT COORDINATION (RIC) PROGRAM MANAGER**

The Board adopted Resolution R01-2012, authorizing the COG Executive Director, or his designee, to receive and expend up to \$100,000 to fund a RIC Program Manager. The program manager will review, compile, and disseminate emergency related information from various regional stakeholders and outlets. Centralizing regional emergency messaging would result in more timely and informed decision making, specifically related to closure and early/ delayed dismissal actions. Funding for this effort will be provided through a Subgrant from the State Administrative Agent (SAA). No COG matching funds are requested.

##### **B. RESOLUTION AUTHORIZING COG TO RECEIVE AND EXPEND FUNDS FOR THE ONGOING MAINTENANCE CONTRACT AND REOCCURRING SERVICE FEES FOR THE REGIONAL AUTOMATED PROPERTY INFORMATION DATA (RAPID) BASE**

The Board adopted Resolution R02-2012, authorizing the Executive Director, or his designee, to receive and expend \$38,000 for the ongoing maintenance contract and recurring service fees for RAPID. Funding for this effort will be provided to COG through a Subgrant from the SAA. No COG matching funds are requested.

##### **C. RESOLUTION AUTHORIZING COG TO RECEIVE AND EXPEND FUNDS TO SUPPORT THE "FRIENDS OF WEDNESDAY'S CHILD FUND"**

The Board was asked to adopt Resolution R03-2012, authorizing the Executive Director, or his designee, to accept a \$25,000 grant from the Freddie Mac Foundation for the Friends of Wednesday's Child Fund. The Wednesday's Child Committee established the Fund and oversees dispersal of grant stipends for the unmet needs of children in the region's foster care system. No COG matching funds are requested.

##### **D. RESOLUTION IN SUPPORT OF A GRANT FOR A REGIONAL FOSTER PARENT OF THE YEAR GALA AND 20<sup>TH</sup> ANNIVERSARY SALUTE TO WEDNESDAY'S CHILD**

The Board was asked to adopt Resolution R04-2012, authorizing the Executive Director, or his designee, to seek and accept a \$125,000 grant from the Freddie Mac Foundation for a combined Foster Parent of the Year and Wednesday's Child 20<sup>th</sup> Anniversary Gala. Wednesday's Child represents a long partnership between COG, the Freddie Mac Foundation, News4 and local child welfare agencies. COG matching funds are requested.

**ACTION: Upon motion made, and seconded, Resolution R01-2012 were unanimously approved and adopted.**

#### **7. ELECTION OF COG BOARD OFFICERS**

Chairwoman Harrison recommended the approval of the proposed slate of the COG Board's Officers for 2012: Chairman – Frank Principi, Prince William Board of County Supervisors; Vice Chairman – Phil Mendelson, Council of the District of Columbia and Vice Chairman – Karen Lewis Young, Frederick Board of Alderman.

**ACTION: Upon motion made, and seconded, COG Board Officers for 2012 were unanimously approved and adopted.**

#### **8. RECOGNITION OF IMMEDIATE PAST CHAIRMAN**

Chairman Principi thanked past Chairwoman Harrison for her leadership and presented her with a crystal gavel.

#### **9. APPROVAL OF FY 2013 WORK PROGRAM AND BUDGET**

Mr. Robertson summarized the proposed FY 2013 Work Program and Budget which will increase slightly by less than 1 percent from FY 2012. Membership assessments have been frozen for the last three years and to lessen the impact on faster growing jurisdictions as the result of population changes, COG capped the increase in membership fees at 5 percent.

The proposed FY 2013 work program is aligned with COG strategic plan which will focus on Region Forward to address key priorities of transportation mobility, climate and energy, housing, and public safety; the preparation for the dissolution of the Freddie Mac Foundation, implementation of the member-wide StreetSmart program, ongoing increases in healthcare and pension costs, and reactivating employee merit raises.

Fairfax County Supervisor Penny Gross asked about the restriction policy on the reserve balance and Mr. Robertson answered that any withdrawals from the reserve fund must be requested and approved by the COG Board with an acceptable reason. Mr. Robertson did agree with Chairman Principi and Ms. Gross that because of the decline in contribution activity by private funders for philanthropy COG should proactively research other resources for funding. Mr. Robertson also addressed other issues with Board members to have more briefings on the activities of the Transportation Planning Board, consolidating similar policy committees, and coordination on the education, engineering, and enforcement of the StreetSmart program.

**ACTION: Upon motion made and seconded, FY 2013 Work Program and Budget was unanimously approved and adopted.**

#### **10. ADOPTION OF 2012 POLICY PLATFORM**

COG Board leadership and COG staff will be focusing on enhancing COG's policy priorities, and strengthening relationships with state and federal elected officials in the coming year. Nicole Hange, COG's Government Relations and Member Services Coordinator, provided an overview of the proposed 2012 Policy Platform and opportunities for outreach.

Ms. Hange discussed the process of this year's platform development, which has been refocused to align with Region Forward, and the limitations on COG's advocacy efforts as a 501c(3) organization. Staff has worked with COG's policy committees and the Ad-Hoc Legislative Committee of the COG Board to draft the region's 2012 policy platform. The platform includes COG's policy priorities as well as supplementing issue specific briefs that highlight the roles and actions necessary, of state and federal officials, to strengthen economic competitiveness in the National Capital Region.

The Policy Platform will be distributed to the Maryland and Virginia General Assemblies, the Council of the District of Columbia, Congress and other stakeholders as appropriate. Staff will be participating in the VACo/VML day in Richmond February 9, and will host a luncheon in Annapolis, date TBD to raise awareness of COG's work and the region's priorities.

Ms. Hange noted that the process for platform development has improved in recent years but would benefit greatly from a more strategic approach. She will return to the Board with a recommendation by summer.

Montgomery Council President Roger Berliner suggested that in addition to our planned outreach efforts, we consider inviting legislators in key leadership positions to speak before the Board.

Loudoun County Board Supervisor Matt Letourneau requested a language change to the sustainability priority: "Support EPA national rules to reduce pollution-creating emissions, and help states and local governments meet the federal air quality health standard for ozone" to add "*cross state pollution-creating*" to narrow the intent and potential for misinterpretation.

**ACTION: Upon motion made and seconded, the 2012 Policy Platform was unanimously approved and adopted as amended.**

#### **11. APPOINTMENT OF 2012 POLICY COMMITTEE LEADERSHIP**

The appointment of 2012 leadership for COG policy advisory committees, public-private partnerships and administrative committees was recommended by Chairman Principi. Additional appointment action is anticipated in February as COG receives information concerning final appointments by its member governments to COG boards and committees.

**ACTION: Upon motion made and seconded, the 2012 Policy Committee Leadership was unanimously approved and adopted.**

#### **12. REGION FORWARD UPDATE**

Prince George's County Council Member and Region Forward Chairman Eric Olson and District of Columbia Director of Planning and Region Forward Vice Chair Harriet Tregoning briefed the Board on the Coalition's 2012 activities. The briefing included a summary of the goals and objectives for the Regional Activity Center update and Complete Community Typologies; Performance Baseline; Opportunity Mapping; and TOD Housing Plan. Board members responded favorably to the goals and added a sense of urgency to the proposed activities. Chairman Principi reaffirmed that a principal priority for his tenure is to ensure that the proposed 2012 Region Forward activities are achieved in a timely manner and that the COG-wide work program support continued success in this effort.

Arlington County Board member Walter Tejada noted that in addition to preserving or increasing the supply of affordable housing in transit station areas or activity centers, it is important that efforts also be made through Region Forward and locally to prevent displacement of existing residents and businesses. Falls Church Council Member Dave Snyder stated that, particularly in light of current economic conditions, Region Forward outcomes should be concrete and seek real solutions.

**ACTION: Region Forward update was accepted.**

#### **13. INCIDENT MANAGEMENT RESPONSE REPORT IMPLEMENTATION**

Montgomery County Council Member and Chair of the Incident Management and Response (IMR) Steering Committee Phil Andrews provided a Status Report on key objectives found in the Final Report

approved by the COG Board on November 9, 2011. He reviewed the four focus areas: (1) Improve Real time information or situational awareness among local, state, and federal government agencies with operational authority and responsibility; (2) Improve real-time information to the media and the public; (3) Improve regional coordination; and (4) Strengthen and focus decision making.

Chair Andrews reported the establishment of a Virtual Joint Information Center (V-JIC) that supports the rapid release of real-time information to the media and the public in the NCR during a storm or other major event. He noted that work is underway to automatically integrate Metropolitan Area Transportation Operations Coordination (MATOC) program information automatically into WebEOC, and to bring MATOC to a 24/7 capacity. Release and "stay put" policies have been improved as the Office of Personnel Management (OPM) has revised its policies, affecting hundreds of thousands of employees directly as well as indirectly influencing decisions of other employers. Mr. Andrews stated that the establishment of a Regional Incident Coordination (RIC) program is underway to improve regional incident management and response by drawing on new and existing tools and increasing coordination.

In moving forward, Chair Andrews noted that the IMR group will continue to meet in 2012 to oversee progress of their recommendations and will report back to the COG Board of Directors regularly on progress.

**ACTION: Report accepted and referred to implementing authorities, agencies and jurisdictions.**

**WHEREAS**, on September 10, 1975, the Board of Directors of the Metropolitan Washington Council of Governments (COG) authorized the development of a Cooperative Forecasting Program as a component of the Metropolitan Growth Policy Program; and

**WHEREAS**, the purpose of this Program is to provide current forecasts of population, households, and employment growth and change for use in metropolitan planning programs, including the Water Resources, Transportation Planning, Air Quality, Energy Resources, Metropolitan Development and Housing Programs; and

**WHEREAS**, the Cooperative Forecasting and Data Subcommittee of the Planning Directors Technical Advisory Committee has been actively engaged during the past year in developing this first update to the 8<sup>th</sup> major series of forecasts, based on current regional development trends, as the basis for further study of land use/transportation relationships to comply with Federal regulations implementing the Clean Air Act Amendments and the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) ; and

**WHEREAS**, the Cooperative Forecasting Program has involved the active participation of the COG's participating governments, as well as Anne Arundel, Carroll and Howard counties and the Tri-County Council for Southern Maryland, which have provided local population, household, and employment forecasts, documentation of methodology and assumptions upon which the forecasts are based, and related analyses for use in the process, and has involved full participation of the Baltimore Metropolitan Council, Fredericksburg Area Metropolitan Planning Organization, the Maryland Office of Planning, and the National Capital Planning Commission; and

**WHEREAS**, to further enhance coordination between regional land use and transportation planning, on February 12, 2003 COG adopted Resolution R8-03, which recommends that approval of each round of the Cooperative Forecasts should occur concurrently with the completion of the National Capital Region Transportation Planning Board's (TPB) Air Quality Conformity Analysis of the Transportation Improvement Program (TIP) and the Financially-Constrained Long Range Plan (CLRP);

**WHEREAS**, on January 20, 2012 the Planning Directors Technical Advisory Committee recommended the draft Round 8.1 Cooperative Forecasts for use by the TPB in this year's Air Quality Conformity Analysis of the 2012 CLRP and the FY 2013-2018 TIP.

# Metropolitan Washington Council of Governments

**INTRODUCTION:** Two forces will shape COG's Region Forward implementation in 2012. The first, is the continued fiscal challenges facing local and state governments struggling to recover from the economic recession. We cannot afford business as usual and will need to innovate and leverage resources in new ways.

The second is an historical reliance on the federal government to drive economic growth. The federal government has provided a strong foundation for decades and will continue to play a major role in the region's economy. However, a plan for economic growth and competitiveness is needed to help put the region on even more solid footing, and COG will help lead the way in its development.

Our region's prosperity depends upon our ability to adapt to changes in the economy. As one of the four pillars of Region Forward, beginning to move the needle on the region's prosperity goals and targets will be the focus of the COG Board of Directors' 2012 Work Plan.

## Economic Growth & Competitiveness Plan

The likelihood of fewer federal workers and reduced federal spending warrants a more pro-active regional approach to build on the region's economic and job strengths, address areas of weakness, and identify new or emerging opportunities.

- **Launch an Economic Growth and Competitiveness initiative.** A Board Task Force, in collaboration with the private sector, will scope the effort and identify the partnerships, roles, resources and benefits required.
- **Develop draft action plan by Fall 2012.** The Board will take the lead role by hosting a series of open discussions and work sessions to be held throughout the year during COG Board of Directors meetings and will ultimately result in the formation of the regional plan. Building upon the Brookings Metropolitan Business Plan model, the plan will leverage regional partners' current efforts, and establish an integrated, public-private regional agenda for job creation and enhanced innovation and entrepreneurship.



## Increasing Stakeholder Diversity & Participation

COG will create economic opportunity where none currently exists through strategic alliances with the federal government as well as non-traditional partners. While federal spending will likely decrease in the coming years, the region is still home to the federal government and COG should continue to strengthen the federal-regional partnership. COG must also look to non-traditional partners to support the work historically supported by the federal government and organizations like Freddie Mac.

- **Host “Building the Region 2” with the White House, Cabinet members and key federal agencies.** In 2010, COG began a dialogue with the Obama Administration to position metropolitan Washington to receive the limited resources directed at regional initiatives. It is time to ramp up this dialogue to sustain progress in the region.
- **Engage the philanthropic, business, and civic community in a series of workshops** aimed at supporting programs and initiatives that have traditionally depended on federal funding.





## Region Forward Implementation

As the region's vision and the underpinning for COG's Strategic Plan, the implementation of Region Forward is a central part. While each of the initiatives outlined in COG's work program and budget are aimed at achieving our shared goals and targets, we must first establish the basis from which progress will be measured.

- **Complete a comprehensive performance baseline analysis for Region Forward.** This analysis will serve as the first assessment of how close our region is to meeting our common goals and targets and will serve as a basis for measuring future progress.
- **Identify policy alignment and gaps between local comprehensive plans and Region Forward.** A third party independent review will identify policy alignment areas where local plans help contribute to regional goals and identify opportunity areas where local policies and plans can support Region Forward. This review will make recommendations on how local jurisdictions can address policy gaps to meet regional goals in areas of housing, land use, growth, transportation, energy and the environment.



## Member Services

Prolonged budget constraints require, now more than ever, that COG enhance and expand its member services and make clear the value added from membership in COG.

- **Improve communication and transparency through new technology.** COG will procure the software necessary to enable live video streaming of COG meetings and events. Many of COG's member governments have this capability and find it an essential public transparency and accessibility tool. Additionally, the ongoing video conference pilot program will be assessed in the Spring for its effectiveness. This capability allows members, specifically those from the outer jurisdictions, an alternative method of Board meeting participation.
- **Develop tailored member service reports.** As a member association, COG must be able to clearly articulate a member's return on investment. Staff will develop tailored member service reports that highlight both shared benefits of COG membership as well as jurisdiction-specific benefits like grants, technical assistance and cost savings.
- **Development of a Strategic Plan for outreach.** Strengthening COG's relationship with state and federal legislators continues to be a priority for COG and its staff. Current outreach efforts would significantly benefit from a strategic plan that identifies a process for developing policy priorities and a strategy for continued engagement of local, state and federal officials. The region cannot achieve its vision without an equal commitment from, and strong partnerships with, state and federal governments.

Subject: **Fiscal Year 2012 Second Quarter Financial Reports**

I am pleased to transmit the second quarter (October to December) financial reports for fiscal year 2012. These reports show significant budgetary and fiscal developments that further strengthen COG's financial position and allow for the completion of this year's approved work program as well as meeting strategic goals.

#### **Balance Sheet - Schedule 1**

Cash at December 31, 2011 was \$3,863,383. The current position allows COG to meet its cash requirements for financial operations in a timely manner.

For the second quarter of the fiscal year 2012, COG's unrestricted net reserve funds were at \$9,466,302. The reserve funds are invested in certificates of deposits and are laddered in maturities to meet liquidity and average rate of returns requirements. The reserve funds include a cash balance of \$10,154,149 with interest. \$687,847 is recorded against the reserve for the net pension obligation related to the required actuarial pension contribution.

#### **Income Statement – Schedule 2**

COG's revenues for the six month period exceeded expenses by \$4,326,105. Interest income from investments amounted to \$94,024. The current average yield on the certificates of deposits is 3.1%

#### **Comparative Project Budgets - Schedule 3**

Total forecast annual program revenues increased by \$1,638,550 or 6.2% from the adopted work program budget. The reason for this change was mainly due to the increased federal funding for the Transportation Program.

#### **Accounts Receivable Aging – Schedule 4**

The Accounts Receivable balance was at \$7,792,740. \$2,330,436 or 30% was over ninety days which COG subsequently has received payments of \$667,861. The staff is working with state and local agencies on the remaining balance.
