Proactive:

Show Truck Drivers where to Drive:

- Provide access into/through the City
- Lead drivers into neighborhoods
- Restrict certain routes during evening/overnight hours

Enforcement concentrated in the port areas


Due to compliance enforcement locations are rotated to

Temporary Full Road Closure and Detour for Construction

- For the Convenience of a Developer
 - Full Road Closures are not routine and require additional evaluation and approvals
 - Developer required to provide communication to affected neighborhoods and businesses
 - Pays the costs of closure
 - Performs the work required for the closure
