3. Approval of Joint COG-GWBOT Business Continuity Web Tool (2:20-2:30)

COG and the Greater Washington Board of Trade (GWBOT) worked together to produce a business continuity planning tool to aid small and medium size businesses in developing individualized business continuity plans. The planning tool was designed to be interactive and will be placed on COG's web site, with links on the GWBOT and other web sites. The project consultant will brief the NCR-EPC on the planning tool.

4. Recommend COG Board Approve a Proposed Letter Concerning Frederick County Inclusion in the Definition of the National Capital Region (2:30-2:40)

The Homeland Security Act of 2002 established the U.S. Department of Homeland Security and the Office for National Capital Region Coordination. The law adopted a definition of the National Capital Region that did not include Frederick County, making the County ineligible to receive funding and other support available to communities in the National Capital Region. Frederick County is in the federally defined MSA, a COG member government and signatory to the Regional Emergency Coordination Plan. The NCR-EPC will be asked to recommend that the COG Board transmit a letter to the congressional delegation requesting that Congress re-examine the definition of the National Capital Region to include key communities such as Frederick County.

Recommended Action: Endorse COG Board sending a letter to the congressional delegation.

5. Status Report and Presentation of Preliminary Outcomes for the RECP Transportation Evacuation/Protective Actions Annex Expansion (2:40-3:00)

The NCR-EPC previously endorsed proceeding with an update and strengthening of three key elements of the RECP: 1) R-ESF #1 Transportation; 2) the Regional Emergency Evacuation Transportation Coordination Annex; and 3) the Protective Actions Annex. This work is being performed in collaboration with related federal/state/local operations and response planning. The NCR-EPC will be briefed on how the annex expansion is being accomplished, preliminary outcomes, and coordination of these endorsed tasks with the District of Columbia and other regional stakeholders.
