The TPB Bylaws provide that the Steering Committee "shall have the full authority to approve nonregionally significant items, and in such cases it shall advise the TPB of its action."

RESOLUTION ON AN AMENDMENT TO THE FY 2017-2022 TRANSPORTATION IMPROVEMENT PROGRAM (TIP), THAT IS EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT, TO INCLUDE FUNDING FOR THE EMBARK RICHMOND HIGHWAY COMPREHENSIVE PLAN AMENDMENT STUDY, AS REQUESTED BY THE VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT)

WHEREAS, the National Capital Region Transportation Planning Board (TPB), which is the metropolitan planning organization (MPO) for the Washington Region, has the responsibility under the provisions of the Fixing America's Surface Transportation (FAST) Act for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the Metropolitan Area; and

WHEREAS, the TIP is required by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as a basis and condition for all federal funding assistance to state, local and regional agencies for transportation improvements within the Washington planning area; and

WHEREAS, on November 16, 2016 the TPB adopted the FY 2017-2022 TIP; and

WHEREAS, in the attached letter of November 21, 2016, VDOT has requested that the FY 2017-2022 TIP be amended to include \$800,000 in FTA Section 5309 planning grant and matching funds in FY 2017 for the Embark Richmond Highway Comprehensive Plan Amendment Study, as described in the attached materials, and

WHEREAS, this project is exempt from the air quality conformity requirement, as defined in Environmental Protection Agency's (EPA) Transportation Conformity Regulations as of April 2012;

NOW, **THEREFORE**, **BE IT RESOLVED THAT** the Steering Committee of the National Capital Region Transportation Planning Board amends the FY 2017-2022 TIP to include \$800,000 in FTA Section 5309 planning grant and matching funds in FY 2017 for the Embark Richmond Highway Comprehensive Plan Amendment Study, as described in the attached materials.

The Virginia Department of Transportation (VDOT) requests an amendment to the FY 2017-2022 Transportation Improvement Program (TIP) to add funding for the Embark Richmond Highway Comprehensive Plan Amendment Study. Fairfax County, Virginia will use a recently awarded Federal Transit Administration (FTA) grant to supplement comprehensive planning efforts for transit oriented development around nine planned Bus Rapid Transit (BRT) stations along the Richmond Highway Corridor.

The TIP amendment adds \$800,000 to the TIP in FY 2017. Fifty percent (50%) of the funding will be provided by an FTA Section 5309 planning grant. The Virginia Department of Rail and Public Transportation (DRPT) and Fairfax County will each contribute 25% of the project budget. VDOT staff has entered the amendment in the TPB's iTIP online database. This is a planning project and therefore will not affect the regional Air Quality Conformity Analysis. Additional information about this project is included in the attached letter from Fairfax County.

VDOT requests that this amendment be approved by the Transportation Planning Board's Steering Committee at its meeting on December 2, 2016. VDOT's representative will attend the meeting and will be available to answer any questions about the amendments.

The Fairfax County Department of Transportation (FCDOT) respectfully requests that the Virginia Department of Transportation amends the FY 2016-2021 Transportation Improvement Program to add the Federal Transit Administration's (FTA's) Transit-Oriented Development (TOD) Pilot Program grant funding recently awarded to Fairfax County for the Embark Richmond Highway Comprehensive Plan Amendment project.

The County was awarded \$400,000 to supplement our current comprehensive planning efforts of transit oriented development (TOD) around the nine (9) planned BRT stations along the Richmond Highway corridor. We plan to use those funds to refine our planned grids of streets around those BRT stations, develop urban design standards for the corridor and to ensure the station areas are planned in such a way to maximize bicycle/pedestrian interaction, providing enhanced access to and from the BRT stations. The Southeast Fairfax Development Corporation (SFDC) is named as a partner in the grant application.

Matching funds are provided from the Virginia Department of Rail and Public Transportation (DRPT), in the amount of \$200,000, and Fairfax County, also in the amount of \$200,000. Combined, this amount for use in the study is \$800,000.

Dear Secretary Foxx:

I am writing to express the support of the National Capital Region Transportation Planning Board (TPB), the metropolitan planning organization (MPO) for the National Capital Region, for the Maryland Department of Transportation's application to the Fostering Advancements in Shipping and Transportation for the Long-term Achievement of National Efficiencies (FASTLANE) grant program.

The TPB understands that the <u>Howard Street Tunnel</u> project in Baltimore City will generate significant benefits for the National Capital Region and the nation overall. This project will provide the vertical clearance needed to enable double stack railcars to move from the Port of Baltimore to the rest of the nation. This will result in significant public benefits such as reduced highway congestion, increased roadway safety and improved air quality. Not only will this project address a long-standing bottleneck in the national rail network, but the improvements will be undertaken in a cost-effective manner with minimal impact to the public. The award of this grant will allow the project to be constructed as quickly as possible.

This infrastructure project is an example of the public and private sectors working together to streamline freight movement and generate benefits for many years to come. With freight volumes expected to increase dramatically over the coming decades, it is important to fund and construct the Howard Street Tunnel project to increase the capacity and improve the efficiency of the freight transportation system and to ensure the country is prepared to accommodate, and benefit from, future growth in freight demand.

The TPB supports this project and appreciates your strong consideration of this application. Even though it is not located within the TPB planning area, the Howard Street Tunnel expansion project is identified in the National Capital Region Freight Plan as a critically important project for the National Capital Region. This project also directly responds to the regional transportation goals and priorities adopted by the Transportation Planning Board and recognizes that the National Capital Region and the Baltimore region are part of the Northeast Megaregion identified by the U.S. Department of Transportation.

On Thursday, December 8, 2016, The TPB and the Bicycle and Pedestrian subcommittee hosted a Transportation/Land Use Connections (TLC) program's Peer Exchange Network (TLC PeerX) event titled, "Fill in the Gaps: Bicycle and Pedestrian Projects Across the Region." The event was held at the Martin Luther King Main Library in the District of Columbia. Six speakers discussed bicycle and pedestrian related projects supported by TLC technical assistance, Transportation Alternative Program Funds, and other TPB partnerships.

PROGRAM OVERVIEW

The TLC PeerX program provides opportunities for the region's planners to engage in information exchange, professional development, and networking around TLC-related projects and topics. Since 2011, the TPB has hosted several workshops, small conferences, and webinars centered around past TLC projects. TLC PeerX was created based on input from past TLC technical assistance recipients, the TLC selection panel, and recommendations from previous internal program evaluations. The goal of TLC PeerX is to provide a variety of opportunities to communicate information and best practices on TLC topics.

FILL IN THE GAPS EVENT

Since 2007, the TPB has supported over 100 projects through TLC technical assistance, and many of those projects concentrated on bicycle and pedestrian-related improvements. These project focus on small, local plans or facilities that work to "fill in the gaps" in existing bicycle or pedestrian networks. The PeerX event gave planners the opportunity to learn how their peers leveraged TLC technical assistance to advance projects toward implementation.

Six speakers presented on various TLC-related projects and topic areas:

• FY 2016 TLC planning project: Low Traffic Stress Bicycle Network Mapping David Goodman, Transportation Planner, Arlington County Department of Environmental Services

Mr. Goodman presented on the results of the County's low traffic stress analysis of his existing bicycle facility network. The results of the project will help the County conduct more detailed analysis and prioritize future improvements in its upcoming Bicycle Master Plan process.

• FY 2016 TLC planning project: Bringing Bikeshare to Reston Adam Lind, Bicycle Program Manager, Fairfax County Department of Transportation

Mr. Lind spoke on the County's efforts to determine the feasibility of bikeshare in Reston, looking at station locations, potential demand, and existing bike facilities. The County officially opened Bikeshare in the Reston area in October 2016.

 TPB 2012 Station Access Study and the 2015 ongoing WMATA Metrorail Station Area Strategic Investment Plan

Jamie Carrington, Planner, Washington Metropolitan Area Transit Authority Planning Department

Mr. Carrington presented on WMATA's station access work to analyze existing local plans and determine where new improved bicycle and pedestrian facilities could expand the walkshed, and improve station access to new riders. This ongoing study builds off a previous 2012 TPB study, that looked at station access at 25 under-utilized WMATA and commuter rail stations.

City of Takoma Park Safe Routes to School Program
Lucy Neher, Safe Routes to School Planner, City of Takoma Park Department of Housing and
Community Development

Ms. Neher spoke on the City's Safe Routes to School program, including direct services and implementation projects focused on bicycle and pedestrian connections to local schools. The TPB has funded several Safe Routes to School projects for Takoma Park through the Transportation Alternatives Program.

• FY 2015 TLC planning project: Creating Non-Auto Infrastructure in the Life Sciences Center Steve Findley, Environmental Planner, Montgomery County Planning Department

Mr. Findley spoke on his work involving the proposed Life Sciences Center Loop Trail in Montgomery County. The trail is part of the County's Great Seneca Science Corridor plan, connecting existing and proposed life sciences facilities and residential areas with trail facilities and a future route of the Corridor Cities Transitway.

• FY 2016 TLC planning project: K Street/Water Street Bikeway and Pedestrian Connectivity Enhancements

Will Handsfield, Director of Transportation, Georgetown Business Improvement District

Mr. Handsfield presented on a proposed trail connection in Georgetown to connect the Capital Crescent and Rock Creek trails. The new connection will also integrate with the National Park Service's redevelopment of a Potomac River boathouse and the proposed DC Streetcar route.

BACKGROUND

To help raise public awareness of pedestrian safety the National Capital Region Transportation Planning Board (TPB) runs a regional pedestrian and bicycle safety campaign known as Street Smart. Street Smart is an educational campaign, directed at motorists, pedestrians and bicyclists, with the goal of reducing pedestrian and bicyclist injuries and deaths. It consists of Fall and Spring waves of TV, transit, outdoor, internet advertising, with supporting law enforcement carried out by partner agencies.

PUBLIC RELATIONS AND MEDIA

The Fall 2016 campaign wave launched on Friday, November 4th, and ran through November 27th. A memo describing the launch event was included in the November TPB mail-out.

Coverage resulting from the event included 34 television news stories, 8 radio news stories, and 36 online news stories. A complete list is attached.

Paid media included:

- Two weeks of 15 second television spots
- 120 bus tails for 4 weeks
- 500 pumptoppers at 125 gas stations for 4 weeks
- Facebook, Pandora, YouTube and Twitter for one month

ENFORCEMENT ACTIVATIONS

In addition to paid media, police from around the region carried out nine "enforcement activation" events. The press was notified in advance about the time and location of the enforcement, giving them the opportunity to cover live enforcement in their own jurisdictions.

To call educate the public directly, and warn them about upcoming enforcement, Street Smart deployed "Street Teams" of walking billboards to educate the public about safer behaviors at high crash locations.

NEXT STEPS

The Spring campaign wave will likely take place in April. Maryland will host the press event.

The campaign uses the successful "Tired Faces" creative of recent years. The Advisory Group has recommended that we continue to use the current materials through Spring 2017.

The Street Smart Advisory Group met on December 12th to begin the process to review proposals for a new creative approach, which would be launched in Fall 2017.
