Description:

Ms. Rohlfs will discuss the revisions to the schedule for completion of the 8-hour ozone state implementation plan.

The Mid-Atlantic states are coordinating a control measure strategy with the Northeastern states and states in the Mid West. As a result of the collaboration, control measures will be applied to a broader geographic area, providing a larger benefit than local measures could provide. The downside of the collaboration is that the Ozone Transport Commission (OTC) and others are about 6 months behind in their schedule. The OTC expects to have model rules developed by June or later.

Item 5: Attainment Modeling: Status Report

Presenter: Tom Ballou, Virginia Dept. of Environmental Quality

Description:

Mr. Ballou will discuss preliminary modeling results and the next steps for the Washington region's attainment demonstration.

The Clean Air Act requires nonattainment areas to perform photochemical modeling to demonstrate that the area will meet the National Ambient Air Quality Standard under worst case scenarios. Virginia Dept. of Environmental Quality (VDEQ) is the lead modeling agency to model attainment for the Washington, DC-MD-VA nonattainment area for the 8-hour ozone standard.

Modeling for both standards, 8-hour ozone and fine particles, is being conducted by Regional Planning Organizations such as the Ozone Transport Commission (OTC) and the Visibility Improvement State and Tribal Association of the Southeast (VISTAS) on a scale that includes the Northeast and Mid-Atlantic states as well as the Mid-West. VDEQ's modeling for the Washington-Baltimore domain is being done in parallel with the larger regional efforts.
