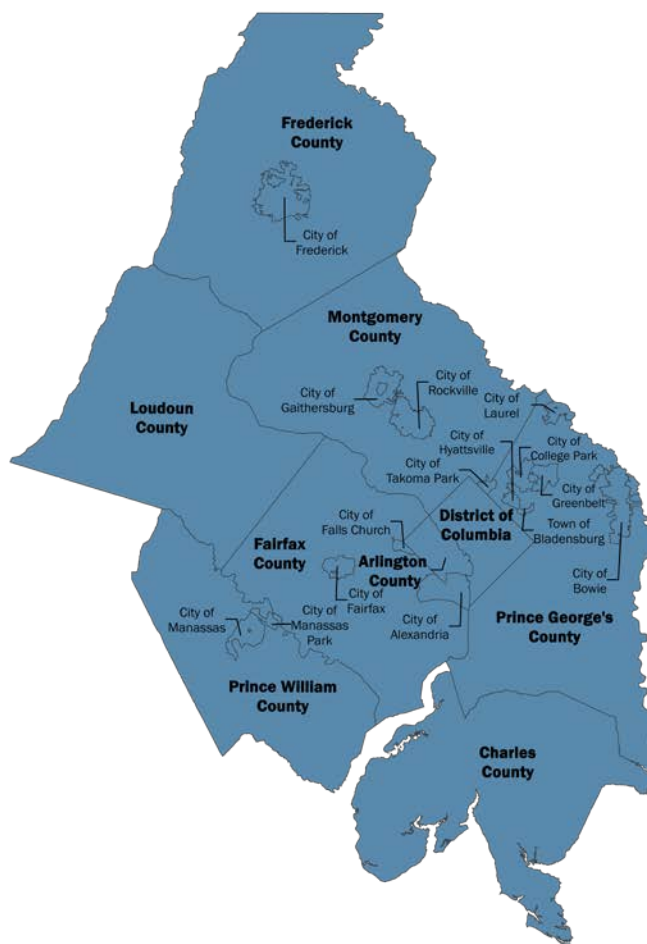
INTRODUCTION

Local governments in metropolitan Washington have worked cooperatively for many years to develop region-wide and neighborhood level forecasts of employment, population, and households. The very first round of Cooperative Forecasts – Round 1 – was adopted by the Metropolitan Washington Council of Governments (COG) Board in 1976. Through this effort, a consistent set of local and regional forecasts is developed for use in program and facilities planning throughout the region.

The Cooperative Forecasting Program, established in 1975 and administered by COG, enables local, regional, and federal agencies to coordinate planning decisions using common assumptions about future growth and development in the region. Each series of forecasts, or a “round,” provides land use activity forecasts of employment, population, and households by five-year increments. Each round covers a period of 20 to 30 years.

The Cooperative Forecasting process provides data necessary for regional planning activities including analyzing the effects of growth and developing policy responses to regional issues. In addition, the forecasts are used to determine the demand for public facilities including schools, parks, medical facilities, roads, stores, and services.

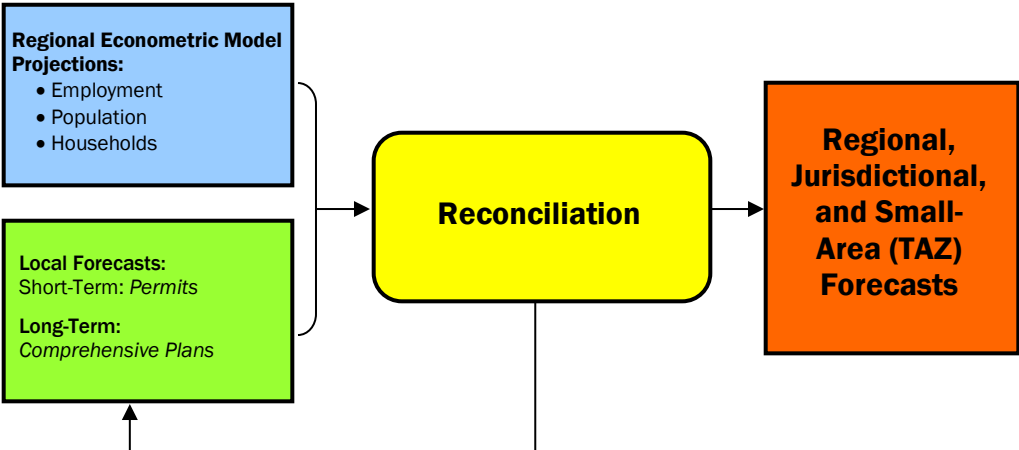

PROCESS

The Cooperative Forecast is a multi-stage, “top-down/bottom-up” process undertaken by COG’s Planning Directors Technical Advisory Committee (PDTAC) and the Cooperative Forecasting and Data Subcommittee. It employs a regional econometric model and local jurisdictional forecasts. The model projects employment, population, and households for the metropolitan Washington region based on national economic trends and local demographic factors.

While the model is based on the COG / Transportation Planning Board (TPB) Planning Area geography, at the time of the development of the Round 9.0 model the urbanized portion of Fauquier County, Virginia was not included. Concurrently, local jurisdictions develop independent projections of population, households, and employment based on pipeline development, market conditions, planned transportation improvements, and adopted land use plans and zoning, taking into account the preliminary regional projections.

The Cooperative Forecasting and Data Subcommittee, which is comprised of local government planners, economists, and demographers, review and reconcile the two sets of projections. The model and local jurisdictional projections must be within three percent of each other for the new set of Cooperative Forecasts to be reconciled.

The forecasts are presented to and approved by the COG PDTAC and the COG Board of Directors.

Recognizing that market conditions and policies may change, the subcommittee reviews the forecasts annually and allows local governments to make minor adjustments. The forecasts may also be adjusted to reflect local governments’ assessment of the likely housing and employment impact due to major new transportation facilities. Updated forecasts are referred to as Round 8.1, Round 8.2, etc.

Important Notes

In reviewing the Round 7.0 forecasts in 2005, the PDTAC and the Metropolitan Development Policy Committee (MDPC) determined that local plans and zoning in the metropolitan Washington region do not currently provide the housing necessary for workers to fill the forecasted jobs. Previously, forecasts adopted by the COG Board were based on local plans and zoning capacities as provided for in adopted land use plans. In approving Round 7.0, the COG Board concluded that certain localities would need to re-plan and re-zone land to provide sufficient housing to meet employment projections. This assumption is still implicit in the Round 9.2 Forecasts.

For the Round 8.0 Cooperative Forecasts, COG partnered with the George Mason University Center for Regional Analysis (CRA) for the development of new regional benchmark totals. With the guidance of COG staff and the CRA, the regional benchmark totals were developed using the econometric modeling forecasts from Global Insight, Inc. for the metropolitan Washington region. The PDTAC was briefed on the development of the benchmark totals methodology and gave their final approval of the benchmark totals at the June 2009 committee meeting.

Results of the Round 8.2 Cooperative Forecasts started to show a divergence from the Round 8.0 regional benchmark totals and starting in 2013, the Cooperative Forecasting and Data Subcommittee began the work to re-examine the economic outlook of the region. A data product from Global Insight, Inc. was examined in anticipation of developing a new regional benchmark total.

For Round 9.2, 2015 was the base year for the employment, population, and households forecast series, again indexed to Global Insight projections for the region. Jurisdictional submissions were provided to COG

staff during the September/October 2020 timeframe with TAZ level submissions in December 2020 and January 2021. The initial Census results, the Decennial Census P.L. 94-171 Redistricting Data, were delayed and were not released until August 2021 and therefore are not included in Round 9.2 Cooperative Forecasts.

ECONOMETRIC MODEL

Employment

The Round 9.0 econometric model projections reveal significant increases in employment, households, and population through 2045, the end of the forecast period.

Employment in the region will reach 4.2 million jobs by 2045. The region will add 1.0 million jobs or a 32 percent increase to an existing 2015 base of 3.1 million jobs.

Figure 2: Historic and Forecast Employment, 1990 to 2045

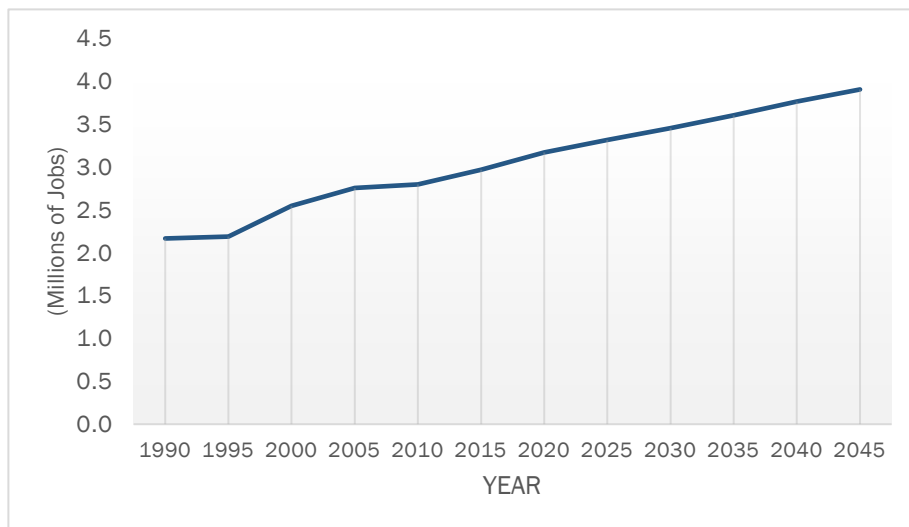


Figure 3: Forecast Job Growth by 5-Year Increment

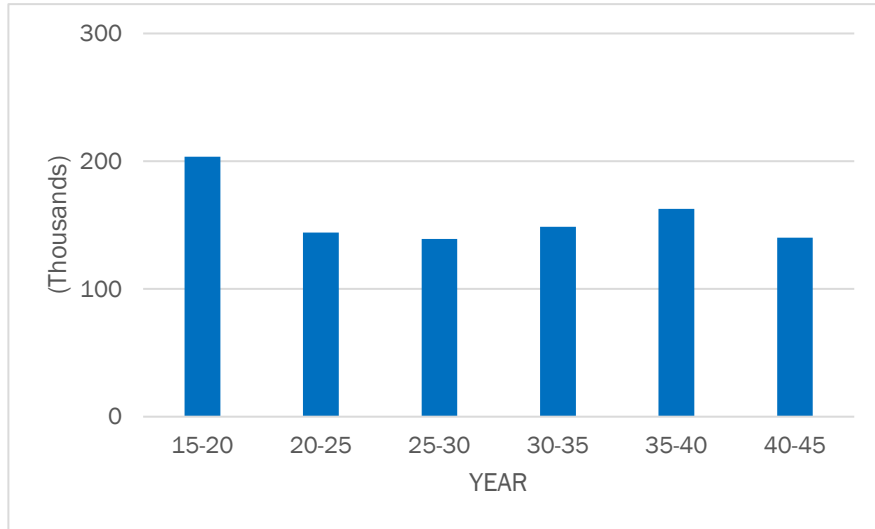
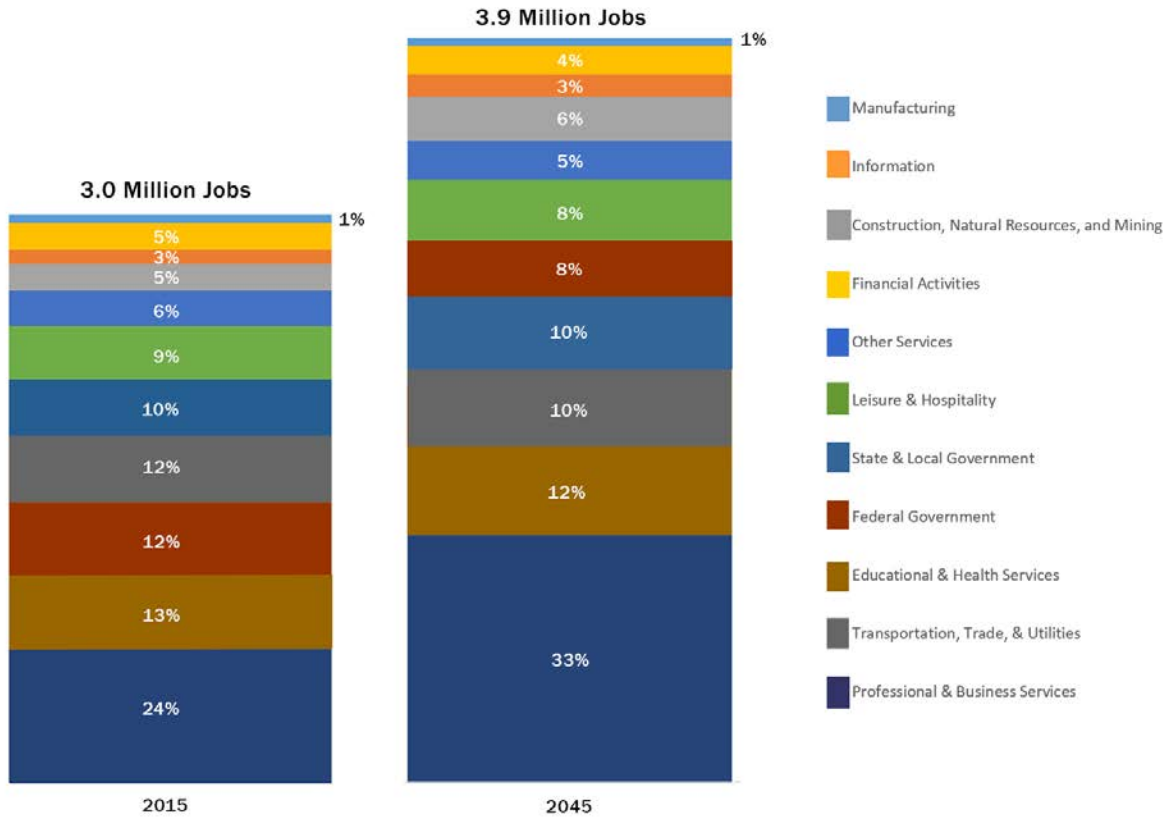

Population and Households

Population in the region will reach nearly 6.9 million people by 2045. The region will add 1.4 million people to an existing 2015 total of 5.5 million people, or a 26 percent increase.

The region will have 2.8 million households by 2045; an additional 766,000 households to an existing 2015 total of 2.0 million households, or a 38 percent increase.

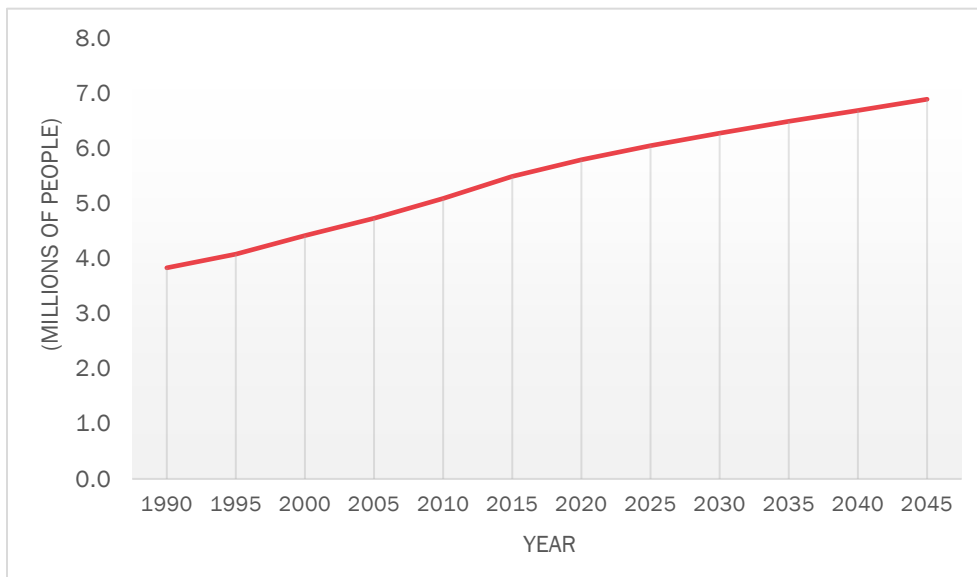


Figure 5: Historic and Forecast Population, 1990 to 2045

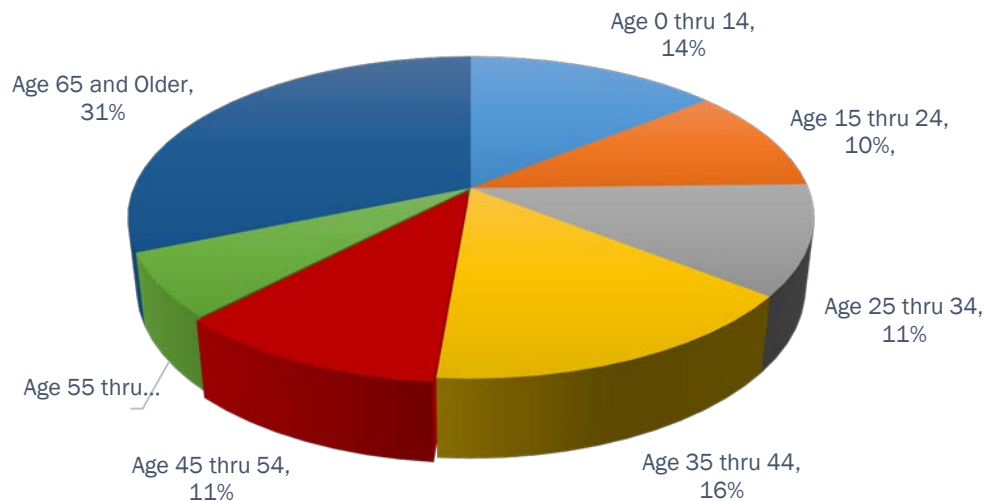


Figure 6: Share of 2015 to 2045 Population Growth by Age Group

JURISDICTIONAL FORECASTS

Employment

Job growth in Northern Virginia (42 percent) will outpace the growth anticipated in Maryland jurisdictions (21 percent), and the District of Columbia (18 percent). The District of Columbia, Fairfax County, and Montgomery County will add the largest number of new jobs to the region’s employment base during the 2020 to 2045 forecast period, followed by Prince William and Loudoun counties.

Collectively, the region’s inner suburbs will add the largest number of new jobs, 384,500 by 2045. As with population and household growth, the largest percentage increases in employment will occur in the outer suburbs of Virginia and Maryland. Together, these outer jurisdictions will add 210,400 jobs to the region’s base, increasing their total number of jobs 19 percent by 2045. Despite the tremendous growth in suburban employment shown in the forecasts, the District of Columbia will continue to have largest number of jobs of any single jurisdiction and would account for about a fifth of the region’s employment in 2045. Collectively, the central jurisdictions will account for 26 percent of regional employment.

Figure 7: Employment Growth by Jurisdiction, 2020 to 2045 (Thousands)

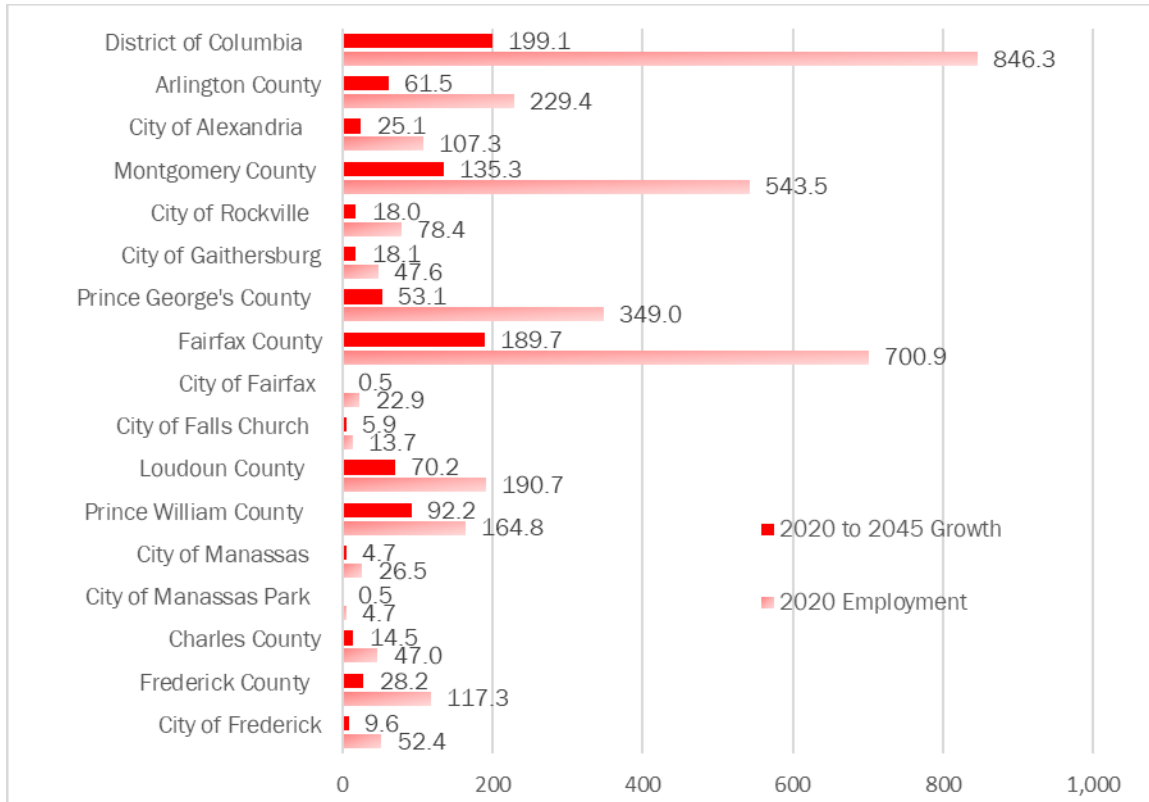


Figure 8: Percent Change in Employment by Jurisdiction, 2020 to 2045

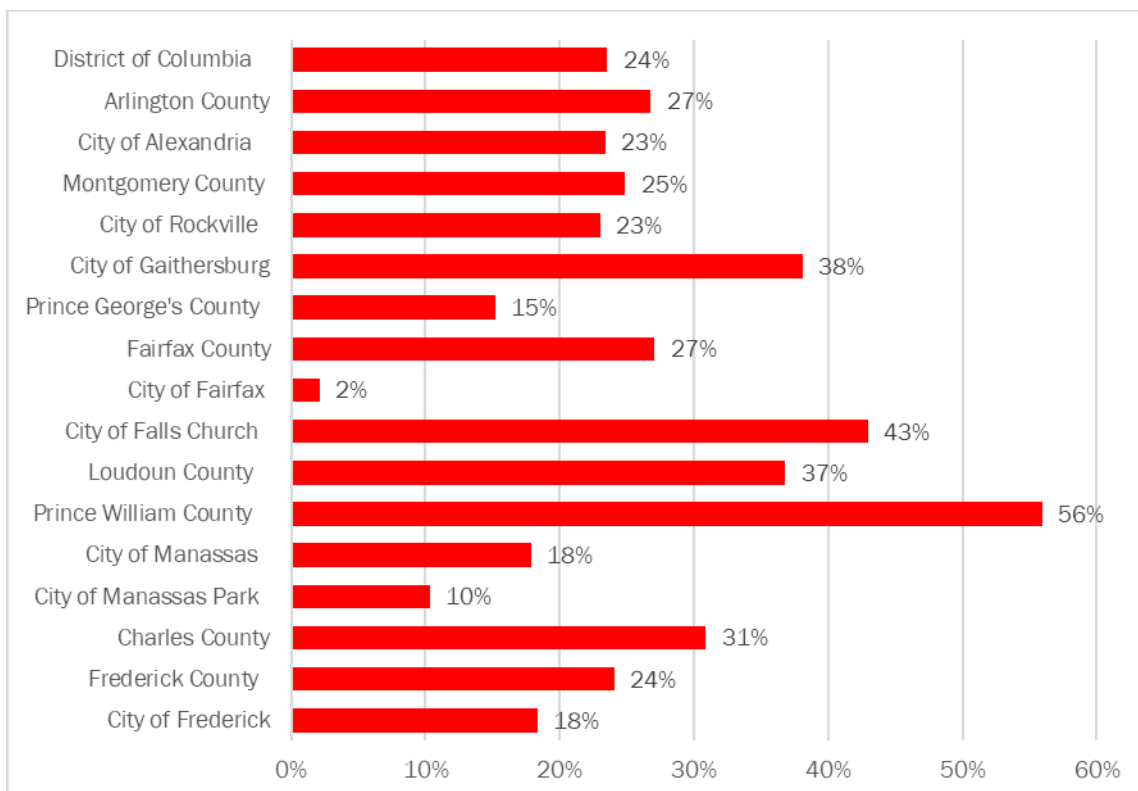
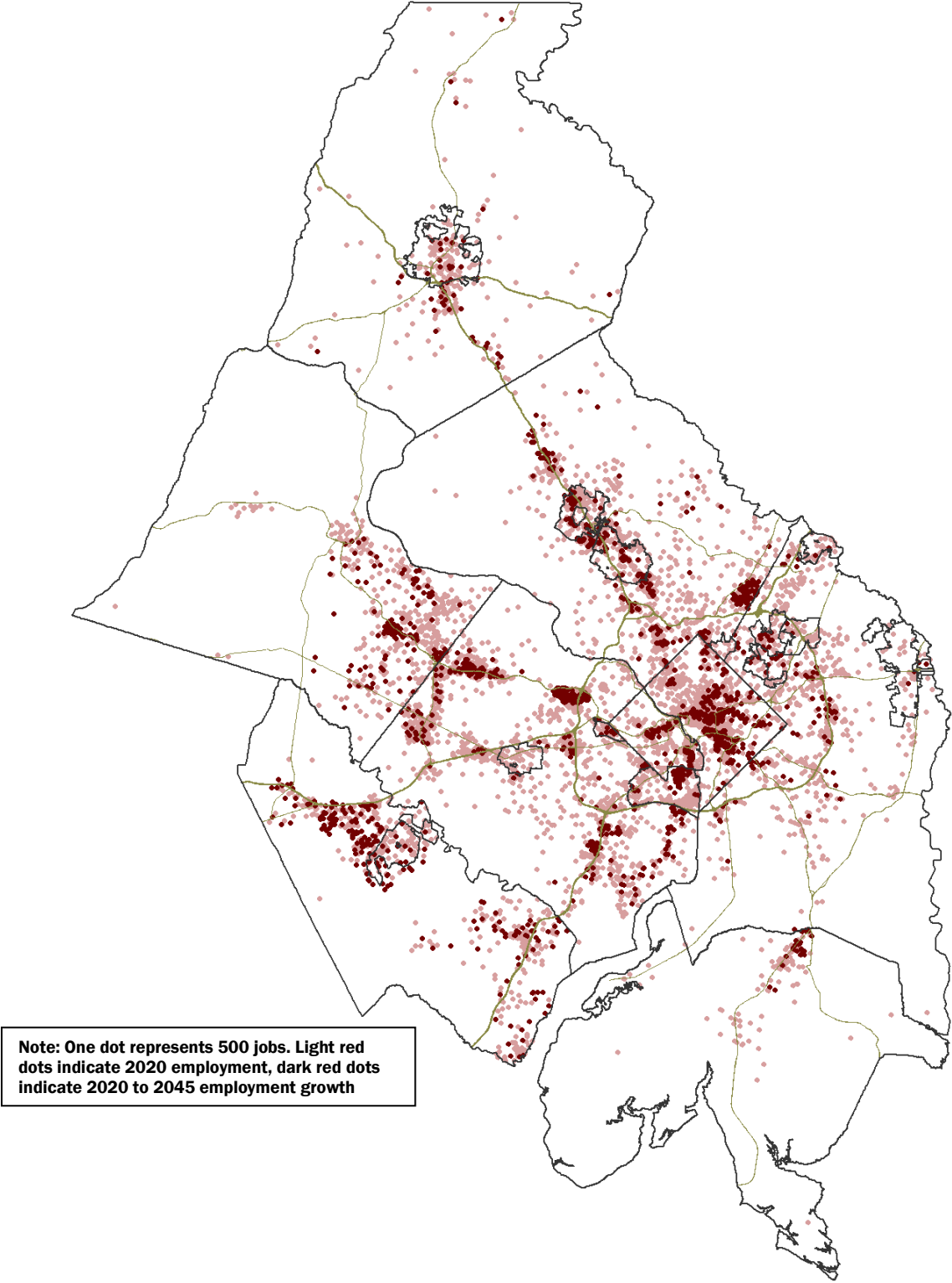


Figure 9: 2020 Employment and Projected Employment to 2045



Households

The addition of more than 535,600 households during the 2020 to 2045 forecast period reflects the growth in jobs and in-migration to the region. The largest number of new households will be in Fairfax County, the District of Columbia, and Montgomery County, which collectively contribute more than half of the household growth during the forecast period. Charles County will grow at a rate of 53 percent, the most rapidly of all jurisdictions, adding about 31,900 households to the 2020 total of 60,300.

Regional economic growth will continue to attract new residents and fuel a general demand for new housing. Households, or occupied housing units, in turn form the basis for population forecasts for most jurisdictions participating in the Cooperative Forecasting process. Planners monitor housing construction and estimate population growth by multiplying the number of occupied housing units by the average number of people in the jurisdiction's households.

Figure 10: Household Growth by Jurisdiction, 2020 to 2045 (Thousands)

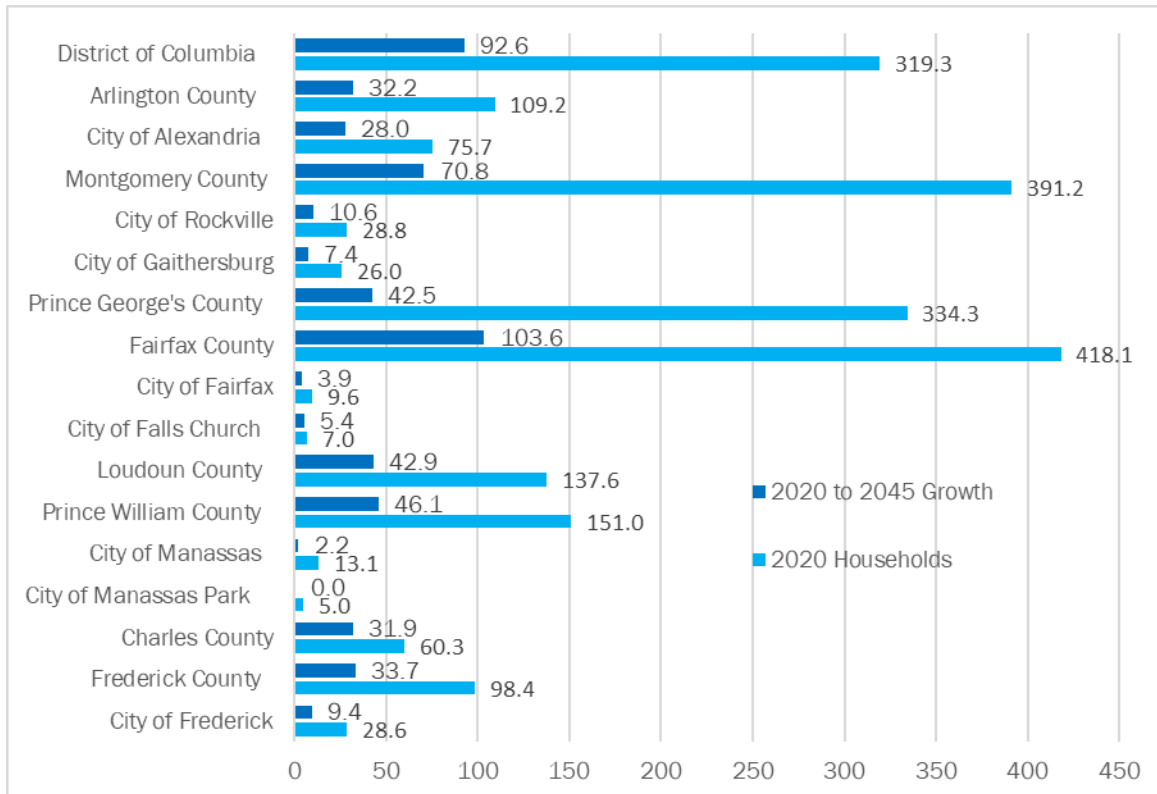


Figure 11: Percent Change in Households by Jurisdiction, 2020 to 2045

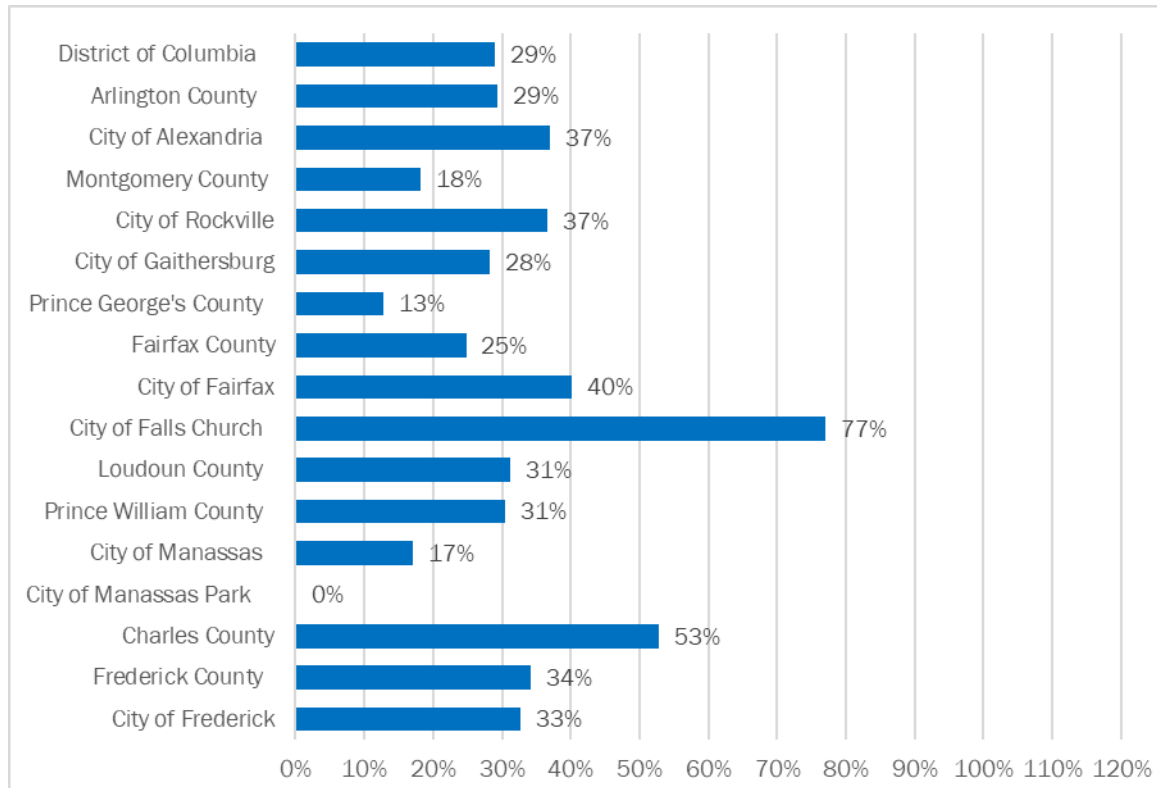
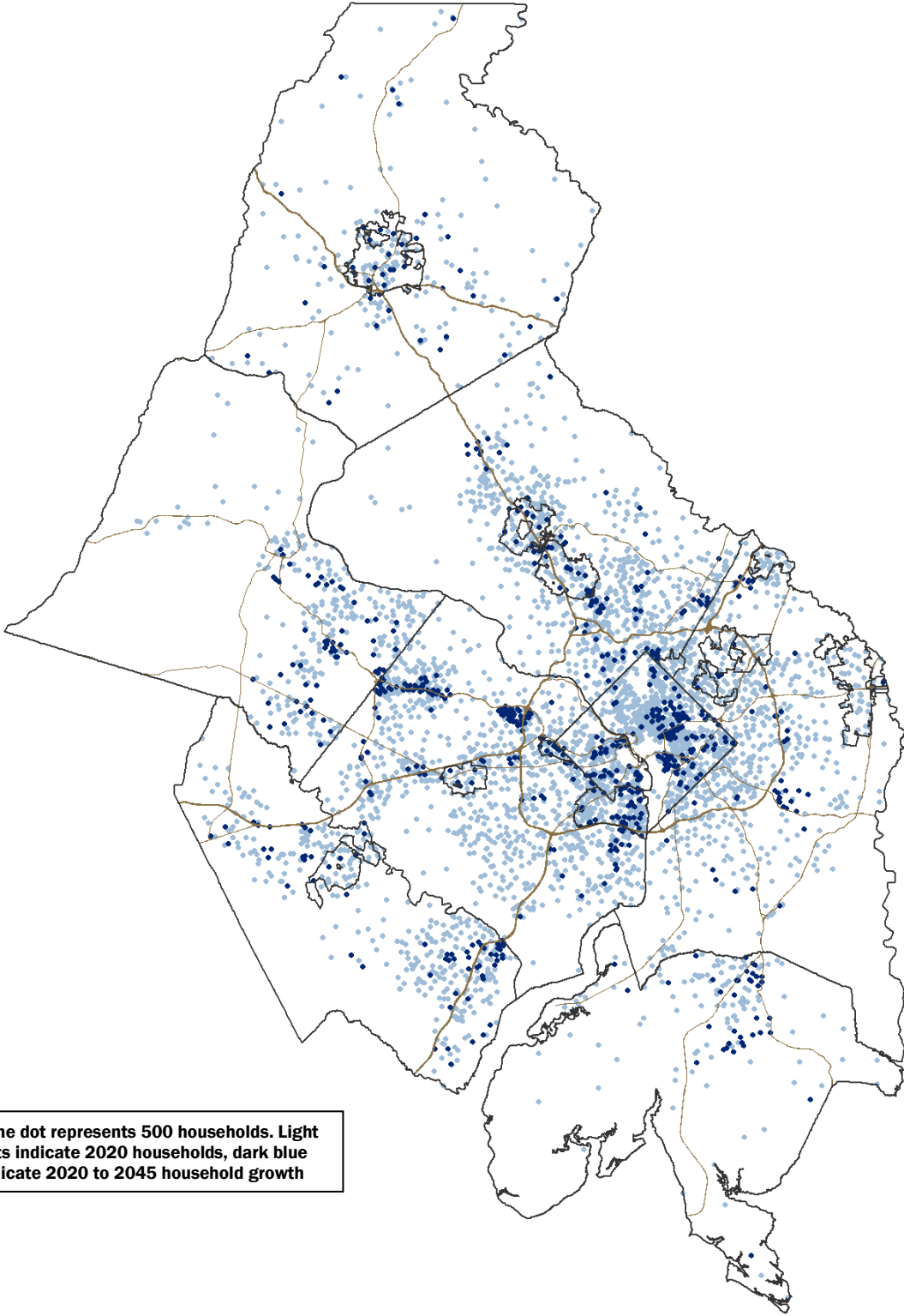


Figure 12: 2020 Households and Projected Households to 2045



Population

The region’s population is expected to grow steadily through the forecast period, adding an average of approximately 51,400 persons a year. Population will be spurred by the long-term strength of the region’s economy, high rate of in-migration and international immigration, and possible decline in average household size.

Most of the population growth will be in the District of Columbia, Fairfax, and Montgomery counties. The outer jurisdictions will experience the fastest rates of growth, led by Charles County (42 percent), Frederick County (31 percent), and Loudoun County (30 percent). The region’s central jurisdictions will also grow. In the District of Columbia, population will increase by 35 percent during the forecast period. In the City of Alexandria and Arlington County, population will increase by 37 and 30 percent, respectively.

Figure 13: Population Growth by Jurisdiction, 2020 to 2045 (Thousands)

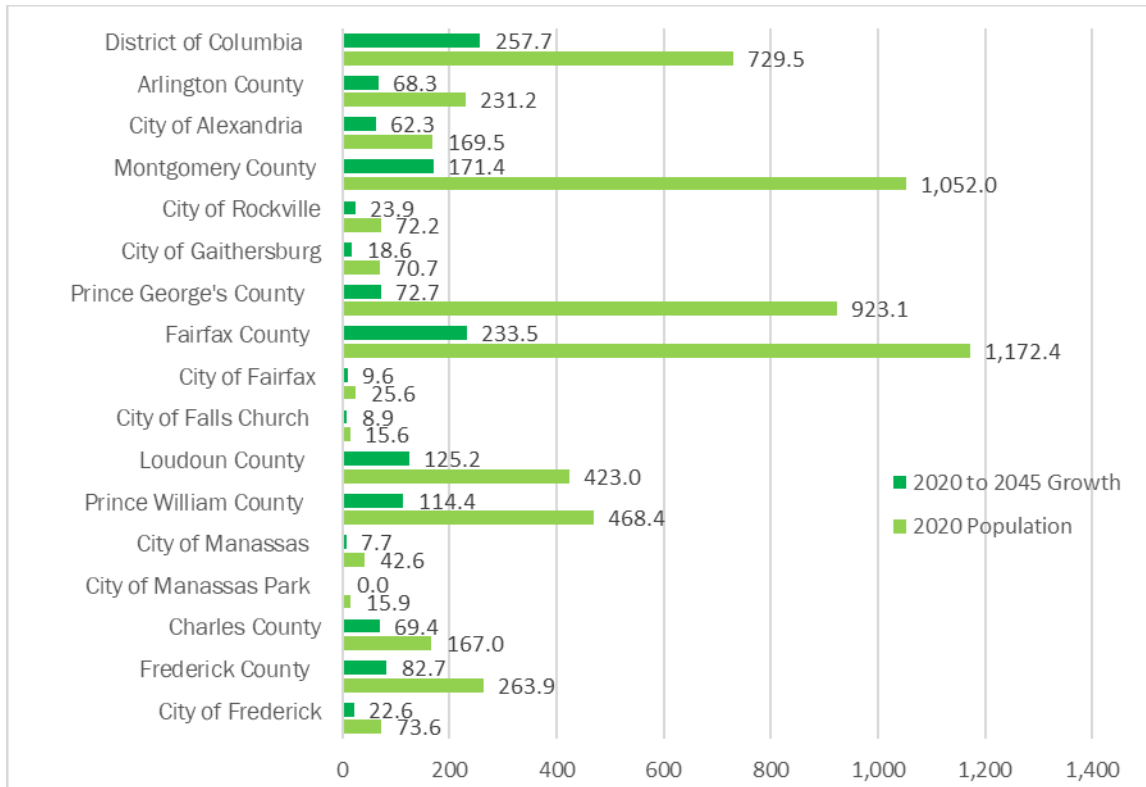


Figure 14: Percent Change in Population Growth by Jurisdiction, 2020 to 2045

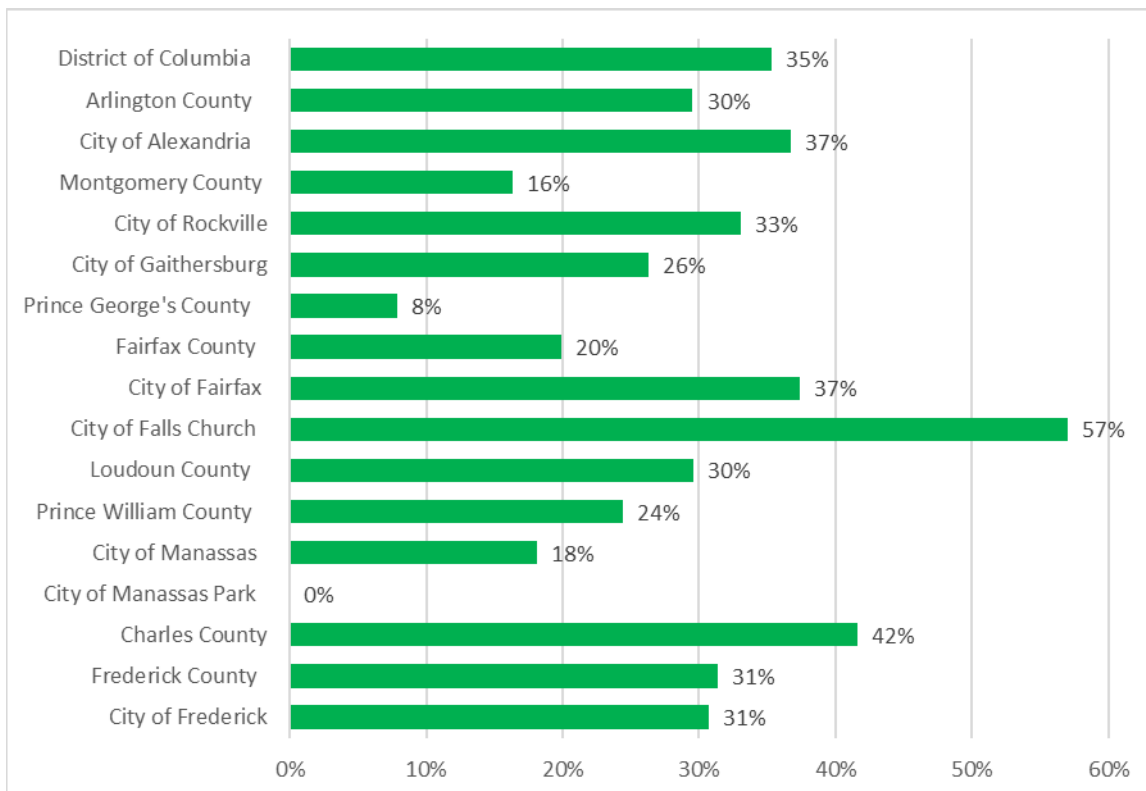
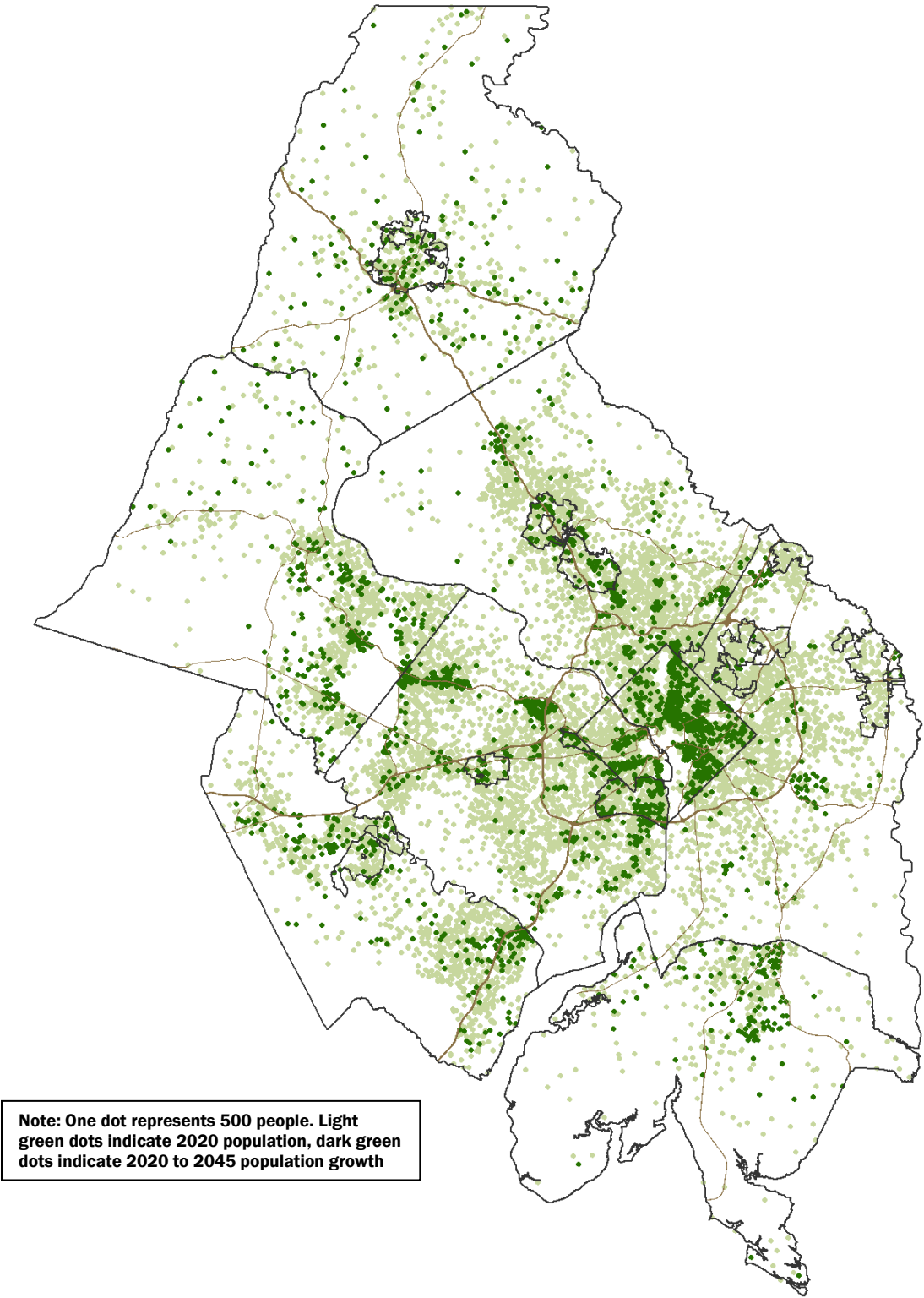


Figure 15: 2020 Population and Projected Population to 2045



REGIONAL ACTIVITY CENTERS

In 2012, COG worked with local planning officials to carry out an extensive redesign of the regional Activity Centers map. The new map was approved by the COG Board of Directors in 2013 and reflects 141 Activity Centers that include urbanized places to traditional downtowns.

The Region Forward Coalition established a target for the region to capture 75 percent of the square footage of new commercial construction and 50 percent of new households in Regional Activity Centers. Based on the new Round 9.2 Cooperative Forecasts, in 2020, 66 percent of the region's jobs were located in Regional Activity Centers. During the 2020 and 2045 forecast period, 74 percent of job growth will be concentrated in Activity Centers. The highest percentage of jobs located in Regional Activity Centers in 2045 will be found in the Central Jurisdictions: District of Columbia (88 percent), City of Alexandria (74 percent), and Arlington County (85 percent).

Households in Regional Activity Centers accounted for 33 percent of the region's total households in 2020. From 2020 to 2045, 62 percent of the household growth is projected to occur in Regional Activity Centers. In 2045, jurisdictions having the highest share of households located in Regional Activity Centers will be in the Central Jurisdictions: City of Alexandria (62 percent), District of Columbia (69 percent), and Arlington County (67 percent).

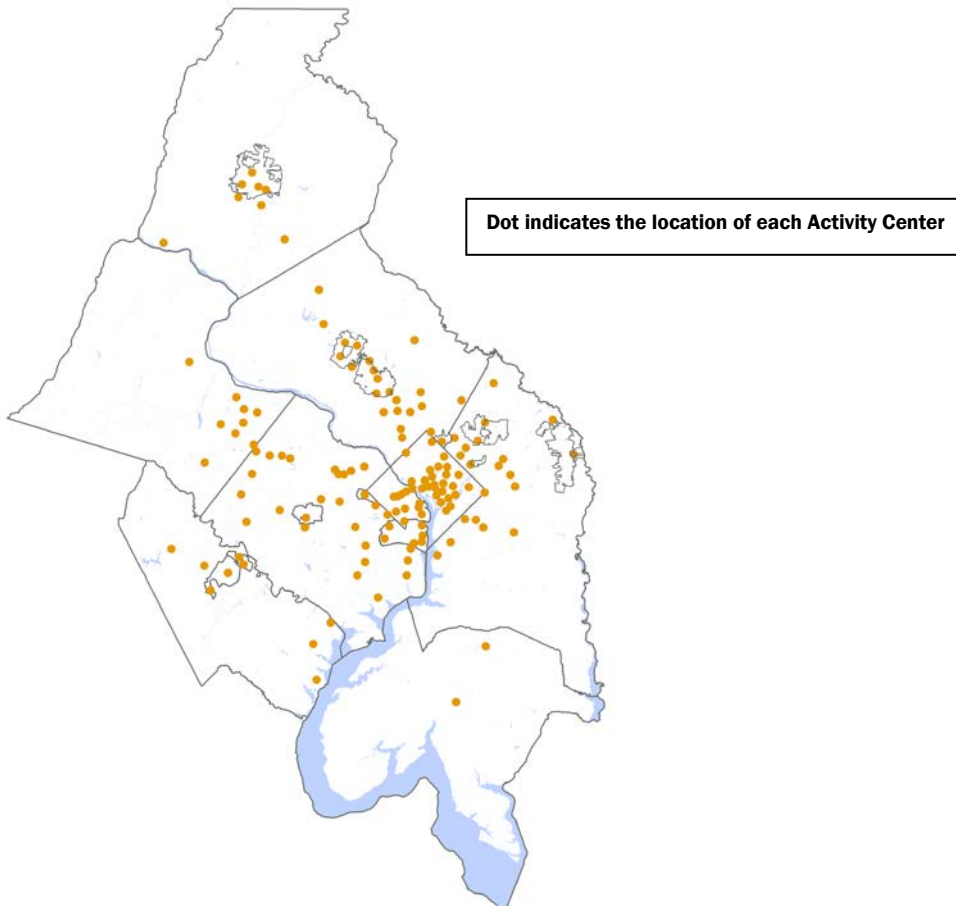


Figure 16: Round 9.2 Share of Employment in Activity Centers by Jurisdiction in 2020

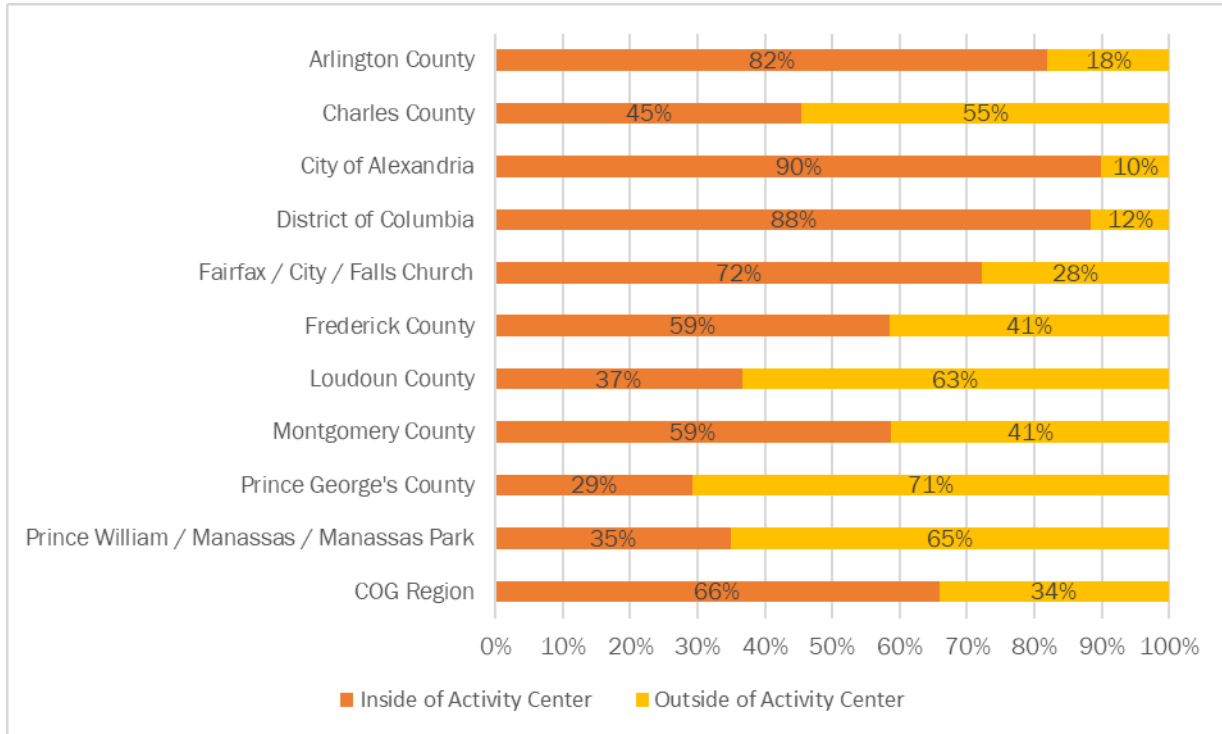


Figure 17: Round 9.2 Share of Employment in Activity Centers by Jurisdiction in 2045

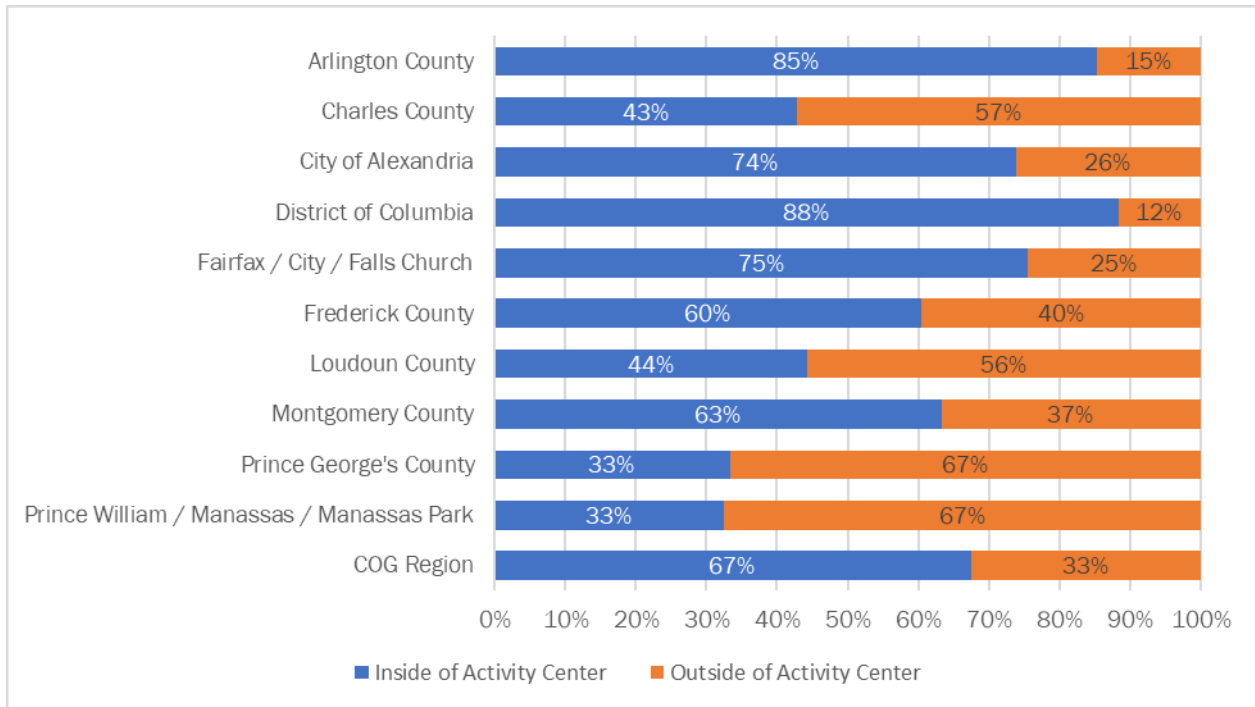


Figure 18: Round 9.2 Employment Growth Between 2020 and 2045 Occurring in Regional Activity Centers

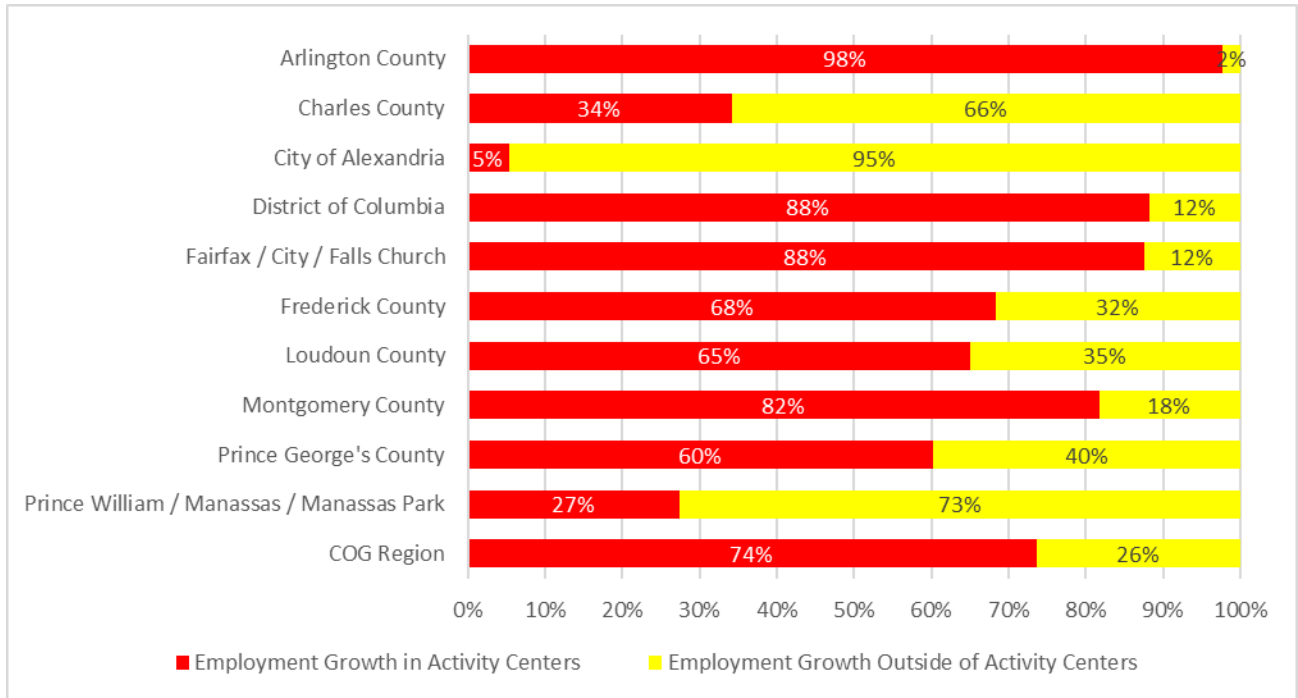


Figure 19: Round 9.2 Share of Households in Activity Centers by Jurisdiction in 2020

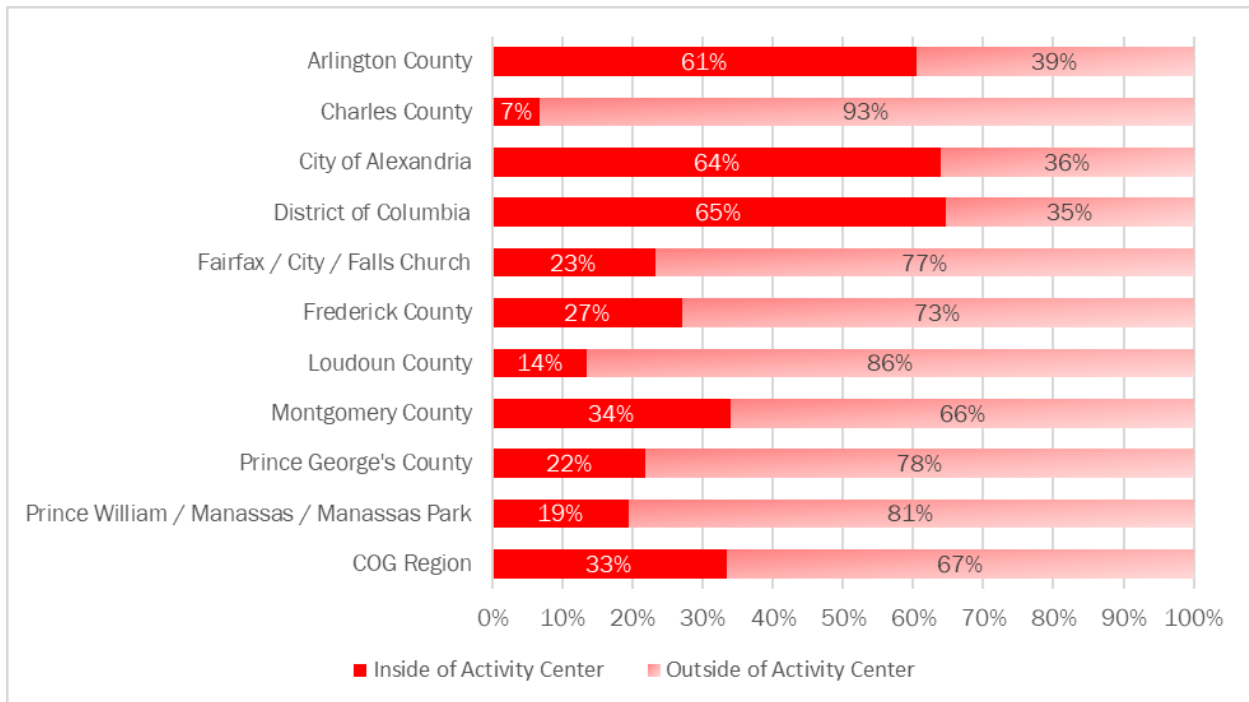


Figure 20: Round 9.2 Share of Households in Activity Centers by Jurisdiction in 2045

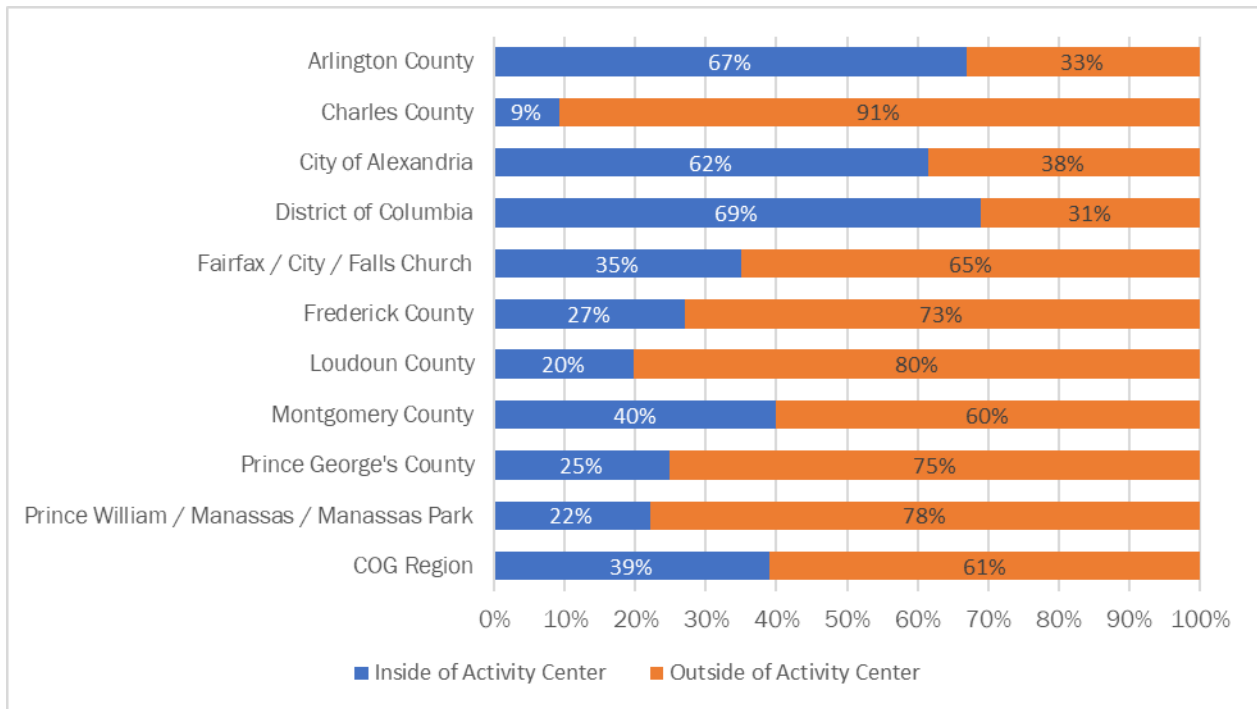


Figure 21: Round 9.2 Share of Household Growth Between 2020 and 2045 Occurring in Regional Activity Centers
