# **Project Overview:**

 AECOM was hired to support the development of an Environmental Justice Action Plan focusing on air quality. Introduction of AECOM team members and partners, including Equitable Cities.

# **Key Points:**

- Objectives: Develop an action plan to consider equity in implementing air quality policies, projects, and programs.
- **Execution Approach**: Stakeholder engagement, regular touchpoints, and plan development phases.

• **Timeline**: 10-month project starting from the previous month, aiming for stakeholder engagement in the next 3-4 months.

Members of the subcommittee discussed the meeting schedule for the year as well as priorities, goals, and outcomes of the subcommittee meetings, stakeholder engagement, and action plan development.

## **Discussion Highlights:**

- Importance of focusing on air quality within the context of MWAQC's mission.
- Engagement strategy to include both impacted community members and environmental justice experts.
- Emphasis on inclusivity and broad engagement methods to ensure diverse input.

#### **Public Engagement:**

- Suggestion to have public comment periods at beginning and end of each subcommittee meeting.
- Acknowledgment of the need for public outreach and engagement, considering the limitations of budget and time.

### Mapping and Data:

- Importance of geographic and demographic nuance in understanding air quality impacts.
- Request for existing resources and data to aid in stakeholder identification and engagement planning.
