INTRODUCTION

- The 2023 Washington-Baltimore Regional Air Passenger Survey was conducted during the entire month of October 2023 at Dulles International Airport (IAD), Reagan National Airport (DCA), and Baltimore/Washington International Thurgood Marshall Airport (BWI).
- Due to methodological changes from previous surveys, a pretest was conducted at Dulles International Airport (IAD) in April 2023.
- There were a total of 486 flights surveyed and 9,755 completed surveys for all three airports.

SURVEY QUESTIONNAIRE

- Survey questionnaires were reviewed from previous air passenger surveys to determine which questions to keep, drop, or add.
- To ensure consistency and to allow for future longitudinal comparisons, the questions asked remained mostly the same except for a question about ground transportation expenses which was dropped in the 2023 survey.
- The 2023 survey included a participation incentive, so there were additional questions requesting participants to provide contact information to enter the raffle drawing for a gift card.




RESIDENT STATUS








AGE DISTRIBUTION

TRIP PURPOSE

For all 3 airports, leisure (vacation or holiday), business (not government), and personal/family affairs are the primary reasons for traveling.

BWI:

- Leisure (38%)
- Personal/family affairs (33%)
- Business (Not government) (18%)

DCA:

- Leisure (29%)
- Business (Not government) (25%)
- Personal/family affairs (24%)

IAD:

- Leisure (38%)
- Personal/family affairs (28%)
- Business (Not government) (21%)

Resident status for the 3 main trip purposes (all 3 airports):

Leisure (37% of passengers):

- 53% Resident
- 47% Non-residents

Personal/Family affairs (27% of passengers):


- 54% Resident









MODE ACCESS/TRIP ORIGIN




PASSENGER MODE ACCESS - ALL AIRPORTS

MODE ACCESS/WORK AND NON-WORK RELATED










REASON FOR CHOOSING AN AIRPORT






REASON FOR CHOOSING MODE OF TRANSPORT






AIRPORT SPENDING - ALL AIRPORTS








PRE/POST PANDEMIC TRAVEL BEHAVIOR - ALL AIRPORTS
