A. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT TO ENHANCE AND EXPAND SITUATIONAL AWARENESS DASHBOARD FROM DC TO NCR PARTNERS

C. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT TO COMPLETE DISTRICT RECOVERY AND MITIGATION PROGRAM DEVELOPMENT PROJECT

The Board will be asked to adopt Resolution R3-2014, authorizing the Executive Director, or his designee to receive and expend up to \$150,000 to develop a Recovery Program to include a base plan and supporting annexes for the District of Columbia (DC) Homeland Security and Emergency Management Agency (HSEMA) and coordinate with NCR partners to identify and direct the means to achieve mission-specific goals. Funding for this effort will be provided through a Subgrant from the State Administrative Agent (SAA). **No COG matching funds are required.**

D. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT TO DEVELOP THE DISTRICT PREPAREDNESS FRAMEWORK

The Board will be asked to adopt Resolution R6-2014, authorizing the Executive Director, or his designee to receive and expend up to \$250,000 to validate and update the Joint All-Hazards Operations Center Standard Operating Procedures for the District of Columbia (DC) Homeland Security and Emergency Management Agency (HSEMA). Funding for this effort will be provided through a Subgrant from the State Administrative Agent (SAA). **No COG matching funds are required.**

RECOMMENDED ACTION: Adopt Resolution R6-2014.

G. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT FOR THE CONDUCT OF AN EMERGENCY EVACUATION TRANSPORTATION SEMINAR

The Board will be asked to adopt Resolution R7-14, authorizing the Executive Director, or his designee to receive and expend up to \$70,000 to obtain the services of a contractor to conduct an Emergency Evacuation Transportation Seminar for all NCR jurisdictions to determine the effectiveness of updated emergency evacuation transportation plans in the region. Funding for this effort will be provided through a Subgrant from the State Administrative Agent (SAA). **No COG matching funds are required.**

H. Resolution Authorizing the Execution of a Memorandum of Understanding with the Maryland Department of Natural Resources for Anacostia Forestry-Related Services

The Board will be requested to approve Resolution R8-2014, authorizing the Executive Director to execute an eighteen (18) month memorandum of agreement with the Prince George's County Department of Environmental Resources in an amount not to exceed \$880,000 for Anacostia forestry-related services. **No local match is required.**

I. RESOLUTION AUTHORIZING COG TO ISSUE A CONTRACT FOR THE CONDUCT A 2014 METROBUS PASSENGER SURVEY

The Board will be asked to adopt Resolution R11-2014, authorizing the Executive Director, or his designee, to receive up to \$820,000 from Washington Metropolitan Area Transit Authority (WMATA) and \$180,000 from the TPB Unified Planning Work Program (UPWP) for the conduct of a 2014 Metrobus Passenger Survey and to execute a contract, not to exceed \$1,000,000, for consultant assistance in the conduct this survey. The demographic and travel pattern ridership data collected in this survey will be used by the TPB in its regional transportation planning efforts and by the Washington Metropolitan Area Transit Authority (WMATA) in its regional bus subsidy allocation formula and in meeting its Federal Transit Administration (FTA) Title VI requirements. **No additional COG funds will be required.**

Recommended Action: Adopt Resolution R11-2014

The Executive Director presented a proposed FY 2015 (July 1, 2014 to June 30, 2015) Work Program and Budget to the COG Budget and Finance Committee, which met in October and early January. The Committee recommended COG Board approval of the FY 2015 Work Program and Budget. The proposed FY 2015 budget was reviewed by the Chief Administrative Officers and sent to senior officials from each COG member government in November for additional review and comment. Mr. Bean will summarize the proposed FY 2015 Work Program and Budget.

COMMITTEE WORK HEART OF COG OUTREACH MEDIA UPCOMING EVENTS

TRANSPORTATION PLANNING BOARD

At the December TPB meeting, area officials discussed the final report and recommendations of a special task force that investigated promising locations in the region to <u>operate buses on the shoulders of highways</u>. Members also discussed <u>a new TPB analysis</u> measuring how well the projects and programs in the region's long-range transportation plan will meet the increased demands of future population and job growth.

METROPOLITAN WASHINGTON AIR QUALITY COMMITTEE

Joe Kruger, Director for Energy & Environment at the Bipartisan Policy Center spoke about <u>the Environmental</u> <u>Protection Agency's role in climate change policy</u> at the December MWAQC meeting. EPA is proposing to limit greenhouse gas emissions from power plants.

CHESAPEAKE BAY AND WATER RESOURCES POLICY COMMITTEE

In November, CBPC members were briefed on future water supply planning, taking into account drought, climate change, and population growth as well as plans in Maryland and Virginia for trading and offsets of water pollutants.

CLIMATE ENERGY AND ENVIRONMENT POLICY COMMITTEE

A panel of developers discussed growth trends at the November CEEPC meeting. They said green buildings located in mixed-use places were the future of the area's development. Stewart Schwartz of the Coalition for Smarter Growth gave a presentation on changing planning in the region to sustain the population and preserve the environment.

HUMAN SERVICES AND PUBLIC SAFETY POLICY COMMITTEE

The Committee hosted a panel discussion in November on age-friendly initiatives that included officials from area agencies on aging and the George Washington University. Members discussed a wide range of topics, including health services, public safety and transportation.

Throughout our diverse and growing region, you can find 141 Activity Centers of different shapes and sizes—places that present a range of opportunities to area residents. And while we all agree that Activity Centers best accommodate our rapid growth, attract businesses and workers, and advance our Region Forward vision, we also know there is no one-size-fits-all strategy for these locations.

That's where *Place* + *Opportunity* comes in. This new report helps us better understand the many types of Centers and offers a variety of strategies tailored to their needs. It is meant to complement local plans and provide a big picture of the relationships among our Centers.

This collaborative project, over a year in the making, has been ably led by Sophie Mintier and Ryan Hand in our Department of Community Planning and Services. It involved close input from City and County planning directors and a team of local and national experts. Going forward, COG staff will work with jurisdictions interested in more detailed analyses of their Centers. In addition, COG is partnering with the Urban Land Institute on Technical Assistance Panels (TAPs) that will help area leaders address land use challenges and create stronger Centers. COG and ULI will work on three local projects over each of the next three years.

NEW PARTNERSHIP CONTINUES CRITICAL PROGRAM

On January 1, the Dave Thomas Foundation for Adoption began implementing the <u>Wednesday's Child program</u> to find adoptive homes for children in foster care in the National Capital Region. It will also operate the program in Atlanta, Los Angeles, New York City and Philadelphia through a two-year grant from the Freddie Mac Foundation, which is winding down its activities in 2014. NBC4 and the Council of Governments will continue to support this program, which features children in foster care who are waiting to be adopted on local news television segments.

SCHOOL CHIEFS MEETING

Chuck Bean discussed activities at the Council of Governments with the region's school superintendents at a meeting of their Washington Area School Study Council. Bean was the featured speaker at the meeting and told the school chiefs that he looks forward to coordinating with the Study Council on new initiatives.

CHIEF ADMINISTRATIVE OFFICERS RETREAT

The region's Chief Administrative Officers (CAOs) and Deputy CAOs met for a <u>first-of-its-kind retreat</u> to strengthen partnerships across area jurisdictions. Prince William County Executive and COG CAO Committee Chairwoman Melissa Peacor emceed the meeting. Leadership coach and author Dr. Bob Rosen gave a keynote speech and facilitated a workshop discussion.

JOB/HOUSING NEEDS STUDY

Chuck Bean and COG Community Planning & Services Director Paul DesJardin met with members of the 2030 Group, Greater Washington Board of Trade, Federal City Council and ULI Washington in D.C. for a forum on future occupational and housing needs for metropolitan Washington led by Dr. Stephen Fuller of George Mason University.

HOMELESS SERVICES

COG hosted a training workshop on December 4 for local government, non-profit and advocacy staff to prepare for the January 2014 Homeless Enumeration. Housing staff also briefed the City of Frederick Board of Aldermen on preparations for the enumeration and plans to develop a scan of local government 10-year plans to end homelessness.

SOLAR ROOFTOP GRANT

COG Principal Environmental Planner Jeff King attended the kickoff meeting of the region's new Solar Rooftop grant project along with 8 other regional councils at the Mid America Regional Council's offices in Kansas City.

CLIMATE RESILIENCY

COG staff worked with NASA, National Capital Planning Commission, Smithsonian, and US General Services Agency to conduct a series of workshops and webinars this fall aimed at building a climate resilient region. In addition to federal agencies located in the monumental core, several COG stakeholders participated including DC Water, WMATA, District of Columbia, Alexandria ReNew, City of Alexandria, and Arlington County. A summary report will be produced in the coming weeks.

TRANSPORTATION/CLIMATE CHANGE

COG Alternative Commute Programs Director Nick Ramfos attended the Behavior, Energy Climate Change Conference in Sacramento and helped to host a panel discussion through the Transportation Demand Management Institute on Transportation Success Stories as Key to the Future of Climate Change.

1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Chairwoman Young called the meeting to order at 12:00PM and led those present in the Pledge of Allegiance.

2. ANNOUNCEMENTS

Annual Membership and Awards Luncheon, December 11

Chairwoman Young encouraged the Board to save the date for the Annual Membership and Awards Luncheon on December 11, 2013. This year's meeting is titled "Shaping our Region's Economy for the Metropolitan Revolution" and will feature Bruce Katz.

Regional Mental Health Resource Guide

Copies of the 2014 Regional Mental Health Resource Guide were distributed to board members and was made available online.

3. EXECUTIVE DIRECTOR'S REPORT

Executive Director Chuck Bean discussed policy board and committee work conducted over the past month including a major roundtable discussion on the Regional Transportation Priorities Plan. Mr. Bean highlighted the November Heart of COG, Carla Sanchez, for improving access to healthcare for area residents. With great sadness, Mr. Bean honored the life of COG Senior Transportation Director Ron Kirby, who passed away on November 11th. In order to allow the board time to discuss the recent passing, Mr. Bean notef the proposed amendments to the agenda.

6. ADOPTION OF CONSENT AGENDA ITEMS

A. RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR TO RECEIVE AND EXPEND FUNDS TO PARTICIPATE IN DOE'S ROOFTOP SOLAR CHALLENGE II

The Board amended Resolution R43-2013 authorizing the Executive Director, or his designee, to receive and expend up to \$125,000 in grant funding from DOE to provide technical assistance to local governments to improve their policies and processes for solar photovoltaic installations. The program will be administered in collaboration with Optony Inc., the Mid America Regional Council (MARC), and the National Association of Regional Councils. The total costs of the services shall not exceed \$125,000. COG will provide matching funds of \$40,000 to MARC and \$8,750 to Optony, Inc. The matching funds will be provided 50 percent from the approved FY 14 climate and energy program budget and 50 percent from the FY 15 climate and energy program budget.

B. RESOLUTION AUTHORIZING COG TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE MARYLAND DEPARTMENT OF NATURAL RESOURCES FOR ANACOSTIA FORESTRY-RELATED SERVICES

The Board adopted Resolution R45-2013, authorizing the COG Executive Director, or his designee to execute a nine month memorandum of understanding with the Maryland Department of Natural Resources (MDDNR) for Anacostia forestry-related services. The contractual services identified in the MOU will not exceed the amount of \$25,000, with funding provided by MDDNR. No COG matching funds are required.

C. RESOLUTION AUTHORIZING COG TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE MARYLAND DEPARTMENT OF NATURAL RESOURCES FOR ANACOSTIA RIVER WATERSHED RESTORATION PARTNERSHIP-RELATED SERVICES

The Board adopted Resolution R46-2013, authorizing the COG Executive Director, or his designee to execute an eleven month memorandum of understanding with the Maryland Department of Natural Resources (MDDNR) for Anacostia Partnership-related technical and administrative support services. The contractual services identified in the MOU will not exceed the amount of \$41,500, with funding provided by MDDNR. No COG matching funds are required.

7. FY 2013 AUDIT REPORT AND FY 2014 FIRST QUARTER REPORT

Mayor Bruce Williams, Chairman of the FY2013 Audit Committee briefed the Board on the status of this year's Audit Committee and their work. Pamela Gray with SB & Company provided an unqualified or "clean" audit to the Audit Committee and the Board of Directors. Paul Beriault, COG Chief Financial Officer provided a summary of the FY 2014 first quarter financial activity and the Form 990 tax return.

9. WINTER WEATHER BRIEFING \ HOMELESS SERVICES IN REGION

Chris Strong, Warning Coordination Meteorologist for the National Weather Service, shared critical points from the November 4th Annual Winter Weather Briefing as they related to the potential shelter needs for the region's residents without adequate or secure shelter. Julie Maltzman with the Fairfax County Office to Prevent and End Homelessness provided an overview of the types and amount of shelter beds currently available to serve the region's residents during hypothermia season. COG Board members were invited to participate in upcoming trainings for the annual Point in Time (PIT) homeless enumeration. COG staff proposed to conduct a regional scan of member jurisdictions' 10-Year Plans to End Homelessness.

ACTION: The Board adopted Resolution R48-2013 to direct COG staff to conduct a regional research effort highlighting joint efforts to end homelessness.

SUMMARY OF BOARD RULES RELATING TO SETTING THE BOARD MEETING AGENDA AND VOTING

At the last Board of Directors meeting there was discussion about how matters come to the Board and how votes are taken. Below are summaries of the Rules of Procedure in this regard. The referenced Rules are in parentheses.

1. The Rules of Procedure provide for setting the Board Agenda as follows:

The Executive Director prepares a list of proposed agenda items for consideration by the Chair and Vice Chairs 10 days before the meeting. The Chair approves the agenda. (3.01) Generally, Board members ask the Chair or the Executive Director to place a matter on the agenda.

Agenda materials are to be provided to members no later than 7 days before a regular Board meeting, and all additional materials are to be distributed to the Board prior to the meeting. The Board may defer any item for which all relevant information has not been prepared in this manner. (3.03)

- 2. The Rules of Procedure set forth 4 methods of voting:
 - **Voice vote,** a member's vote shall be recorded upon request (2.09);
 - Show of hands vote at request of Chair or member (2.10);
 - **Roll call vote**, at demand of member in advance of or promptly after a show of hands or voice vote (2.11);
 - Weighted Vote, at request of majority of members present representing any 2 participating governments, any question shall be determined by the majority of the aggregate votes of each participating government as set forth in the Bylaws (2.13).

Voting records are official Board records (2.12). When a roll call or weighted vote (or a request for recordation of a member's vote) occurs, the Board Secretary/Clerk notes the vote on the final resolution and in the meeting minutes.

Over the last few years, the Council of Governments has become increasingly engaged in, and placed a greater focus on, strengthening its relationship with state and federal officials and the advocacy of regional priorities. The Board has annually adopted policy priorities to focus COG's advocacy efforts in this regard. These positions are grounded in COG's strategic plan and are consistent with the annually adopted Work Program and Budget. We now have the opportunity to more clearly define the parameters that will provide practical guidance to the Board when considering policy action.

Adopted policy positions are based on regional cooperation and present a unified voice on regional issues. One of COG's greatest strengths is the willingness and desire of our very diverse communities to work together, through COG, on issues reflecting our core competencies in transportation, homeland security, economic development and the environment. For the most part, positions are generated from policy committees and support the advancement of our mission: the creation of a more prosperous, accessible, livable and sustainable region. We tend to focus on issues that are specific to our region, or to assert the particular needs we have as a region in a state or federal matter.

Part of COG's success over the years has been due to the constructive review and thoughtful input which its committees have brought to legislative and other issues prior to Board consideration as to whether to take a position. This process will benefit from a more strategic approach as to why, how and when a position is taken.

Guidelines for policy development

To be considered, a policy position should:

- 1. Adhere to COG's mission of advancing the principles and goals within Region Forward.
- 2. Fit within COG's core programmatic areas: transportation, human services, public safety, economic development and the environment.
- 3. Demonstrate COG's ability to influence and effectuate a policy decision.
- 4. Be regional in nature.
- 5. Be germane to the National Capital Region.
- 6. Be in the best interest of COG and its members.

BACKGROUND

Recent analysis by the Transportation Planning Board (TPB) underscores one of the most pressing long-term challenges for transportation in metropolitan Washington: the urgent need for additional revenues, both to ensure the region's existing roadway and transit systems are adequately maintained, and to fund increases in capacity to support future population and employment growth.

Metro dedicated funding, which provides \$1.5 billion over ten years from the federal government for Metro's rehabilitation and maintenance, is set to expire in 2020, and there is currently no legislation to extend the measure nor is there a commitment by the states to continue providing 50 percent matching funds. Federal and State policy makers need to devote attention to exploring new ways to dedicate increased metro funding to extend past the current allocated funding expiring in 2020, only 6 years away.

Metropolitan Washington is projected to add more than 1.2 million new residents and 1.1 million new jobs by 2040. The region's already crowded Metrorail cars, buses, and roadways cannot meet the challenge presented by this growth without new resources.

TRANSPORTATION INFRASTRUCTURE INVESTMENT

The current structure and levels of federal transportation funding are inadequate for addressing pressing needs for system maintenance, new infrastructure, and the increasingly urgent problem of congestion on both roadway and transit systems in the Washington region. Federal and State policy makers need to devote attention to exploring new ways to dedicate increased Metro funding to extend past the current allocated funding expiring in 2020, only 6 years away.



REGULATORY & LEGISLATIVE AGENDA

• A substantial increase in federal transportation funding is necessary to address the under-investment in the region's transportation system.

• Federal and State policy makers need to devote attention to re-dedicating and increasing Metro funding to extend past the current allocated funding expiring in 2020, and explore ways to continue metro funding in 6 years.

• Federal transportation policy should provide for increased federal funding over the long-term, with a greater focus on metropolitan congestion and other metropolitan transportation challenges. MAP 21, enacted in July 2012 and a significant milestone in surface transportation legislation, expires in September 2014. While MAP-21 maintains current funding levels, it includes no new revenue sources dedicated to transportation, and provides very limited sub-allocation of funding to metropolitan areas.

• State legislatures need to continue building on the progress made last year and make local transportation funding a priority in 2014.

Buildings account for about 40% of U.S. energy use. Energy efficient technologies available today could save homes and businesses 30-50% on monthly energy bills, yet only about one-fifth of potential cost-effective energy improvements are made each year.

Accessible finance is critical to enable residents, business owners and communities to make cost-saving energy efficiency improvements. COG encourages state and local governments to explore new finance programs and public-private partnerships that lower up-front costs, make more capital available and provide affordable terms for residents and businesses. Potential solutions include: on-bill financing, property assessed clean energy (PACE) financing, Energy Savings Performance Contracts (ESPCs), a regional infrastructure bank for energy improvements and sustainable community energy planning, and savings-sharing mechanisms to better align customer and utility incentives.

MODERNIZING OUR ENERGY SYSTEM

Demand for clean energy, the growth of distributed generation, and new environmental and security concerns are leading utilities and regulators to explore ways to make the grid more efficient, reliable and secure. Smart meters, demand response programs and time-ofuse rates can lead to significant efficiency gains simply by increasing customer information and engagement. Grid-level improvements such as voltage optimization and smart switches can greatly improve reliability and security.

Harnessing the benefits and efficiencies of clean, distributed energy resources and load management will contribute to a robust, resilient and sustainable power system, both regional and national productivity and competitiveness. Renewable, combined heat and power, district energy and microgrid technologies reduce peak load, improve reliability, lower costs and help utilities meet environmental goals.

Monitoring and storage should be used to maximize these benefits and minimize interconnection and variability challenges. If appropriate, regulators should explore alternative regulatory models like decoupling that ensure fair cost recovery for utilities.

INVESTING IN INNOVATION

Investing in clean, efficient and advanced energy technologies will not only help expand the energy technology sector but create spill-over benefits for other industries and make our economy more competitive in the world market. Energy efficient and clean energy technologies, like renewable energy, combined heat and power, smart grids, microgrids, and grid-level advances in transmission, flexible generation and storage will not only accelerate economic growth, but will be critical to solving new reliability, security and environmental challenges.

Energy efficiency promotes local jobs and businesses. National estimates indicate that per million dollars invested, building efficiency improvements will create 20 new full-time jobs, versus 10 created by the energy generation industry. By shifting consumer spending from the energy sector to more employment-intense industries, efficiency improvements have a high return-oninvestment: each dollar saved on utility bills has 2.24 times the effect on domestic employment and wages than a dollar spent on utility bills. Combined, the energy productivity gains from investment in financing, grid modernization and innovation could create 1.3 million jobs and save \$327 billion per year by 2030.

Support for basic and applied research, development, demonstration and deployment of new technology is essential to reach our economic and environmental goals. Public investment has been critical to many important innovations in the energy sector. Governments can also help support new technology by offering public facilities as demonstration sites or through collective and bulk purchasing programs.

BACKGROUND

Local jurisdictions' best management practices will also be shaped by goals within the new Bay Agreement, expected to be signed in spring of 2014, and measured by milestones reached as we approach the 2017 mid-point to the Chesapeake Bay TMDL implementation. Many jurisdictions in the region will also be receiving their "next generation" of stormwater permits in 2014 with more stringent requirements.

A major challenge is controlling the pollution that occurs during wet weather; which includes stormwater runoff, flows from combined sewer and stormwater systems in several parts of the region, and even leaks and overflows from sanitary sewers. In the case of stormwater runoff, the challenge is complicated by the need to address runoff from existing developed areas, many of which were built without the "best management practices" for improving water quality that have become commonplace – but only since the 1980s. Retrofitting stormwater pollutant controls into older developed areas is inherently complex, time consuming and highly expensive. (continued on back)

WATER QUALITY PROTECTION

Protecting water quality in metropolitan Washington to achieve the goals of the federal Clean Water and Safe Drinking Water Acts requires that EPA, state regulatory agencies, the state legislatures and United States Congress support actions to: adopt feasible implementation schedules and utilize regulatory flexibility such as integrated planning/permitting solutions in recognition of significant financial impacts on local government and utilities; and identify funding and funding mechanisms to support implementation by local governments and utilities.



REGULATORY AND LEGISLATIVE AGENDA

• Federal government: Define clear affordability criteria to ensure that local governments and utilities can finance and pay for water infrastructure requirements and advance water quality progress, without unduly burdening ratepayers and taxpayers, and without compromising other critical local programs. Affordability criteria should take into account the cumulative costs for complying with drinking water, wastewater and stormwater regulations, as well as trade-offs between environmental sector costs and other local responsibilities.

• State government: Ensure that the extent and pace of implementation proposed under the new generation of local government stormwater permits (MS4s) is feasible and costeffective. Continue to apply the "Maximum Extent Practicable" (MEP) standard so that stormwater permits reflect what can reasonably be accomplished within their 5-year permit terms.

 Federal and state government: Use the flexibility inherent in existing regulations and policies, as well as EPA's 'integrated planning/permitting' policy to allow local governments and utilities to prioritize spending on water quality projects. Allow localities to experiment with new technology, such as green infrastructure, and use trading between different sources of pollution to meet permit requirements on a cost-effective basis.

• Federal and state government: Identify funding sources to reestablish historically shared financial commitment and partnership with local governments. Ensure that tax credits and other financial assurances for borrowing are retained. Work with local governments to develop creative mechanisms for shared funding such as infrastructure banking.

BACKGROUND (continued)

Because meeting permit requirements is a local responsibility, and because state and federal governments provide little cost-share assistance in the Washington region (as compared to the past), funding has become a major challenge for local governments and utilities. To meet these obligations, they are raising water-based rates and taxes at a rate well above inflation. They are also making new investments in infrastructure at the same time as they are struggling to pay for the maintenance of existing infrastructure.

As a result, conflicts are developing between paying for water quality requirements and funding other necessary local government services. Better use of existing regulatory flexibility and application of integrated permits/planning that allows localities to address their wastewater, stormwater and drinking water needs in an integrated and prioritized manner would help localities meet permit requirements with limited resources. This includes permit implementation schedules that recognize limitations due to affordability and other criteria. Beyond this, additional cost-share funding from state and federal governments would accelerate progress toward reducing pollutant loads.

BACKGROUND (continued)

Partnerships and training through the region's network of world-class colleges and universities is essential for the advanced training to serve a growing economy. In addition, Economy Forward and the Region Forward Coalition both noted the need to strengthen education and training through the region's excellent community colleges to meet current and future demand for jobs that may only require technical certification or an Associate's Degree. Partnerships between COG and the region's many Workforce Investment Councils, as well as with the region's Economic Development Directors, will be essential to ensuring strong economic growth and workforce development.

As called for in Economy Forward – and building on the Board's approval in 2013 of the new Activity Centers map – "Place + Opportunity: Strategies for Creating Great Communities and a Stronger Region" is COG's new initiative to strengthen and enhance Activity Centers throughout metropolitan Washington. Activity Centers—the places that will accommodate much of the region's growth in the coming decades—are a key factor that attracts residents, businesses, and visitors to the area, and are critical to ensuring the region's future competitiveness and success. Incorporating in-depth research on market, physical, and socioeconomic characteristics of the region's Activity Centers, this report presents goals, strategies, and tools to assist local governments and other stakeholders working to create thriving, high-opportunity places. Together with the Transportation Planning Board's Regional Transportation Priorities Plan (RTPP), Place + Opportunity offers an array of tools, strategies and resources to better link land use, transportation and affordable housing.
