Item: 3. Attainment Modeling Results/ SIP Schedule

Description:

Recent attainment modeling results for the Washington, DC-MD-VA region show the higher ozone concentrations in 2009 than previously anticipated. The modelers are analyzing the results to explain the difference from previous modeling results. The Ozone Transport Commission (OTC) is performing further modeling to include additional new measures. The new modeling results will be available in February and will provide information to the states that need further measures to meet the 8-hour ozone standard by 2009.

Ms. Rohlfs will propose a revised SIP schedule for the next six months to accommodate the time needed for further modeling analysis.

Item 4. Letter to Ozone Transport Commission (OTC) re Modeling

Presenter: Phil Mendelson, Chair, MWAQC

Description:

The Ozone Transport Commission (OTC) is coordinating the attainment SIP modeling for the northeast and mid-Atlantic states. More than 23 states are now involved in the modeling effort. At its Fall meeting in Richmond, the OTC decided to model additional control measures for the large region and to meet in February to review the results and consider adopting the additional control measures as model rules.

The Washington region's SIP schedule has been delayed considerably because of the complicated OTC modeling process. Mr. Mendelson proposes to urge the OTC to meet an early deadline for modeling, as the modeling results will be critical to the metropolitan Washington region's state implementation plan for the 8-hour ozone standard.

Item 5. Mobile Budget Revisions—Use of Transportation Control Measures (TCMs)

Description:

Transportation Control Measures (TCMs) have been included in previous state implementation plans and the benefit from these measures needs to be reflected in the proposed mobile budgets for 2008 and 2009. In a letter to MWAQC Chair Phil Mendelson, TPB Chair Michael Knapp transmits recent information on the benefits of the TCMs in the new SIP and how these benefits affect the proposed 8-hour mobile budgets.

Jeff King will describe the California Low Emission Vehicle (CAL LEV) standards and recent actions by northeastern states to adopt these standards. Under the Clean Air Act, states can opt into the CAL LEV program which will lead to reductions in emissions for a variety of air pollutants compared to the current Tier 2 motor vehicle standards. In addition to reductions in VOC and NO_x, CAL LEV will require reductions in air toxics and carbon dioxide.
