## 4. TDM System Update

Stephen Finafrock, COG/TPB Staff, briefed the Committee on software development highlights regarding the TDM system. He stated additional enhancements can be expected throughout FY16.

Mr. Finafrock stated the GRH Applicant Survey was about to launch and asked rideshare coordinators to relay any reported issues to COG/TPB staff.

Mr. Finafrock then explained the upcoming enhancements to the commute log. The logs have been visually improved and a commute profile has been added to simplify the logging process. The commute logs have been consolidated and the system has been programmed to order the logs by incentive program and then general logs. This will should eliminate any confusion for commuters enrolled in the 'Pool Rewards program and increase their chance of completing the program successfully.

A customized employer site is available for large employers upon request. Currently, Arlington Public School Systems and the University of Maryland are the only two employers to utilize the customized site capability.

Mr. Finafrock announced that the route-based ridematching option can be expected toward the end of the fiscal year. This option will be in addition to the current radial search and should prevent commuters from matching across natural barriers such as large bodies of water.

The TDM 4.0 working group has discussed a way to simplify the application process for users. The group has suggested that all users of the TDM System be required to select a program in order to aid rideshare coordinators in supplying relevant and desired information.

George Clark, Tri County Council for Southern Maryland, suggested the application process should require an email address and the selection of a program first, and based on that selection, the system will ask for any additional information needed.

The home button, back button and the time out session were all brought up for discussion.

Lisa DuMetz, VDRPT, inquired about the ridematching options a user could choose from. Mr. Finafrock stated the commuter will have the option to choose between a route-based or radial search. Population density and geography will be factors in determining which search algorithm is the best choice for a commuter.

As part of his presentation, Mr. Finafrock also discussed updates to the look and feel of the TDM System, aka TDM 4.0 and the Commuter Connections dynamic rideshare (real-time) application. The real-time mobile application is currently in development. Travis Johnston, COG/TPB Staff, explained that COG is open to ideas such as a driver rating system and gamification as part of the mobile application. The target date for release is late fall or early winter of FY17. Mr. Finafrock also mentioned that online Park N' Ride maps has been updated. The upgrade to the map improves its appearance and its speed. Mr. Finafrock wrapped up his presentation by further explaining the current tasks for Commuter Connections. These tasks include the CMS tool review, Facebook login integration, one-click ridematching, bike routing system overhaul and GRH ride request integration with the TDM applications. Mr. Finafrock then recommended that all members of the committee review the Best Practices manual to identify items of interest and report any suggestions or ideas.

## 5. TDM System Reports Module Presentation

Tammy Bowles, Montgomery County DOT, presented a tutorial on generating reports using the reports module within the TDM web application. This presentation demonstrated the various types of reports available, filters for reports, status definitions and how to properly obtain the correct information for your report. The presentation included screenshots and step-by-step instructions of reports commonly used by MCDOT.

Travis Johnston, COG/TPB Staff, asked Committee members to provide feedback on any reports they generate. Committee members are reminded to reach out to Tammy Bowles, Darlene Nader, or COG/TPB staff with any questions they may have regarding generating reports within the TDM web application.

## 6. Client Status | Roundtable Discussion

George Clark, Tri-County Council for Southern Maryland, suggested changing the way the green-bar reports are delivered. Mr. Clark suggested that these reports be delivered electronically.

Stephen Finafrock, COG/TPB staff, noted the addition of upcoming special events into the TDM System. These events include home games for the Washington Nations and the Baltimore Orioles as well as signature events for this year's National Cherry Blossom Festival. Committee members were reminded of the special events module functionality and were asked to enter any relevant events into the system.

# 7. Quarterly Progress Report

Stephen Finafrock, COG/TBP Staff, asked members to examine the progress report and address any issues or concerns with COG staff. The technical report assistance to local jurisdictions was also attached at the end of the package. This table highlights technical support issues encountered at client sites.
