At the July 18, 2012 meeting of the Transportation Planning Board (TPB), the Board requested that a task force be established to identify promising locations in the region to operate buses on the shoulders of highways. In response to that request, COG/TPB staff has been developing a proposal, anticipated to be given to the TPB at its September 19 meeting, regarding potential membership for a TPB task force and a work plan and schedule for coordinating an assessment of the experience and potential for Bus On Shoulder (BOS) operations on the region's freeways and major arterials.
