#### What You Will Learn

- That Building Energy Codes have myriad benefits to your community, putting money in your constituents' wallets, stabilizing electricity grids which delays the need for new power plants, & reducing carbon emissions.
- That America's Model Energy Code the IECC is updated every three years by local and state official voting; that local and state officials have boosted the efficiency of the last three IECCs by 38%; and that 2016 is the year the International Code Council (ICC) is facilitating the development of the 2018 IECC.
- That in the first round of hearings, efficiency opponents won recommendations that will rollback or trade away those gains, making the 2018 IECC the first IECC in history that is weaker than its predecessor code.
- That "THE POWER IS IN YOUR HANDS" to defeat the rollbacks proposals and support putting the 2018 and future IECCs on a glide path of modest and steady improvements. Governmental members of the ICC will have a two week voting window to cast their 4, 8, or 12 allowable votes.

- 3. CAST YOUR 4, 8, OR 12 VOTES DURING ICC'S 2-WEEK ELECTRONIC VOTING WINDOW (Currently Anticipated to open on November)
