2023 Population Estimate (Round 10.0 Cooperative Forecasts)

Formula (2025 Population – 2020 Population) = Growth Increment between 2020 and 2025 (222.9 Thousand People)

One Year of Growth Increment = Five years/222.9 Thousand People (Assuming the same amount growth for each year)

~44.6 Thousand People



Year 2023 represents three years of increment of population growth

~44.6 Thousand People * 3 Years = ~133.8 Thousand People

Add to 2020 Population Regional Population (5.73 Million People)

Findings:

- Year 2023 for Round 10.0 is a little more optimistic than the Census Population estimate for July 1, 2023
- Round 10.0 population forecast was developed during the fall of 2022
- It's now approaching the fall of 2024 should we think about own individual jurisdictional forecasts and determine if the short-term still seem reasonable?
- What are we seeing at the jurisdictional level? [e.g. school enrollment, migration trends, or building permit activity] Do the short-term population forecasts and year 2025 still seem reasonable?
