CMP Requirements and Features

- A Congestion Management Process (CMP) is a requirement in metropolitan transportation planning (reaffirmed in the most recent federal FAST Act)
- The official regional CMP to address this requirement is integrated into the overall quadrennial long-range transportation plan Visualize 2045, aided by a separate biennial CMP Technical Report
- CMP strategies include operations management strategies (such as incident management and traffic engineering); demand management strategies such as Commuter Connections programs; and integrated operations/demand management strategies
- TPB staff needs your help to ensure that TDM/Commuter Connections information in the CMP Technical Report remains up-to-date



CMP and Commuter Connections

- Chapter 3 of the CMP Technical Report documents the breadth of Commuter Connections programs
 - Sections on surveys/evaluation; telework; employer outreach; car/vanpooling/ridesharing/other commuter resources; incenTrip and Rewards programs; Bike-to-Work and Car-Free Days
 - Commuter Connections monitoring/evaluation documentation particularly important and helpful for complying with CMP regs
- Special thanks to member agencies help in 2019 providing/updating information for Table 3-1, "Ongoing State Local Jurisdictional Transportation Demand Management (TDM) Strategies"
