Item 8. Mobile Budgets Proposal

Presenter: Joan Rohlfs, Chief, Air Quality Planning

Description:

The air quality plan (SIP) includes an emissions inventory for the attainment year 2009. In June the inventory was completed when the mobile inventories for 2009 developed. Once approved by EPA, the 2008 and 2009 mobile inventories will serve as mobile "budgets." The budgets are used as benchmarks to determine if the region's constrained long range transportation plan (CLRP) and six year transportation improvements program (TIP) conform with the Clean Air Act Amendments of 1990. Under EPA regulations the projected mobile source emissions for 2009 become the mobile emissions budgets for the region unless MWAQC takes actions to set another budget level.
