## Brief History of MWAQC

- COG Board was designated air quality planning body for Washington area dating back to 1970's
- Clean Air Act Amendments of 1990 led to revised planning procedures and required examination of new planning body
- MWAQC certified as regional air quality planning body for Washington region in late 1991 and early 1992 by then Mayor Kelly and Governors Schaeffer and Wilder
  - Independent committee staffed by COG was certified
  - Certification in response to COG Board proposal developed after period of local-state dialogue
  - Certification pursuant to Section 174 of the Clean Air Act Amendments of 1990

### MWAQC Mission and Membership

- Mission prepare ozone and carbon monoxide air quality plans for Washington region pursuant to Clean Air Act Amendments of 1990
  - These "State Implementation Plans" are submitted to the states then to EPA
- Membership
  - Local elected officials from all COG member jurisdictions plus Charles, Calvert, Stafford Cos.
  - State Air Management Directors
  - State Transportation Directors
  - TPB Chair

### MWAQC Accomplishments

- MWAQC has prepared all required air quality plans and plan elements for the past 12 years
  - I hour ozone standard: "15% plan", rate of progress plan, attainment plan, severe area plan
  - Carbon monoxide attainment plan and 2 maintenance plans

### Legal Analysis of Section 174 of the Clean Air Act Amendments of 1990

- Section 174 "clearly sets forth the Congressional intent that air quality planning is a process which requires joint action of state and local government officials."
  - For developing new planning procedures at the outset of the planning process in 1990.
  - Preparing regional air quality plans requires an organization certified by the state in consultation with local elected officials.
  - AQ planning entity shall include elected officials of local governments, state air and transportation agencies, and others.
- Section 174 does not specify the extent of participation, however, it must be "consultative, accordant, and joint."

Background Leading to Re-examination of MWAQC process

- Mayor Williams, Governor Ehrlich, and Governor Warner have been meeting since 2002 on a range of regional issues in the National Capital Region
- One topic has been the air quality planning process
- In February, 2004, a formal dialogue with MWAQC began with a letter from the Mayor and Governors to MWAQC

### Feb. 19, 2004 Letter

#### Letter from Mayor/Governors to MWAQC

- Recognized MWAQC's 12-year effort to prepare regional air quality plans for 1 hour ozone std.
- Noted directive to state air and transportation agencies to find ways to improve the process for the new 8 hour ozone standard and small particle standard

### March 3, 2004 Response

MWAQC offers to work together with Mayor and Governors on cooperative planning process to address new standards and requests a formal meeting.

### April 5, 2004 Secretaries Letter

- Environmental and Transportation Secretaries respond on behalf of Mayor and Governors
  - Agree to dialogue with MWAQC Leadership
  - Outline principles and goals to better recognize and enhance state role in regional air quality planning process
  - Propose adding additional stakeholders to MWAQC
  - Indicate intent to re-certify new MWAQC process

# April 21, 2004 Secretaries-MWAQC Leadership Meeting

#### Meeting Participants

- MWAQC Leadership
- State Secretary Delegation led by Virginia Natural Resources Secretary Tayloe Murphy
- Proposal presented for discussion that would revise MWAQC from current decision-making role to advisory committee to state secretaries
  - Significant local concerns expressed
  - COG's General Counsel and Environmental Director charged to negotiate enhancements to MWAQC process with state secretary staff guided by April 21 dialogue

### Status of Dialogue

COG staff has held several discussions with state representatives

- Several proposals exchanged
- Dialogue guided by:
  - MWAQC remains the major state-local collaborative entity for regional air quality planning.
  - Role of States in both governance and technical direction and oversight will be enhanced.
  - COG will continue to have the lead staff role for the regional air quality planning process.
- Major proposed change establishment of State Secretaries "Steering Committee"

### Next Steps

- COG and state staff complete negotiations on proposal for circulation to MWAQC Leadership and State Secretaries with 7 to 10 days
- State Secretaries to present status report to Mayor/Governors on June 25<sup>th</sup>
- Meeting(s) prior to June 25<sup>th</sup> likely between MWAQC Leadership and State Secretaries
