On <u>April 19-21, 2010</u>, the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) will jointly conduct a planning review certification of the National Capital Region Transportation Planning Process. The federal team will also attend the April 15th Citizen's Advisory Committee to dialogue with them about the TPB's Planning Process. Regulations state that "the FHWA and the FTA jointly shall review and evaluate the transportation planning process for each TMA no less than once every four years..." The last review was completed in 2005, and a report issued in 2006.

Consistent with 23 U.S.C 134(k)(5) and 49 U.S.C 5303(k)(5), the primary purpose of a planning certification review is to ensure that the federal planning requirements are being satisfactorily implemented. In a broader sense, the certification review process is a valuable opportunity to provide advice and guidance to a Transportation Management Area (TMA), defined as an urbanized area with a population over 200,000, for enhancing the planning process and improving the quality of transportation investment decisions. While the FHWA and FTA interact with TMA planning officials, State DOTs, Transit operators, etc on a routine basis, the certification review provides an objective view of the TMA transportation planning process and can serve as a catalyst to improve the effectiveness and efficiency of the planning process provides an opportunity for continued progress in expanding the art of transportation planning while implementing the regulations.
