AGENDA ITEM 5 - FAIRFAX COUNTY'S BIKE BENEFIT INITIATIVE

Marcus Moore and Glenn Hiner of Fairfax DOT briefed the committee on Fairfax's Bike Benefit Program. The initiative is a great assist in pitching TDM to prospect employers. Currently, PriceWaterhouseCoopers in Tyson's is a client in the program. The program kicked off in July. There is no limit to the amount of clients that can enroll in the program.

AGENDA ITEM 6 - JARC/NEW FREEDOM AND E-CALC

Jim Larsen of DATA presented information on the rotating rideshare coordinator grant program. The grant is in the processing phase and will be ready soon. The target clients are hotels and restaurants in the DATA service area. The program is slated for a two-year timeline. The E-Calc application is an entrée for surveying employers. The program measures VMT/VOC levels. The initial survey gave a 40% response rate. The program will be available to the entire Northern Virginia region and looking to expand to the DC region as a whole. The next step would be to tie this into the Commuter Connections website.

Nicholas Ramfos of COG/TPB staff updated the committee on recent developments in the regional telework effort. The telework effort is now folded into the regional employer outreach

There is a scorecard for employers and goals to meet by August 2011. Mirza Donegan of North Bethesda Transportation Center informed the committee of the vanpool service they are working with the at the HHS Twinbrook facility. Parking is being reduced and NBTMD is working with employers to start the process (3 – 6 months) for initiating a vanpool.
