# 12:50 P.M. 5. HISTORY OF EMISSION REDUCTION PROGRAMS, AIR QUALITY IMPROVEMENT, & CURRENT OZONE SEASON SUMMARY

COG staff will provide a historical perspective on emission reductions in the region and discuss the progress made to date towards improving air quality. OTC staff will present results from OTC modeling studies, which will help show the relationship between emission reductions and ozone concentrations in the region. This will help frame committee discussions about the focus and scale of additional reductions needed to further clean the air. Staff will also update members on the status of air quality this summer.
