- The TPB Climate Change Mitigation Study of 2021 (CCMS) is a scenario study whose goal is to identify potential pathways for the region to reduce on-road, transportation-sector greenhouse gas emissions to meet COG's regional greenhouse gas (GHG) reduction goals associated with 2030 and 2050. The analysis phase of the study is now complete and the committee will be briefed on the results of the analysis. The analysis includes three "top-down" scenarios and 10 "bottom-up" scenarios that explore single and combination pathways to reduce on-road transportation GHG emissions. The TPB will be briefed about these results in a special work session on December 13, 2021 at 3 PM and will discuss the matter further at its regular meeting on December 15 at Noon.

moveDC, which is DDOT's long-range transportation plan, was updated this past year. The plan features 7 goals, which are Safety, Equity, Mobility, Management and Operations, Project Delivery, Sustainability, and Enjoyable Spaces. From these goals, DDOT has devised 41 strategies that will guide the Department over the next 5 years. These strategies are direct actions that DDOT will take to ensure the goals are met. Each year, DDOT will release an annual report detailing progress on moveDC. In addition to the goals and strategies, moveDC also developed mobility priority networks. These networks - Transit, Freight, and Bike - will guide future project decision-making at DDOT. This presentation will give a more in-depth look into moveDC 2021.

As the old 11th Street Bridge that connected D.C.'s Capitol Hill / Navy Yard and historic Anacostia / Fairlawn neighborhoods has been replaced, the District government and Building Bridges Across the River are transforming its aged infrastructure into the city's first elevated park: a new venue for healthy recreation, environmental education, and the arts. Mr. Kratz will provide the Committee a project overview, including how it aligns with recent regional transit and equity goals, as well as the park's design and how it connects to the region's larger network of bicycle and pedestrian infrastructure.
