### 5. TDM System Update

Michael Hemry, Media Beef, presented the new upcoming enhancements for the TDM system. These enhancements are classified in 3 categories: Marketing, Database Consistency, and System Enhancements including Automated Commute Logging, IncenTrip and Capital Bikeshare Integration.

Within the marketing category enhancements, Mr. Hemry talked about the Registration Source Tracking (ROI). This feature will allow admins to define the source of new applicants via phone, e-mail etc. In addition, it will facilitate better internal reports. The Registration Source Tracking (ROI) will allow MWCOG staff to run ROI reports that will detail all new Commuter Connections accounts created by individual ad campaigns and through the advertising channel.

Also, Mr. Hemry highlighted the e-mail simplification process including the new personalized "sent-from" e-mail address for partner agencies, and a comprehensive review of all outbound e-mails generated from the Commuter Connections TDM System. Also, TDM system has improved the communication between commuters who can notice the new design which uses the ride matching system as well as special event integration.

Regarding the Database consistency enhancement, the main improvement has been through efforts to mitigate the duplicate employer issue during the new account creation which strengthens the address standardization. Another significant improvement is the requirement for both home and work addresses to be geocoded correctly for a user to participate in the ridematching database. The system will notify a commuter whose address is not located on a map to update their profile to ensure a well-functioning ridesharing search. Also, another great update introduced is the alternative of using route matching algorithms which use alternative origins and destination.

Mr. Hemry concluded his presentation with 3 more system enhancements which are the automated commute logging, the IncenTrip integration, and Bikeshare integration. The auto commute logging will enable users to receive notifications from Commuter Connections. In general, commuters will benefit from this as the log-in process will be easier.

With regards to the incenTrip integration, users can now choose to share commute data from Commuter Connections and vice versa. Moreover, TDM will be adding support for commuters who are part of Flextime Rewards to share their commute pattern to see if they would qualify to receive points under the incenTrip program.

### 6. Mobile Applications Update

Steven Osborn, COG/TPB staff, began his presentation of the updates that have been made to the driver incentive within the CarpoolNow mobile application. The mobile application is a new dynamic rideshare option for commuters in the Washington, D.C. Region. The driver incentive for this program was recently expanded to include the whole Washington D.C. nonattainment area. The incentive will only be available to those offering to drive. Members login using their existing Commuter Connections credentials, or they can create a new account.

Mr. Osborn demonstrated an example of commuters offering a ride. Any other users logged in requesting a ride will appear at their current location. Selecting the "List View" tab at the top of the screen will give the user access to each commuter requesting a ride. The driver needs to wait for a response. The ride will receive a notification that the ride has been offered. After the rider accepts the offer, the user will have the option to confirm the pickup. The driver and trip data will appear in a report ran by COG staff to be used to process payment or incentive.

Mr. Osborn then continued his presentation win an update on the incenTrip app. The app is now fully integrated with the Commuter Connections program and the existing user base via deeplink technology. Only users with an origin and/or destination in the Washington DC-nonattainment region can earn incentives. The registration process for users has been simplified. There is still a registration code request, which will be removed this fall when the app becomes open to all users.

Other updates to the app include extending bike trips to a maximum distance from 5 to 10 miles and integration of commuter busses as a transit option. Future development plans include an improved "Agency Dashboard" for incentive performance monitoring and management. Mr. Osborn reminded everyone that several other changes were made based on partner and user feedback. A few bugs were fixed.

Mr. Osborn then explained back-end improvements made to incenTrip::

- Congestion mitigation and increasing multimodal trips (transit, rideshare, etc.) has been added to the objective set of the incentive optimization algorithm.
- Time tables and routes of commuter buses and shuttles have been synchronized in the multimodal algorithm
- Travel mode confirmation algorithm has been enhanced.
- Online Artificial Intelligence (AI) architecture for predicting individual travel choices has been developed for even more cost-effective incentive programs.

Mr. Osborn briefed attendees on the existing funding for incenTrip, and then showed an article in the Washington Post dated August 18<sup>th</sup>, from the transportation section, in which the app is mentioned as a reward for smart commuting choices.

To conclude his presentation, Mr. Osborn summarized the ongoing work for the incenTrip program. The University of Maryland team welcomes additional feedback from Ridematching Committee members and will continue working on app improvement for a possible Fall 2018 opening to all commuters in the MWCOG region. # 7. GIS Update

Stephen Finafrock, COG/TPB staff, began his presentation by asking those in attendance to provide COG staff with new park and ride data, if available. Mr. Finafrock asked that it be sent to the commuter support inbox at <u>commutersupport@mwcog.org</u>.

Mr. Finafrock then asked those in attendance to turn their attention to the special events ticker that has been added to the TDM System. Those in attendance were then asked to supply contact information for those that may have important GIS data for GOG's new bike routing map.

Mr. Finafrock then demonstrated the bike routing module in the TDM System. Several examples of regional trails were shown. Mr. Finafrock highlighted the ability to modify a suggested bike route by dragging and dropping a point was displayed. Fatemeh Allahdoust, VDOT, asked how this map is different than using bike routing via Google Maps. Mr.

Finafrock responded by noting that this map includes data that has been regionally sourced, making it comprehensive and more accurate.

Mr. Finafrock noted that COG may add a Capital Bikeshare layer to the map. This layer could be toggle on and off by the user to locate bikeshare locations.

### 8. Client Site Status/Roundtable

Mr. Finafrock, COG/TBP, stated that COG has been speaking to state funders regarding certain report data collected and changes have been made to table 6A. Irrelevant items have been taken off and the form is now a fillable PDF and should be easier for stakeholders to fill out and send to COG. Monthly collection of this data is reflected in the annual report.

### 9. Quarterly Progress Report

The FY18 Fourth Quarter Progress Report showed approximately 2,300 rides given throughout the year. Agencies that have left the Commuter Connections network are still appearing in the FY18 report and will be removed from the FY19 report.

### 10. Other Business/Upcoming Agenda Items

No discussion was had at this time. A motion to adjourn was initiated by Chairperson Thomas Hamed and supported by Kelly Woodward and Jonathan Boldes.
