The TLC Program began in November 2006 with two components:


- Regional Clearinghouse

## TLC Technical Assistance Summary

48 Technical Assistance Projects funded at \$1,350,000:

- 7 in the District
- 24 in Maryland
- 16 in Virginia
- 1 Region-wide



Projects address common challenges:

- Bike/Ped Issues
- Complete Streets
- Transit Access
- TOD / Mixed UseDevelopment
- Freight

## FY 2012 Available Funding

- The TPB will provide \$220,000 for TLC technical assistance projects reflecting regional diversity and studying a variety of topics
- The Maryland Department of Transportation (MDOT) will commit \$130,000 in TPB Technical Assistance funding for projects in Maryland
  - MDOT has expressed interest in funding projects that focus on Transit-Oriented Development

## FY 2012 Project Solicitation

#### **Project Solicitation**

- March 1 May 18, 2011
  - New Abstract Process received nine abstracts by March 31

#### **Application Summary**

- The TPB received 15 applications from 11 jurisdictions (\$705,000):
  - 3 applications from the District of Columbia (\$150,000)
  - 6 applications from Maryland jurisdictions\* (\$235,000)
  - 6 applications from Virginia jurisdictions (\$320,000)
