Metropolitan Washington is one of four U.S. regions being recognized by Global Covenant of Mayors (GCoM) as a U.S. Metro-Scale Climate Leader. The recognition comes with guidance and technical support for the development of CEEPC's 2030 Regional Climate and Energy Action Plan. Panelists will review EU in the US climate diplomacy initiatives; GCoM Reporting Framework and what it would mean for CEEPC to become a GCoM signatory; and review the scope and timeline for the 2030 Regional Climate and Energy Action plan development.

The Transportation Climate Initiative (TCI), led by the Georgetown Climate Center (GCC), is a regional collaboration of northeast and mid-Atlantic states and the District of Columbia that seek to reduce carbon emissions from the transportation sector. TCI jurisdictions have been working to develop a regional low-carbon transportation policy by the end of 2019. Later this fall, specific regional policy options will be published for public input.
