# **Survey Pre-Test Strata**

- The address-based sampling frame composed of 66 geographic strata were aggregated into five "Super Strata" for the survey pretest.
  - S1: District of Columbia
  - S2: Arlington and Alexandria
  - S3: Suburbs High Density (MTG, PG, FFX, LDN, PW, CHS, FRD)
  - S4: Suburbs Low Density (MTG, PG, FFX, LDN, PW, CHS, FRD)
  - **S5: Outer Ring Jurisdictions** (CAR, HOW, AA, CAL, STM, KG, SPOT, FRB, STF, FAQ, CLK, JEFF)

## **Pre-Test of Two Survey Methods**

- Survey pre-test households were assigned to one of two different survey segments within each survey strata
  - <u>Segment 1</u>: Households with qualifying smartphones for each household member age 16+ were assigned to complete the survey using the **rMove app**. (Households not meeting this smartphone criteria were assigned to complete the survey using the **rSurvey** online web survey).
  - <u>Segment 2</u>: All households were assigned to complete the survey using the **rSurvey** online web survey regardless of smartphone qualification criteria.
- rMove households were asked to report trips for an assigned
   7-day travel period
- rSurvey households were asked to report trips for only one randomly assigned weekday



### **Survey Pre-Test Status**

- Survey pre-test for the Regional Travel Survey was launched on February 9
- A total of 16,020 randomly selected households were invited to participate in the pre-test survey
  - 8,010 households assigned to Segment 1 (rMove eligible)
  - 8,010 households assigned to Segment 2 (rSurvey only)
- Survey packets, pre-notice, and reminder postcards were mailed out
- Households agreeing to participate were assigned specific travel dates
- Reminder phone calls/emails were made to recruited households



# **Survey Pre-Test Status: Response Rates**

# **Updated Survey Schedule**

- Some dates still subject to adjustment
- Survey pre-test: February and March 2017
  - Last travel date March 27
- Analysis of pre-test results and survey refinement: April through June 2017
- Main survey: July 2017
  - WMATA SafeTrack Surges 15 and 16
     May and June 2017 (specific dates TBD)
  - 12 months of travel dates
- Complete main survey: early Summer 2018
- All deliverables by end of 2018
